Scrutinizer's Report on remote e-Voting for Postal Ballot conducted by Aditya Birla Sun Life AMC Limited ("the Company") in terms of provisions of Sections 108 and 110 of the Companies Act, 2013 (the "Act") read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014

- A. In accordance with provisions of Sections 108 and 110 of the Act, read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014, I, Omkar Dindorkar (Membership No. A43029), Partner of M/s. Makarand M. Joshi & Co, Practicing Company Secretaries, have been appointed as Scrutinizer by the Board of Directors of the Company through circular resolution passed on November 18, 2025 for scrutinizing the Postal Ballot voting conducted by way of remote e-Voting process in respect of the resolutions as set out in the Postal Ballot Notice dated November 19, 2025 ("Notice").
- B. Member's approval via Special Resolution(s) was sought for following Special Business(es):
 - i) Adoption of Aditya Birla Sun Life AMC Limited Employee Stock Option and Performance Stock Unit Scheme 2025; and
 - ii) Approval for extending the benefits of Aditya Birla Sun Life AMC Limited Employee Stock Option and Performance Stock Unit Scheme 2025 to employees of the Subsidiary Companies of the Company.
- C. Pursuant to provisions of Sections 108 and 110 of the Act and Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014, and General Circular No. 03/2025 dated September 22, 2025 and other relevant Circulars issued by the Ministry of Corporate **Affairs** ('MCA') from time to time ("MCA Circulars"), Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Secretarial Standard - 2 on General Meetings issued by the Institute of Company Secretaries of India, and other applicable laws and regulations (including any statutory modification(s) and/or re-enactment(s) thereof for the time being in force), the resolutions as set out in the Notice were placed for approval of the Members of the Company through remote e-Voting only. The Company has confirmed that the copy of the Notice and Explanatory Statement along with the process of remote e-Voting in terms of the MCA Circulars were sent by electronic mode on Wednesday, November 19, 2025 only to those Members whose name appeared

- in Register of Members/ List of Beneficial Owners maintained by the Company/Depositories as on cut-off date i.e. Friday, November 14, 2025 and whose e-mail IDs were registered with the Company/ Depositories.
- a) The Company had appointed KFin Technologies Limited ("K-Fintech"), Registrar and Transfer Agent as the agency for providing remote e-Voting facility to the Members of the Company.
- b) Members were required to communicate their assent or dissent only through remote e-Voting facility in terms of the MCA Circulars.
- c) The remote e-Voting period commenced on Thursday, November 20, 2025 (9:00 a.m. IST) and ended on Friday, December 19, 2025 (5:00 p.m. IST).
- d) Accordingly, the votes cast through remote e-Voting facility were taken into account and at the end of the remote e-Voting period, on Friday, December 19, 2025 (5:00 p.m. IST), the remote e-Voting module was thereafter disabled by us for voting. The remote e-Voting summary statement was thereafter downloaded from the website of K-Fintech.
- e) The register, in accordance with Rules 20(4)(xiv) and 22(10) of the Companies (Management and Administration) Rules, 2014, has been maintained electronically to record the assent or dissent received, mentioning the particulars of name, address, folio number or DP ID Client ID of the Members, number of shares held by them and nominal value of such shares. There were no shares with differential voting rights in the Company, hence there is no requirement of maintaining the list of shares with differential voting rights.
