1. The case has been heard today, wherein, Learned Counsel for CH Bank has requested for re-issuance of Proclamation of Sale (PoS) stating that auctioned for the qua properties were held on 21.01.2020 but same was reported unsuccessful due to no bidder. CH Bank has also submitted fresh POR and recent valuation report through Dairy No. 8932 dated 31.07.2023.
2. As submitted by the CH Bank, the below mentioned property/properties are owned by the CDs and the same is mortgaged with CH Bank. It is further submitted by the CH Bank this is unencumbered properties and no dues of any kind against the mortgaged properties are known to the CH Bank.
3. In this case a Recovery Certificate No. 1477/2017 in O.A. No. 3373/2017, for recovery of sum of Rs. 4,29,35,650.17p, jointly and severally with costs, current and future with simple interest of 10.00 % p. a. and costs of Rs. 1,50,000/- till the date of realization of the amount due to the Applicant Bank/Certificate Holder from the Certificate Debtors.
4. On perusal of records and submissions of the CH Bank, CDs were given sufficient time and opportunity to clear all the dues as per the Recovery Certificate and CDs are failed in comply with the orders of this DRT. Now, no other alternatives are available other than to recover the dues of the bank by sale the mortgaged properties of the CDs, as per the process laid down in rules 52 to 57 of the second schedule to the Income Tax Act, 1961 read with Sections 25 and 29 of RDDB & FI Act, 1993. Hence, I am of considered opinion that recovery of RC amount should be recovered/made by selling the mortgaged/personal properties of the CDs by exercising the powers conferred on the Recovery Officer under Section 25 to 29 of RDDBFI Act, 1993 read with Second Schedule of Income Tax Act, 1961 along with Income Tax (Certificate Proceeding) Rules, 1962.
5. Further, I have heard the submission of the CH Bank regarding the determination of the reserve price of the questioned properties, CH Bank has requested for considering the distress value of the properties as reserve price stating that the earlier auction for the questioned properties was unsuccessful at reserve price which was much below the distress value (as present valuation report) and no effective purpose will serve if it is placed on higher reserve price if it is unable to attract the potential buyers. After taking into consideration the facts that the and circumstances of the case and keeping in view that the reserve price is the minimum bench mark price below which the property cannot be sold and there is no bar on selling these property at higher price, I am in agreement with the CH Bank that the reserve price should be such that it is reasonable at the same time competitive to attract the buyers to promote competition. It is pertinent to mention here that the present reserve price is fixed in a manner, so as to ensure that the reserve price of properties should must be equal or greater than the earlier reserve price. Further, the CDs have liberty to bring the buyers to participate in the proposed public auction, if desire so. Accordingly, the reserve price of the properties are fixed and let a POS be issued.
