SUMMARY OF PROCEEDINGS OF THE 16TH ANNUAL GENERAL MEETING (AGM) OF ACCURACY SHIPPING LIMITED (THE COMPANY)

The 16th AGM of the Members of the Company was held on Monday, September 30, 2024, at 04.00 P.M. (IST) through Video Conferencing (VC)/ Other Audio Video Means (OAVM), in compliance with 09/2023 dated September 25, 2023, issued by the Ministry of Corporate Affairs (MCA) and Circular SEBI/HO/CFD/CFD-PoD-2/P/CIR/2023/167 dated October 7, 2023 issued by the Securities and Exchange Board of India (SEBI) (hereinafter collectively referred to as “the Circulars”) and other applicable provisions of the Companies Act, 2013.

Ms. Shivani Palan, Company Secretary and Compliance Officer, informed the members that since the Meeting was held through VC, the proxy related procedures has been dispensed with.
