The Thirteenth Fourth Annual General Meeting (AGM) of the Company is scheduled to be held on Wednesday, September 22, 2021 at 08:30 PM IST through Video Conferencing and Webcast facilities. The AGM shall be held on Wednesday, September 22, 2021 from 08:30 AM to 09:00 PM IST. The AGM shall be held on Wednesday, September 22, 2021 dated January 13, 2021 with draft circular no. 16/2020, 17/2020 and 20/2020 issued by the Ministry of Corporate Affairs (MCA) and SEBI Circular dated May 12, 2020, respectively. The AGM shall be held on Wednesday, September 22, 2021 at the Exchange Building of India (SEBI) (hereinafter collectively referred to as "Circulars"). Companies are allowed to hold AGMs through VCDMAA, without the physical presence of members at the annual general meeting. (b) The Notices are addressed to members, whose names appear in the Register of Members of the Company as on the cut-off date. If there is any change in the shareholding shares after the dispatch of the Notices and before the cut-off date i.e., September 15, 2021 may approach CSIL for issuance of the User ID and Password for exercising their right to vote.

(c) Once the votes on a resolution are cast by the members, the members shall not be allowed to change it subsequently.

(d) The facility of e-voting shall also be made available during the Meeting and the Members attending the AGM who have not already casted their vote by remote e-voting facility may still cast their votes through the AGM.

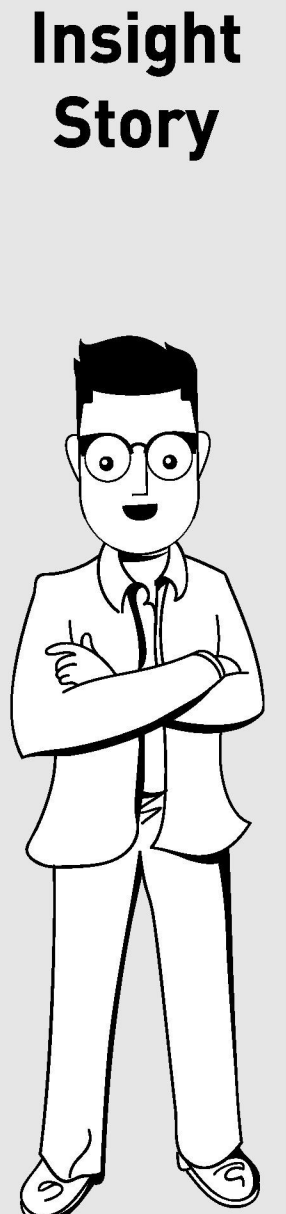
(e) Members who have casted their vote through remote e-voting prior to the AGM may attend the AGM but shall not be entitled to cast their votes again.
