In terms of Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform you that Arcadia Logistics Limited, a subsidiary of Arvind Port and Infra Limited, has executed a Memorandum of Agreement ("MOA") dated Saturday, 27 June 2026, with Vrinda Marine LLP for the sale and transfer of a Crane Pontoon Barge named "KB 19", bearing Registration No. JMR-0006, registered with the Mercantile Marine Department (MMD), Jamnagar.

The sale and transfer of the vessel shall be completed in accordance with the terms and conditions of the Memorandum of Agreement and subject to completion of the customary contractual and statutory formalities, wherever applicable. The vessel shall be transferred in accordance with the terms and conditions of the Memorandum of Agreement executed between the parties.

The transaction is in line with the Group's ongoing evaluation and optimization of its marine asset portfolio and is consistent with its focus on enhancing operational efficiency and supporting future growth initiatives.
