With reference to the captioned subject, we would like to inform you that the Company has received an intimation (on March 2, 2026 at 5:27 P.M. IST) from Kutch Copper Limited, ("KCL"), a wholly owned subsidiary of the Company, that KCL has divested its entire 50% stake in Praneetha Ecocables Limited ("PEL") on March 2, 2026 and consequently PEL has ceased to be JV of KCL.
