Ahmedabad, 30 December 2024: In alignment with the Adani Group's routine internal leadership transitions and planning, and to continue fostering sustainable growth and an ever-evolving leadership development consistent with the broader group and Company objectives, a leadership transition has been undertaken.

Adani Green Energy Limited

Mr. Amit Singh, the current CEO of Adani Green Energy Limited (AGEL), will step down from his position as CEO of the Company, effective 31 March 2025 and will transition to his new role as CEO of International Energy Business of the Adani Group.

Adani International Energy Business

Mr. Ashish Khanna, who is currently CEO of the International Energy Business of Adani Group, is appointed as AGEL's new CEO, effective 1 April 2025.

As Adani Group now wishes to expand its business territory to international geographies, especially where growth paradigms are formidable such as MENA, Amit's leadership will further strengthen Group and align Group's goals.
