Sub: Resignation from the post of Director/ Independent Director

At the outset, let me convey my sincere thanks to the Board of Directors and shareholders of Adani Power Limited (“APL”) for reposing confidence in me as an Independent Director of the Company, since August 2015. It has indeed been an honour and a privilege for me to have been associated with the Board of APL for nearly 7 1/2 years- and that too during the period when the Company was passing through a phase of a ‘difficult financial situation’. It is a matter of happiness and pride for me that the Company is now in a healthy financial/ profitable position. Needless to say, I have learned a great deal from the vision, grit and leadership of the Chairman, Sh. Gautam Adani- as well as Sh. Rajesh Adani, and the full Management team.

In July 2020, I had also been inducted as an Independent Director on the Board of Adani Green Energy Limited (“AGEL”), the renewable energy vertical of Adani Group. At that time, the proposal had been to ‘delist’ APL. However, now, APL will continue to remain listed. As a Policy of Good Corporate Governance, I sincerely believe that the same individual should not be an Independent Director on the Board of more than one ‘listed’ company of the same Group.

Further, in view of the rapid growth in both the business verticals (APL and AGEL), and my being a Member/ Chairman on various Committees (including Audit committee) of both the companies, I believe that it would be better for me to focus my energy/ association with one vertical/ company only.

Hence, I hereby tender my resignation from the post of Director, i.e. as an Independent Director of APL, with effect from the close of working hours on November 11, 2022.

I take this opportunity to extend my sincere gratitude to the Board of Directors and Management of the Company for their support in performing my duties to the best of my 'limited' abilities.
