An Air India Express spokesperson said in a statement. Earlier, on September 2, the Delhi-Indore Air India flight returned to Delhi shortly after take-off. Similarly, the Navy will get a new aircraft carrier, 10 next-generation frigates, 7 advanced corvettes, and 4 landing dock platforms. NDA ATTACKS CONGRESS' THINKING

The Congress on Friday tendered an apology after its Kerala unit issued a controversial tweet which equated Bihar with 'bids' while commenting on the reduction of Goods and Services Tax on bids in the "next-gen" reforms announced by the Centre on Wednesday. In the post, the Kerala Congress wrote alongside a chart which depicted the increase of GST on cigars and cigarettes from 28 percent to 40 percent (as a 'sin tax') and the reduction of GST on bids from 28 percent to 18 percent that "Bids and Bihar start with B. Cannot be considered a sin anymore."

soon, BJP spokesperson Shehzad Poonawalla accused the Congress of crossing the line again while linking the remarks to the abuses which were hurled at Prime Minister Narendra Modi from a party platform during Rahul Gandhi's Voter Adhikar Yatra earlier this month. In the letter to the Chief

Minister, All India Matua Mahasangh, led by Mamata Bala Thakur, also raised the demand that Moitra should publicly apologise for her comments, which had hurt the sentiments of the people from the Matua community. However, Mamata Bala Thakur, who herself hails from the community, had not directly written the letter to the Chief Minister. Instead, the letter was written by the Mahasangh General Secretary, Sukesh Chowdhury. Earlier this week, the Ma-

hasangh had issued a statement condemning Moitra for her anti-Matua comments and

also demanded a public apology from her in the matter.
