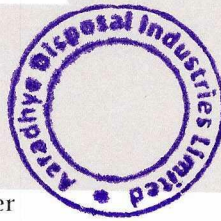

With Zelenskyy after 3-hour Putin meet



A Russian official said the discussion focused on the situation in Ukraine that can be done before the Moscow talks. Zelenskyy has three hours of talks with Putin. Zelenskyy's foreign policy spokesman described the talks as constructive, frank and Moscow also gave

the envoys its "comprehensive assessment" of the battlefield, while potential economic projects between Russia and the US were discussed in detail. Russia and Ukraine continued exchanging fire despite an agreement to pause strikes on each other's capitals. Russian attacks killed one person and wounded at least 10 in Ukraine, while a Ukrainian drone strike killed a man in Russia's Belgorod. —AP

Trump moves SC over mail ballot curbs

Washington: The Trump administration on Sunday again asked the Supreme Court to allow new restrictions on mail ballots ahead of the Nov midterms. The appeal came after US District Judge Indira Talwani extended an order blocking the Postal Service from enforcing Trump's executive order. Solicitor General John Sauer argued ballots were al-

ready being mailed in some states and delaying the rules risked "confusion and chaos". It is the administration's third appeal to SC. The court has allowed the plan to proceed but has not ruled on its legality. Democratic-led states and voting rights groups say the curbs are unconstitutional. Poll officials say there is too little time to change systems.
