 2. The above results have been reviewed by the Audit Committee and approved by the Board of Directors at their meeting held on May 21, 2026.
 3. The Board of Directors have proposed a final dividend of Rs. 1.50 per equity share for the year ended March 31, 2026 subject to the approval of the shareholders at the ensuing Annual General Meeting.
 4. On 21 November 2025, the Government of India consolidated 29 existing labour legislations into a unified framework comprising 4 Labour codes. In accordance with the requirements of Ind AS 19 Employee Benefits, these changes have resulted in an increase in the past service cost of gratuity by ₹ 130 lakhs considering that the enactment of the new legislation is a non-recurring event, the Company has presented this one-time charge under Exceptional Item. The Company continues to monitor the finalisation of Central/State Rules and clarifications from the Government on other aspects of the Labour Code and would provide appropriate accounting effect on the basis of such developments as needed.
 5. During the quarter and year ended March 31, 2026, the Company has allotted Nil and 1,31,875 fresh equity shares, respectively, having a face value of Rs. 5 each, pursuant to the exercise of stock options vested under the ESOP Plan.
