Since the AGM will be held through VC, the Route Map is not annexed in this Notice.
2. The relevant details of persons seeking appointment/re-appointment under Item Nos. 2 of the Notice, as required pursuant to Regulation 36 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and Secretarial Standard 2 on General Meetings is also annexed.

#### **ITEM 3: TO APPOINT STATUTORY AUDITOR OF THE COMPANY FOR THE FINANCIAL YEAR 2026-27 AND FIX THEIR REMUNERATION:**

The existing Statutory Auditors, M/s Jethani and Associates, Chartered Accountants, Jaipur, were appointed by the Members at the 16<sup>th</sup> Annual General Meeting ("AGM") to hold office until the conclusion of the ensuing 17<sup>th</sup> AGM, held in the year 2026. Accordingly, their tenure expires at the conclusion of this AGM, and a vacancy will arise for the position of Statutory Auditors for the financial year 2026-27.

Based on the evaluation of qualifications, experience, and independence, the Board of Directors of the Company, on the recommendation of the Audit Committee, at its meeting held on **August 21, 2026**, approved and recommended the appointment of **M/s GOPAL SHARMA & CO.**, Chartered Accountants, Jaipur (Firm Registration Number: 002803C), as the new Statutory Auditors of the Company in place of the retiring auditors, subject to the final approval of the Members at the ensuing AGM, to hold office for a term of one (1) year for the Financial Year 2026-27.

The Company has received the formal consent letter and eligibility certificate from M/s GOPAL SHARMA & CO. under Sections 139 and 141 of the Companies Act, 2013, confirming that they satisfy the criteria for appointment and are free from any disqualifications under the Act.

None of the Directors and Key Managerial Personnel of the Company or their respective relatives is concerned or interested, financially or otherwise, in the resolution.

The Board recommends the resolution as mentioned at Item No.3 above for the approval of the members by way of Ordinary Resolution.



**ITEM NO. 4: TO APPROVE RELATED PARTY TRANSACTIONS WITH VARIOUS ENTITIES UNDER SECTION 188 OF THE COMPANIES ACT, 2013 FOR THE FINANCIAL YEAR 2026-27:**

As per Section 188 of the Companies Act, 2013 (“the Act”), transactions with related parties which are on arm’s length basis and in the ordinary course of business are exempted from the requirement of obtaining prior approval of the Members.

However, pursuant to Regulation 23 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”), as amended by the SEBI (Listing Obligations and Disclosure Requirements) (Sixth Amendment) Regulations, 2021, effective from April 1, 2022, all related party transactions (“RPTs”) with an aggregate value exceeding Rs. 1,000 Crore or 10% of the annual consolidated turnover of the Company as per the last audited financial statements, whichever is lower, shall require prior approval of the shareholders. The said thresholds are applicable even if the transactions are in the ordinary course of business and at arm’s length.

Further, as per Regulation 2(1)(zc) of the SEBI Listing Regulations, related party transactions include any transaction involving transfer of resources, services or obligations between a listed entity or any of its subsidiaries on one hand and a related party of the listed entity or any of its subsidiaries on the other hand, irrespective of whether a price is charged.

In order to efficiently carry out its business operations in the glass industry and ensure uninterrupted supply chain, cost efficiency, and operational synergies, the Company proposes to enter into various related party transactions during the Financial Year 2026-27. The aggregate value of transactions during the Financial Year 2026-27 is expected to be as follows, with the following related parties:

**a. M/s Agarwal Fortune India Limited – up to Rs. 10 Crore (Rupees Ten Crore)**– engaged in trading of raw and processed glass products including laminated, safety, and allied glass items.

**b. Agarwal Float Glass India Limited: up to Rs. 15 Crore (Rupees Fifteen Crore)**- – engaged in trading of raw and processed glass products including laminated, safety, and allied glass items.

**c. M/s Hardik Glasses – up to Rs. 50 Lakhs (Rupees Fifty Lakhs only)**– engaged in wholesale/dealing of industrial glass and allied materials.

The above entities are engaged in manufacturing and trading of glass products including toughened glass, laminated glass, safety glass and allied products. The Company expects to derive benefits such as economies of scale, assured supply of raw materials, and competitive pricing.

The proposed transactions include purchase and sale of goods, procurement of raw materials, trading activities, and availing/rendering of services relating to glass products, all of which are in the ordinary course of business and on an arm’s length basis.

The Audit Committee, at its meeting held on **21st August, 2026**, has reviewed and approved the proposed transactions, subject to compliance with the applicable provisions of the Act, SEBI Listing Regulations, and the Company’s Policy on Related Party Transactions.

The manufacturing processes are designed to ensure compliance with the quality standards prescribed by the Bureau of Indian Standards (BIS), and the Company's manufacturing facilities are certified under ISO 9001:2015. The Company's products are widely used in applications where strength, durability,

Pursuant to SEBI (LODR) Regulations, 2015, your Directors have the pleasure in presenting the Management Discussion and Analysis Report for the year ended on March 31, 2026.

**INDUSTRY OVERVIEW AND DEVELOPMENTS**

The Indian glass industry continues to benefit from structural growth in construction, infrastructure, urbanization, commercial real estate and the increasing adoption of safety and energy-efficient building materials.

Architectural applications remain the principal demand driver for flat glass in India. Industry data indicates that architectural applications accounted for approximately 69% of float-glass consumption in FY2025, while the processed-glass segment is increasingly shifting towards higher-value products such as toughened, laminated and insulated glass. The processed-glass market was estimated at approximately ₹82.2 billion in FY2025, with toughened glass accounting for the largest share, followed by laminated and insulated glass.

Government infrastructure spending, expansion of airports and transportation infrastructure, commercial real estate development, premium residential construction and increasing adoption of energy-efficient building envelopes are expected to support demand for processed glass. NITI Aayog's buildings-sector analysis estimates that India's annual glass demand for buildings could increase from approximately 2–3 million tonnes in 2025 to 4–5 million tonnes by 2050 under its reference scenario.

The broader construction-glass market is also expected to maintain a growth trajectory. A recent MarketsandMarkets assessment estimates the Indian construction-glass market at approximately US\$2.21 billion in 2024 and projects it to reach approximately US\$2.92 billion by 2029, representing a CAGR of about 5.7%.

The demand environment is particularly favorable for processed and performance-oriented glass. Commercial and institutional buildings increasingly require products that combine safety, thermal insulation, solar control, acoustic performance and architectural aesthetics. This creates opportunities for manufacturers with the ability to offer customized and specification-driven solutions rather than commodity glass alone.

At the same time, the industry remains sensitive to fluctuations in the prices and availability of key inputs such as float glass, energy, natural gas, electricity and other processing materials. Industry sources also identify energy and soda-ash cost volatility as continuing margin considerations for glass manufacturers.

**COMPANY OVERVIEW**

Your Company is engaged in the business of processing and manufacturing of premium toughened glasses and other value-added glass products for architectural, commercial, institutional and industrial applications. The Company processes different types of float glass into a range of specialised products, including toughened glass, laminated glass, double-glazed/insulated glass and other customised processed-glass solutions. These products are designed to provide enhanced strength, safety, thermal insulation, acoustic performance and aesthetic appeal across a wide range of applications.

The Company's products are used in residential and commercial building façades, windows, doors, partitions, hospitals, airports, hotels, shopping centres, educational institutions, offices and other infrastructure and architectural applications. The Company primarily operates in the Indian market and caters to a diversified customer base comprising real estate developers, contractors, architects, institutional customers, project companies and other industry participants.

The Company has developed capabilities across multiple stages of glass processing, enabling it to offer customised solutions based on project specifications and customer requirements. Its focus on quality, precision and timely execution supports its participation in specification-driven projects where product performance and consistency are critical. The Company's manufacturing facilities are supported by modern processing equipment and are operated in accordance with applicable quality and safety standards. The Company is ISO 9001:2015 certified and its manufacturing processes are aligned with the relevant Bureau of Indian Standards (BIS) requirements.

Besides this, the Company is also planning to expand its offset capacity by venturing into manufacturing of glass processing units and adding a new plant and machinery. With these capacity additions your company is well prepared to manage the high demand for sustainable packaging solutions that is expected to grow going forward.

During FY 2025-26, the Company continued to strengthen its manufacturing platform and expand its operating scale. The Company's revenue from operations increased to ₹94.92 crore from ₹55.31 crore in the previous financial year, reflecting strong growth in demand and increased business volumes. The Company remains focused on increasing capacity utilisation, improving manufacturing efficiency and enhancing its product mix towards higher-value processed-glass applications.

As part of its growth strategy, the Company has been investing in additional manufacturing capacity, plant and machinery and advanced glass-processing capabilities. The expansion of manufacturing infrastructure is intended to enable the Company to undertake larger and more complex projects, improve production flexibility, reduce turnaround time and support the increasing demand for value-added glass products.

The Company is also focused on strengthening its presence across India through an expanding sales and marketing network. Its sales and marketing team, supported by industry experience and customer relationships, enables the Company to service both direct customers and channel or industry partners and to respond effectively to project-based requirements.

Going forward, the Company intends to leverage its expanded manufacturing capabilities, growing product portfolio and established customer relationships to participate in the continued growth of India's construction, infrastructure, commercial real estate and institutional sectors. The Company will remain focused on quality, operational efficiency, technological upgradation, customer satisfaction and prudent capacity utilisation while pursuing sustainable and profitable growth.

The Company believes that the increasing adoption of processed and performance-oriented glass in modern buildings, coupled with growing demand for safer, energy-efficient and aesthetically advanced building solutions, provides a favourable long-term opportunity for its business. With continued investment in manufacturing capabilities and a focus on value-added products, the Company is well positioned to address the evolving requirements of its customers and strengthen its position in the Indian processed-glass industry. While continuing to enhance the Company's capabilities to achieve growth, your Company is focusing on strengthening its facilities and making the best use of them.

### **FINANCIAL AND OPERATIONAL PERFORMANCE**

FY26 represented another year of substantial growth for the Company. Revenue from operations increased to ₹94.92 crore, compared with ₹55.31 crore in FY25, representing growth of approximately 71.6%. Total revenue increased to ₹100.06 crore from ₹58.30 crore in FY25, an increase of approximately 71.7%. The Company's profit before tax increased to ₹29.67 crore from ₹18.50 crore in FY25, representing growth of approximately 60.4%. Profit after tax increased to ₹21.60 crore from ₹15.17 crore, representing growth of approximately 42.3%. Basic earnings per share increased to ₹12.22 from ₹8.58. The Company's operating profit before finance costs and depreciation increased to approximately ₹33.20 crore in FY26 from ₹23.12 crore in FY25. While the absolute EBITDA increased substantially, the EBITDA margin moderated to approximately 33.18% from 39.65%, reflecting the Company's rapid scale-up, higher material consumption and increased operating expenses during the year.

The moderation in margins should be viewed in the context of the significant increase in business scale and the Company's ongoing investment in capacity and operating infrastructure. Management continues to focus on improving project mix, increasing the contribution of value-added products and achieving greater operating efficiency as the expanded capacity is utilised.

### **BUSINESS ENVIRONMENT AND DEMAND TRENDS**

During FY26, the Company operated in an environment characterised by strong demand for architectural and safety glass and continued development of commercial, institutional and infrastructure projects. The increasing use of glass in façades, windows, partitions, railings and other building applications is supported by changing architectural preferences as well as safety and energy-efficiency considerations. The shift from basic glass products towards processed solutions such as toughened, laminated and insulated glass is particularly relevant to the Company's business model. The Company believes that its focus on value-added

processing, project-oriented execution and customised solutions provides an opportunity to participate in the higher-value segments of the glass value chain.

### OPPORTUNITIES AND THREATS

The Company sees several structural opportunities for future growth.

- **Infrastructure and construction**  
Continued investment in airports, transportation infrastructure, commercial buildings, hospitals, educational institutions and urban development is expected to support demand for safety and architectural glass.
- **Commercial and residential real estate**  
Premium residential and commercial projects increasingly use large-format and performance-oriented glass for façades, windows, partitions and interiors. The trend towards modern architectural designs and energy-efficient buildings creates opportunities for processed-glass manufacturers.
- **Value-added glass**  
The shift towards toughened, laminated, insulated, jumbo and other specialized products offers an opportunity to improve product mix and customer value proposition.
- **Energy efficiency**  
Growing emphasis on energy-efficient buildings and improved building envelopes is expected to support demand for insulated and solar-control glass solutions.
- **Renewable energy**  
The Company has evaluated opportunities in solar glass as part of its diversification strategy. Management has indicated that it is exploring lightweight, high-durability glass solutions for photovoltaic applications and related export opportunities.
- **Geographic expansion**  
The Company's largely B2B customer base provides scope for expansion beyond its existing geographic markets.

### THREATS AND CHALLENGES:

Despite the favourable trends, the Company faces certain risks and challenges that require careful management:

- **Raw material price volatility**  
Float glass is a significant input and fluctuations in raw-material prices can affect margins, particularly where price increases cannot be immediately passed through to customers.
- **Energy costs**  
Glass processing is energy intensive. Electricity and fuel costs can materially influence manufacturing economics. Volatility in energy prices therefore remains an important operating risk.
- **Working capital**  
The project-driven nature of the business can result in extended receivable cycles and inventory requirements. The increase in receivable and inventory levels during FY26 highlights the importance of disciplined working-capital management.
- **Project concentration and execution**  
Large institutional and infrastructure projects may involve stringent specifications, delivery schedules and quality requirements. Delays, cancellations or execution issues could affect revenue recognition and capacity utilisation.
- **Competition**  
The Company operates in a competitive market comprising organised glass processors as well as regional and smaller manufacturers. Maintaining quality, delivery reliability, technological capability and competitive pricing is essential.
- **Capacity utilisation**  
The benefits of recent capital expenditure will depend on effective utilisation of expanded manufacturing capacity. Any prolonged period of under-utilisation could affect fixed-cost absorption and margins.
- **Regulatory and quality requirements**  
The processed-glass industry is subject to applicable quality, safety and environmental standards. Maintaining certifications and compliance with evolving requirements remains critical to the Company's ability to serve institutional and infrastructure customers.

### SEGMENT-WISE & PRODUCT-WISE PERFORMANCE

The company operates in only single segment, hence segment reporting is not applicable. The Company is engaged in the business of manufacturing glasses and other allied activities.

*The Highlights of the Company's performance are as under:*

Revenue from operations increased to ₹94.92 crore, compared with ₹55.31 crore in FY25, representing growth of approximately 71.6%. Total revenue increased to ₹100.06 crore from ₹58.30 crore in FY25, an increase of approximately 71.7%.

### INTERNAL CONTROL SYSTEMS AND THEIR ADEQUACY

Your Company has established a robust internal control framework commensurate with the size and complexity of its operations. The Company's internal financial controls ensure that transactions are properly authorized, recorded, and reported, and that assets are safeguarded against significant misuse or loss. During the year, the effectiveness of internal controls was reviewed and enhanced in line with the expanded operations post-IPO.

The internal audit team, in coordination with the Audit Committee, regularly monitors adherence to set processes and policies. Any observations or weaknesses identified are addressed promptly. Management believes that adequate internal control systems are in place for all major operational areas, including procurement, production, inventory management, and finance, and that these systems are operating effectively to ensure compliance with applicable laws and regulations. In addition, the Company has implemented standard IT systems for accounting and inventory which provide checks and balances through system controls. Overall, the internal control environment remains sound and is continuously being improved as the business grows.

### MATERIAL DEVELOPMENT IN HUMAN RESOURCES/INDUSTRIAL RELATIONS FRONT, INCLUDING NUMBER OF PEOPLE EMPLOYED

The company's industrial relations remained cordial throughout the year. As of March 31, 2026, the company's payroll had an estimated 207 employees.

The Company regards its human capital as one of its most important assets. Various HR initiatives were undertaken during the year focusing on training and development, particularly in new machinery operation, quality control, and safety protocols. The Company has fostered a culture of safety and teamwork – regular safety drills and workshops were conducted to ensure a safe working environment in the factory. Employee welfare schemes (health check-ups, medical insurance, etc.) continued to be provided, which helped maintain high morale. Importantly, industrial relations remained cordial throughout the year.

There were no labour stoppages or disputes; management and employees (and their representative forums) worked in harmony to achieve the Company's goals. With the expansion of capacity, Agarwal Glass also generated new employment opportunities, hiring additional technicians and support staff for the upgraded plant. The Company remains committed to up skilling its employees and aligning HR policies with business needs, which in turn is expected to improve productivity and retention.

### OUTLOOK

The Company enters FY27 with a significantly larger operating base following the growth achieved in FY26 and investments made in manufacturing capabilities.

Subsequent to the close of FY26, the Company reported encouraging momentum in Q1 FY27. Revenue from operations for the quarter ended 30 June 2026 was approximately **₹34.40 crore**, compared with approximately ₹28.00 crore in Q1 FY26, representing growth of approximately 22.86%. Capacity utilisation during the quarter was approximately 57%. The executable order book stood at approximately ₹55 crore as at 30 June 2026, comprising projects across hospitality, malls, educational institutions, airports and real estate.

The Company has also received domestic DGU orders aggregating approximately **₹6.11 crore**, covering approximately 12,850 sq. metres, with execution scheduled by March 2027.

The Company has further strengthened its capital position through a preferential issue involving equity shares and convertible warrants aggregating up to approximately **₹68.04 crore**, subject to the applicable terms and conditions. Management has indicated that the funds will support expansion of processing capabilities, working capital and market development.

## NOTE 1 - CORPORATE INFORMATION & SIGNIFICANT ACCOUNTING POLICIES

### 1.1 : CORPORATE OVERVIEW

The company specializes in the manufacturing and trading of toughened and laminated glass products. ### 1.2 : SIGNIFICANT ACCOUNTING POLICIES

#### a) Basis of Accounting and Preparation of Financial Statements

The financial statements of the company have been prepared and presented in accordance with Indian Generally Accepted Accounting Principles (IGAAP) under historical cost convention unless otherwise stated and on an accrual basis. GAAP comprises accounting standards specified under section 133 of the Act, to the extent applicable, other pronouncements of Institute of Chartered Accountants of India, the provisions of Companies Act, 2013.

The Company is a small and medium sized company (SMC) as defined in the Companies (Accounting Standards) Rules, 2021 notified under the Companies Act 2013. Accordingly, the company has complied with the Accounting Standards as applicable to a Small and Medium Sized Company.

#### b) Use of Estimates

The preparation of financial statements requires estimates and assumptions that affect the reported amount of assets, liabilities, revenue and expenses during the reporting period. Although such estimates and assumptions are made on a reasonable and prudent basis taking into account all available information, actual results could differ from these estimates and assumptions and such differences, if arise, are recognized in the period in which the results are crystallized.

#### c) Current and non-current classification

All the assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle and other criteria set out in the Schedule III to the Companies Act, 2013.

##### **Assets:**

An asset is classified as current when it satisfies any of the following criteria:

- i) It is expected to be realized in, or is intended for sale or consumption in, the Company's normal operating cycle;
- ii) It is held primarily for the purpose of being traded;
- iii) It is expected to be realized within 12 months after the reporting date; or
- iv) It is cash or cash equivalent unless it is restricted from being exchanged or used to settle a liability for at least 12 months after the reporting date.

##### **Liabilities:**

A liability is classified as current when it satisfies any of the following criteria:

- i) It is expected to be settled in the Company's normal operating cycle;
- ii) It is held primarily for the purpose of being traded;
- iii) It is due to be settled within 12 months after the reporting date; or
- iv) The Company does not have an unconditional right to defer settlement of the liability for at least 12 months after the reporting date. Terms of a liability that could, at the option of the counterparty, result in its settlement by the issue of equity instruments do not affect its classification.

Current assets / liabilities include the current portion of non-current financial assets / liabilities respectively. All other assets / liabilities are classified as non-current.

#### a) Operating Cycle

Based on the nature of products / activities of the Company and the normal time between acquisition of assets and their realization in cash or cash equivalents, the Company has determined its operating cycle as 12 months

### **b) Inventories**

Inventories are valued at the lower of cost and net realizable value. Net realizable value (NRV) is the estimated selling price in the ordinary course of the business, less the estimated costs of completion and the estimated costs necessary to make the sale. Cost of inventories comprises all cost of purchase, cost of conversion and other costs incurred in bringing the inventories to their present location and condition.

### **c) Cash Flow Statement**

The cash flow from operating, investing and financing activities of the company are segregated based on the available information. Cash flows from operating activities are reported using the indirect method, whereby profit before extraordinary items and tax is adjusted for the effects of transactions of non-cash nature and any deferrals or accruals of past or future cash receipts or payments.

Cash comprises cash on hand and demand deposits with banks. Cash equivalents are short terms balances (with original maturity of three months or less from date of acquisition) highly liquid investments that are readily convertible into known amount of cash and which are subject to insignificant risk of changes in value

### **d) Property, plant & equipment (fixed assets), depreciation & amortization**

Property, plant & equipment (Fixed assets) are carried at the cost of acquisition or construction less accumulated depreciation. The cost of property, plant & equipment (fixed assets) includes non-refundable taxes, duties, freight and other incidental expenses related to the acquisition and installation of the respective assets.

Subsequent expenditure related to an item of property; plant & equipment (fixed asset) is capitalized only if it increases the future benefits from the existing assets beyond its previously assessed standards of performance.

Advances paid towards acquisition of property, plant & equipment (fixed assets) outstanding at each balance sheet date are shown under long term loans and advances. Cost of assets not ready for intended use, as on the balance sheet date, is shown as capital work-in-progress.

Depreciation on property, plant & equipment (fixed assets) is provided using the WDV method based on the useful life of the assets as specified in Schedule II to the Companies Act, 2013. Depreciation is calculated on a pro-rata basis from the date of installation till the date the assets are sold or disposed. Individual assets costing less than Rs 5000/- are depreciated in full in the year of acquisition.

### **e) Intangible Assets and amortization**

Intangible assets are recorded at the consideration paid for acquisition including any import duties and other taxes (other than those subsequently recoverable by the enterprise from the taxing authorities), and any directly attributable expenditure in making the asset ready for its intended use. Intangible assets are amortized on a systematic basis over the best estimate of their useful lives, commencing from the date the asset is available to the Company for its use.

### **f) Revenue Recognition Sale of goods**

Revenue is recognized when the significant risks and rewards of ownership have been transferred to the buyer, recovery of the consideration is reasonably certain, the associated costs and possible return of goods can be estimated reliably, there is no continuing management involvement with the goods and the amount of revenue can be measured reliably.

Revenue from the sale of goods includes excise duty and is net of returns, sales tax and applicable trade discounts and allowances.

### **g) Foreign Exchange Transactions and balances**

Company engaged in local transaction only. So, there is no requirement for Reporting of Foreign Currency.

### **h) Investments**

Investments that are readily realizable and are intended to be held for not more than 12 months from the date, on which such investments are made, are classified as current investments. All other investments are classified as non-current investments.

Current investments are carried at the lower of cost and fair value. The comparison of cost and fair value is done separately in respect of each category of investment.

Non-current investments are carried at cost less any other-than-temporary diminution in value, determined separately for each individual investment. The reduction in the carrying amount is reversed when there is a rise in the value of the investment or if the reasons for the reduction no longer exist. Any reduction in the carrying amount and any reversal in such reductions are charged or credited to the statement of profit and loss.

### **i) Employee Benefits**

Employee benefits are recognized as an expense at the undiscounted amount expected to be paid over the period of services rendered by the employees to the Company.

### **j) Borrowing costs**

General and specific borrowing costs directly attributable to acquisition or construction of those fixed assets which necessarily take a substantial period of time to get ready for their intended use are capitalized. Borrowing costs are interest and other costs incurred by the Company in connection with the borrowing of funds. All other borrowing costs are recognized in the statement of profit and loss in the period in which they are incurred.

### **k) Segment Reporting**

Company does not have any segment. So Segment Reporting is not applicable on company.

### **l) Leases**

There is no such lease transaction during the year under our audit.

### **m) Earnings per share**

The basic earnings per share ("EPS") is computed by dividing the profit after tax for the year by the weighted average number of equity shares outstanding during the year. For the purpose of calculating diluted earnings per share, profit after tax for the year and the weighted average number of shares outstanding during the year are adjusted for the effects of all dilutive potential equity shares. The dilutive potential equity shares are deemed converted as of the beginning of the period, unless they have been issued at a later date.

### **n) Taxation**

Current income tax expense comprises taxes on income from operations in India and in foreign jurisdictions. Income tax payable in India is determined in accordance with the provisions of the Income Tax Act, 1961. Tax expense relating to foreign operations is determined in accordance with tax laws applicable in countries where such operations are domiciled.

Minimum alternative tax (MAT) paid in accordance to the tax laws, which gives rise to future economic

benefits in the form of adjustment of future income tax liability, is considered as an asset if there is convincing evidence that the Company will pay normal income tax after the tax holiday period. Accordingly, MAT is recognized as an asset in the balance sheet when it is probable that the future economic benefit associated with it will flow to the Company and the asset can be measured reliably.

Deferred tax expense or benefit is recognized on timing differences being the difference between taxable incomes and accounting income that originate in one period and are capable of reversal in one or more subsequent periods. Deferred tax assets and liabilities are measured using the tax rates and tax laws that have been enacted or substantively enacted by the balance sheet date.

In the event of unabsorbed depreciation and carry forward of losses, deferred tax assets are recognized only to the extent that there is virtual certainty that sufficient future taxable income will be available to realize such assets. In other situations, deferred tax assets are recognized only to the extent that there is reasonable certainty that sufficient future taxable income will be available to realize these assets.

Advance taxes and provisions for current income taxes are presented in the balance sheet after offsetting advance taxes paid and income tax provisions arising in the same tax jurisdiction and where the Company intends to settle the asset and liability on a net basis.

The Company offsets deferred tax assets and deferred tax liabilities if it has a legally enforceable right and these relate to taxes on income levied by the same governing taxation laws.

### **o) Impairment of assets**

The Company assesses at each balance sheet date whether there is any indication that an asset may be impaired. If any such indication exists, the Company estimates the recoverable amount of the asset. If such recoverable amount of the asset or the recoverable amount of the cash generating unit to which the asset belongs is less than its carrying amount, the carrying amount is reduced to its recoverable amount. The reduction is treated as an impairment loss and is recognized in the statement of profit and loss. If at the balance sheet date there is an indication that if a previously assessed impairment loss no longer exists, the recoverable amount is reassessed and the asset is reflected at the recoverable amount subject to a maximum of amortized historical cost.

### **p) Provisions and contingent liabilities and contingent assets**

A provision is recognized when the Company has a present obligation as a result of past events and it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation. Provisions are measured at the best estimate of the expenditure required to settle the present obligation at the balance sheet date.

#### **Contingent liabilities and contingent assets**

A disclosure for a contingent liability is made when there is a possible obligation or a present obligation that may, but probably will not, require an outflow of resources. Where there is a possible obligation or a present obligation in respect of which the likelihood of outflow of resources is remote, no provision or disclosure is made.

Contingent assets are not recognized in the financial statements. However, contingent assets are assessed continually and if it is virtually certain that an inflow of economic benefit will arise, the asset and related income are recognized in the period in which the change occurs.

### **q) Research and development**

Revenue expenditure pertaining to research is charged to the Statement of Profit and Loss. Development costs of products are also charged to the Statement of Profit and Loss unless a product's technical feasibility has been established, in which case such expenditure is capitalized. The amount capitalized comprises expenditure that can be directly attributed or allocated on a reasonable and
