Subject: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015– Temporary suspension of operations at Manufacturing Unit.

Dear Sir/Ma'am,

Pursuant to Regulation 30 read with Para B of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI LODR Regulations”), we wish to inform you that the management of the Company has decided to temporary close/suspend the operations of the Company’s manufacturing unit with effect from May 16th, 2026.

The decision has been taken due to continued non-availability and disruption in supply of industrial gas required for production operations, arising from prevailing macro-economic conditions and international trade-related issues affecting the supply chain and procurement ecosystem.

In view of the above circumstances, continuation of manufacturing operations has become commercially and operationally unviable for the Company at present.

The Company is taking all necessary steps in compliance with applicable laws and regulations, including:

- safeguarding the interests of employees, workers, customers and other stakeholders;
- complying with contractual and statutory obligations; and
- evaluating alternative sourcing arrangements and future operational strategies.

The Company shall continue to assess the evolving market conditions and shall inform the stock exchange regarding any further material developments in accordance with applicable provisions of SEBI LODR Regulations.
