Sub: Clarification for Financial Results - AGI Greenpac Limited

With respect to the captioned subject and your email dated 9th December, 2024 seeking clarification on your observation that the financial results submitted is not as per format prescribed by SEBI and standalone and consolidated figures are same.

In this regard, we would like to submit that there is no deficiency in the financial results submitted by the Company, and the format is also as prescribed by the SEBI. Additionally, we would also like to submit the following points in response to our clarification:

- 1. That the Company's subsidiary i.e. "AGI Retail Private Limited" ("Subsidiary") was incorporated during the 2nd quarter i.e. on 27th August, 2024. Therefore, it was necessary to prepare consolidated and standalone financial statements for the period ended 30th September 2024.
- 2. That there were incorporation expenses of Rs.1.47 lakh only in subsidiary, which were considered while preparing consolidated financial statements. Additionally, the results were prepared in crores, therefore exact amount impact not appeared in financial statements due to rounding off to crores. You may kindly observe that in Profit & Loss statement under the head "other expenses" there is a difference of Rs.0.01 crore.
- 3. That in the Balance Sheet also you may observe that all the figures are not same in standalone and consolidated.
- 4. That in the Cashflow Statement also you may observe that there is a difference of Rs.0.01 crore.

Hope above will satisfy your query.
