E-Voting:

- (i) The e-voting period remained open from Sunday, 25th September, 2016 (09.00 a.m.) to Tuesday, 27th September, 2016 (05.00 p.m.)
- (ii) The members of the Company as on the "cut-off" date i.e. 21st September, 2016 were entitled to vote on the resolutions (items no. 1 to 8 as set out in the notice of the 10th Annual General Meeting of the Company).
- (iii) The votes cast under remote e-voting facility were thereafter unblocked in presence of two witnesses, who were not in employment of the Company.
- (iv) The Corporate members, who had participated in the remote e-voting, had provided the scanned copy of the resolution passed at the Board of Directors for authorization to exercise their votes through e-voting.
