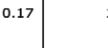

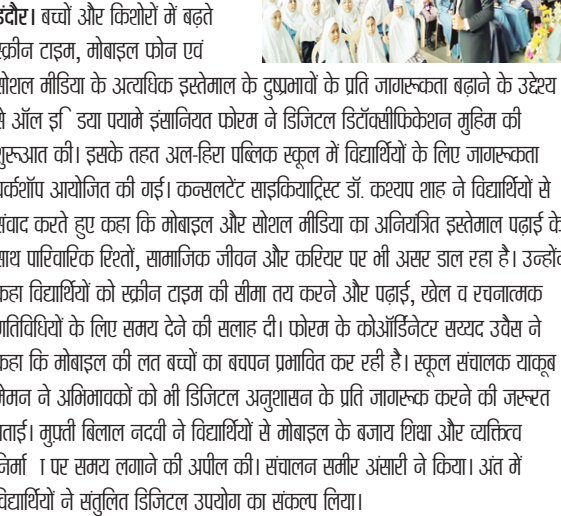

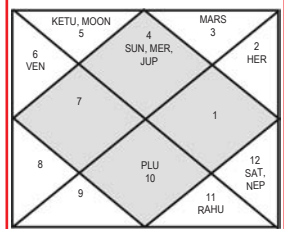

BMC issues 1,135 fresh notices on day 5

Bhopal Municipal Corporation (BMC) on fifth day of its citywide crackdown against commercial activities operating from residential properties, issued 1,135 fresh notices on Thursday, including city's prominent shopping complex Aura Mall. With this, the total number of notices issued so far has reached 3,316.

The BMC has set a target of carrying out more than 100 demolitions and sealing around 1,000 properties found violating land-use and building norms, after getting 144 stays vacation from the Jabalpur High Court. Officials said action was being taken in compliance with Supreme Court directions.

Action against illegal construction

The BMC also removed illegal construction and encroachments in Indus Muskan Colony near Ayodhya Bypass. In another operation at Khejra Baramad, illegal structures linked to an unauthorised colony being developed on about 2.3 acres were demolished. Separately, action was taken against unauthorised construction within the 50-metre limit of the Bhoj Wetland's Full Tank Level.

Aura Mall served notice

Officials from BMC Building Permission Wing inspected Aura Mall and issued a notice under Section 302(1) of Madhya Pradesh Municipal Corporation Act, 1956, after allegedly finding changes to the building's elevation. The owner/developer has been asked to submit documents and explanations and ensure that construction conforms to the approved plan and building permission.

Shan-e-Bhopal Rail coach restaurant likely to be shifted to Smart City Park

Shan-e-Bhopal Rail Coach Restaurant may be shifted to Smart City Park in TT Nagar. Madhya Pradesh State Tourism Development Corporation (MPSTDC) has sent a proposal regarding this to the state government. The shifting has become necessary as Lake View Hotel, where the restaurant was located, has been handed over to a consortium of private companies for redevelopment.

Launched in March 2007 by ITDC, which used to run what was then known as Ashoka Lake View, in collaboration with Railways, the Shan-e-Bhopal was one of the first rail-themed restaurants in the country. Set up in a refurbished retired second class coach, it was immensely popular among the locals and tourists alike. The coach is currently parked on Lake View premises.



Sair Sapata, Kerwa Dam options closed: Formal permission sought from govt

An MPTDC official said formal permission has been sought from the state government to set up the restaurant at Smart City Park. The proposed site is close to the city's tourist attractions including Indira Gandhi Rashtriya Manav Sangrahalaya (IGRMS), the Tribal Museum, and the State Museum. Earlier plans to shift the restaurant to Sair Sapata Park were dropped due to reasons, which are not clear. Other options, including Kerwa Dam, were also explored, but none could be finalised.
