# North Korea to mass produce self-detonating drones: Report

Korean leader Kim North Korean leader Kim Jong Un has ordered his country to quickly start mass producing self-detonating ex-plosive drones, calling their development an "essential requirement," after over-seeing a test of the deadly aerial weapon, state media reported Friday, according to CNN. Images published by North Korean state media show

Images published by North Korean state media show Kim and various officials at the launch site. Images show a car and a tank being de-stroyed by what appears to be unmanned aerial whicles, which have been heavily blurred by the news agency. State media reported that drones "of various types pre-cisely hit the targets" as part of the test. They can be "used

within different striking ranges' and are designed "to precisely attack any enemy targets on the ground and in the sea," it said.

Such self-detonating drones, also sometimes referred to as suicide drones, shave been widely used to great effect on the battlefield in Russia's war in Ukraine and in the Middle East.

Comparatively cheap to produce and usually deployed in swarms making their numbers difficult to shoot down.
