Ukraine can win back lost territory: Trump

US President Donald Trump said on Tuesday he believed Ukraine could win back all territory lost to Russia, a dramatic shift from his repeated calls for Kyiv to make concessions to end the war.

Trump made his comment in a post on Truth Social after meeting Ukrainian President Volodymyr Zelenskyy on the sidelines of the UN General Assembly. "With time, patience, and the financial support of Europe and, in particular, Nato, the original borders from where this war started, is very much an option," Trump said. "Trump is a game changer by himself," Zelenskyy said after the meet.

In the post, Trump criticised Russia, saying it had been fighting "aimlessly" in a war that a "real military power" would have won in less than a



week. "This is not distinguishing Russia. In fact, it is very much making them look like a paper tiger."

PRODDING NATO

He hinted at stronger action against Moscow. "Putin and Russia are in big economic trouble, and this is the time for Ukraine to act," the post said, adding, the US will continue to supply weapons to allies "for Nato to do what they want with them."

He said Nato countries should shoot down Russian aircraft that violate their airspace. Recently, Russian fighter jets and drones have violated airspace of Poland, Romania and Estonia.

MOSCOW SCOFFS

The Kremlin, however, rejected Trump's remarks about Ukraine retaking lost territories, saying Russia is an "integral part of European security".

Stop Russia now or Putin will expand war wider, deeper: Zelenskyy

Ukrainian President Volodymyr Zelenskyy on Wednesday told world leaders on Wednesday Vladimir Putin will keep driving the Ukraine war "wider and deeper" unless he is stopped.

Addressing the UN General Assembly, he calls for countries to work together as "peace depends on all of us".

He said the world is in "the most destructive arms race in history" and called on the international community to act against Russia now, asserting that Vladimir Putin wants to expand his war in Europe.

Global South under attack: EAM @ UN

External Affairs Minister S Jaishankar has urged Global South countries to reduce dependence on any single supplier or market by building resilient supply chains, alongside promoting fair economic practices, and boosting South-South trade and technology collaborations.

Speaking on the sidelines of the UNGA in New York, he said

the rights of Global South nations were under attack and chalked out a plan of action as to how they could deal with them. "The rights and expectations of developing countries in the international system – which has been so assiduously developed over many decades – are today under challenge," said Jaishankar.

"The building blocks of the contemporary order are starting to come apart. And the cost of delaying much-needed reforms

is today starkly visible," he said. The criticism of "contemporary order" would be viewed as interesting, as it comes after his meet-

ing with US Secretary of State Marco Rubio, who said India remained a partner of "critical importance".
