Dear Sir/Madam,

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('SEBI Listing Regulations'), we would like to inform that the Company has imported certain machinery under EPCG Scheme during the years 2017, 2018 and 2019. On 09th August 2025, the Superintendent of Customs (EOMC, HQRS), Customs Department, Hyderabad and Appraising Officer of Customs, Hyderabad have unilaterally seized in the premises, the said imported machinery (Capital Goods) without giving any opportunity/notice/showcause notice/letter/correspondence and without considering the submission made by the Company when the applications for extension of time for export obligation filed by the Company for various licenses are pending before the DGFT. The Company is in the process of taking legal course of action in the interest of the Company and Justice.

The details under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with Clause 19 of Para A of Part A of Schedule III are enclosed as **Annexure 'A'**.

a).	Name of the Authority	Superintendent of Customs(EOMC, HQRS), Hyderabad Customs Commissionerate) and Appraising Officer of Customs, Hyderabad.
b).	Nature and details of actions taken, initiated or orders passed:	The Authority has seized the Machinery (Capital goods) of the Company imported by the Company under EPCG scheme under various licenses on the pretext of noncompliance of the Export obligation though the Company has applied for extension of time for compliance of Export Obligation with DGFT.
c).	Date of receipt of Direction/Order, including any ad-interim orders or any other communication from the Authority	09.08.2025
d).	Details of the violations committed or alleged to be committed.	The goods were seized by the said Authority under the reasonable belief that the Company failed to comply with the provisions of Export Promotion of Capital Goods Scheme.
e).	Impact on financial, operation or other activities of the listed entity quantifiable in monetary terms to the extent applicable	The operations will beaffected due to the unjustifiable Seizure of the Machinery (Capital goods) of the Company.
f).	Remarks/Action from the Company side.	The Company has applied for extension of the time limit for export obligation, and it is in the process of consideration before DGFT. However, the Customs Authorities have seized the Capital goods of the Company without consideration of the process of extension. The Company is under process of filing of Petitions before the concerned legal forums /Courts on unjustifiable action of the Customs Authorities.
