Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('SEBI Listing Regulations') and with reference to the Seizure intimation on 09.08.2025 under four EPCG Licenses, it is to inform that the office of the Principal Commissioner of the Customs, Hyderabad, vide Order No. C.No. CUS/HYD/38/2025-SIIB dated 25.08.2025 has considered the letter dated 22.08.2025 of the Company along with extensions granted by the DGFT with respect to the Export Obligation period and lifted the Seizure and the concerned officers on 26.08.2025 have unsealed the machinery that was seized vide Seizure memo dated 09.08.2025 with respect to three EPCG Licenses.

The Machinery was seized by the said Authority under the reasonable belief that the Company failed to comply with the provisions of Export Promotion Capital Goods Scheme, but the Company has not committed violation under the provisions of Foreign Trade Policy and relevant applicable Rules in force since the DGFT, Hyderabad has granted extension of time for complying the Export Obligation under various licenses.
e).	Impact on financial, operations or other activities of the listed entity quantifiable in monetary terms to the extent applicable	There is no impact on financial or the operations of the Company due to lifting of seizure with respect to three licenses.
f).	Remarks/ Action from the Company side.	The Company has applied for extension of the time limit for export obligation for four licenses and has received approval for three licenses while one is in process. The Company has also filed WP No. 24008/2025 challenging the Seizure before Hon'ble High Court of Telangana at Hyderabad.
