1. We Asian Hotels (West) Ltd. (hereinafter referred to as the "**Company**") are in receipt of the email dated March 26, 2026, vide which your goodself has sought clarification regarding financial statements submitted for period ending June 30, 2024, March 31, 2025, and June 30, 2025.
2. In regards to the financial statements pertaining to period ending June 30, 2024, it is humbly submitted that only the standalone financial results were submitted on October 7, 2024. The consolidated financial results pertaining to period ending June 30, 2024, was submitted on November 28, 2024.
3. It is further submitted that the financials pertaining to the aforesaid period was approved in the Board meeting held on November 27, 2024. In the said Board meeting, along with financials pertaining to quarter ending June 30, 2024(consolidated), the quarterly financials for the following quarters were also approved:
 - i. Quarter ending March 31, 2021
 - ii. Quarter ending June 30, 2021
 - iii. Quarter ending September 30, 2021
 - iv. Quarter ending December 31, 2021
 - v. Quarter ending March 31, 2022
 - vi. Quarter ending June 30, 2022

- vii. Quarter ending September 30, 2022
- viii. Quarter ending December 31, 2022
- ix. Quarter ending March 31, 2023
- x. Quarter ending June 30, 2023
- xi. Quarter ending September 30, 2023
- xii. Quarter ending March 31, 2024

It is hereby clarified that the aforementioned financial statements were duly considered and approved at the meeting of the Board of Directors held on November 27, 2024, as the Company had previously been undergoing through Corporate Insolvency Resolution Process (CIRP). Consequently, the financial statements for the quarter ended June 30, 2024 do not contain comparative figures, as the financials pertaining to prior periods were also finalised and approved concurrently at the said Board meeting.

In regards to financial statements pertaining to period ending March 31, 2025, and June 30, 2025, as per our knowledge, we are of the belief that the same are accurate in terms of format and presentation. However, if there are any discrepancies or inconsistencies which require clarification or correction, we kindly request you to identify the same and let us know. In the absence of such identification, we are unable to undertake any steps required for correction/clarification.
