INDIA'S FIRST NAMO RRTS CORRIDOR FROM DELHI TO MEERUT OPENS TO PUBLIC

'Corridors from Delhi to Alwar, Kamal set to get nod this fiscal'

WITH TWO new rapid corridors starting from Sarai Kale Khan in Delhi expected to get a green-light soon, **Shalabh Goel, Managing Director, National Capital Region Transport Corporation (NCRTC)**, the executing agency of the project, talks to **Devansh Mittal** about transit-oriented development, focus on AI use and reducing air pollution.

What is the status of upcoming corridors?

The ones from Delhi to Alwar and Delhi to Kamal are under consideration at a very senior level, and are expected to get approved this financial year. Among other proposed corridors, the Ghaziabad-Jewar and Noida-Paritosh-Gurgaon corridors are at a more advanced stage.

How is NCRTC helping tackle NCR's air pollution?

After commissioning of the Delhi-Meerut corridor, we expect that around one lakh vehicles could come off the road. This will lead to a reduction of approximately 2.5 lakh tonnes of CO₂.

NCRTC hired Deutsche Bahn, Germany's national rail firm, for operations and maintenance. How has that worked out?

Deutsche Bahn brought a new model to the country. It brings international experience, which helped with reducing costs and manpower requirements. It is a win-win situation.

What initiatives are being taken on transit-oriented development?

Transit-oriented development (TOD) is a model to the country. It brings international experience, which helped with reducing costs and manpower requirements. It is a win-win situation.

Our experience with the UP government has been very positive. We jointly framed the TOD policy and defined value capture finance instruments, which means that incremental value with development of infrastructure should also benefit the government and the transit agency.

PM NARENDRA Modi on Sunday inaugurated the country's first regional rapid transit system (RRTS)—the 82-km Delhi-Meerut Namo Bharat corridor developed at the cost of Rs 30,000 crore—which cuts the travel time between the two cities to less than an hour. With 16 stations connecting Sahibabad, Ghaziabad, and Modinagar, among other urban centres, it has become possible to live in Meerut and commute to Delhi for work for lakhs of people.

The inauguration of the Meerut Metro, Namo Bharat train, and the new section of the RRTS will make the lives of people in the NCR simpler, and more convenient," PM said. Earlier, 55 km of the corridor between New Ashok Nagar and Meerut South was open. PM Modi on Sunday inaugurated the 25-km stretch in Delhi between Meerut South and Modipuram, which will use the same tracks and infrastructure as the semi-high-speed Namo Bharat trains.

"The government's investment in them is infrastructure—including expressways, freight corridors, and the Jewar International Airport is creating vast employment opportunities," the PM said, and added, "Before 2014, Metro services reached only 11 cities, but now metros are running in more

PARTNER HELD FOR TORTURING HER AT GURGAON HOME

Confined for days, beaten and sexually assaulted by partner, claims Tripura teen

Private parts burnt, claims teen; police say will ensue speedy investigation

A 19-YEAR-OLD woman from Tripura is hospitalised in Delhi and recovering from serious injuries after she was allegedly confined by her partner in a rented accommodation in Gurgaon for days, and sexually and physically assaulted, police said on Sunday. The accused, who is also 19, was arrested on February 19 and subsequently sent to judicial custody after the woman's mother alerted the police from Tripura, where she lives, and a team of officers rescued the woman from the rented home.

The survivor, a student of a private university, had managed to call her mother and inform her about the assault, said police, adding that she met the accused, a resident of Delhi, last September via a social media app. Gurgaon Police's spokesperson ASI Sandeep Kumar said, "They were in a live-in relationship and were staying in a paying guest accommodation in Gurgaon. The relationship apparently deteriorated due to frequent disputes. This led to repeated physical abuse, culminating in the assault following late-night argument."

An FIR was registered on February 19 against the accused on charges of voluntarily causing hurt by grievous means, wrongful confinement, and sex-

ual intercourse by deceitful means. However, the woman's family has demanded that sections for rape and attempt to murder be added too.

ASI Kumar said, "We will soon file the chargesheet, have witnesses ready and ensure a speedy trial, given the seriousness of the matter." A police officer said, "More charges like rape will be added once a conclusive report from the doctor is received regarding the extent of injuries, and other details. The doctor's opinion in this regards is awaited, but the FIR will be pressed for sections for attempt to murder and rape to be added at the earliest." Rai claimed that the woman was coerced into living together.

Even as investigators suspect that discussions regarding their marriage were underway between the families, the woman's mother denied the claims. "We arrived in Delhi by flight on February 19. He (the accused) was raving and my daughter's life, even hanging him will not suffice. My daughter, during the call, said—'Ma, come and save me.' Even today, she won't eat anything. The accused has brought us unimaginable pain and suffering. Once she is better, we will have her give another statement to the police." In January, the survivor had filed an FIR against her partner after she was sexually assaulted, said her mother.

Couple booked for hurling racial slurs at 3 women from Arunachal

A COUPLE has been booked for allegedly hurling racial slurs and intimidating three women from Arunachal Pradesh in South Delhi's Malviya Nagar, police said on Sunday.

According to the Delhi Police, a case has been registered at the Malviya Nagar police station under BNS sections 79 (word intended to insult a woman's modesty), 35(2) (criminal intimidation), 365 (common intention) and 196 (promoting enmity on

grounds of religion, race, place of birth, residence, language) against a husband and his wife Ruby Jay. The women and the couple live in the same building.

Police said the women were allegedly targeted on February 20 around 3:30 pm when they were getting an air conditioner installed at their rented home. During the process, some debris allegedly fell in the houses of the accused, who live on the lower floor.

Following this, the accused allegedly verbally abused the trio. The complainants alleged

ADAY after security agencies issued a possibility of a terrorist attack near Red Fort by terror outfit Lashkar-e-Taiba, Delhi Police Sunday said that eight people—including six Bangladeshi nationals—were arrested in Tamil Nadu and West Bengal over alleged links with Pakistan's ISI intelligence agency and Bangladesh-based terrorist organisations.

Officers said that videos in their phones revealed they conducted exercises in multiple states for alleged terror operations.

Police said six of them—identified as Md Mizanur Rehman (32), Md Sefayat Hossain (34), Md Zahidul Islam (40), Md Liton (27), and Umar (32)—were working at three garment factories in Tamil Nadu and were arrested on Saturday during a joint operation by the Delhi Police Special Cell and the Tamil Nadu Police, officers said.

"The police got on their trail after posters reading 'Free Kashmir' were put up at metro stations during the AI Summit, recently held in the Capital," officers said. "The metro police tracked down the two who affixed the posters. The trail showed that both absconded in Kolkata," Additional CP (Special Cell) Pramod Singh Kushwah

Police said multiple raids were conducted in Kolkata during which Umar Farooq and Robil Islam, a Bangladeshi national, were arrested.

"Robil had previously been arrested in 2007 in India. He and Umar were getting directions from one Shabir Ahmad Lone from Bangladesh," an officer said, adding that "similar videos were affixed by the accused at metro stations in Kolkata on February 10."

"They affixed the posters on February 7 night at 10 different locations in Delhi. They also made videos and sent these to the media to create a buzz and directed them to affix posters in Kolkata too," Kushwah said.

Umar and Robil were allegedly also tasked with recruiting people of Bangladeshi origin for terror-related operations, and they hence got in touch with the six garment factory workers in Tamil Nadu, police said. "Raids were conducted at three fac-

Hundreds of students march in JNU as protest against VC escalates

SEVERAL HUNDRED students of Jawaharlal Nehru University (JNU) marched across the campus late on Sunday night, escalating the protests against Vice-Chancellor Sanjiv Shree Dhullipudi Pandit over her remarks in a recent podcast interview and the rustication of elected students of the JNU Students Union (JNUSU).

The march began at Sabarmati Point and proceeded to the East Gate near the VC's residence, where student leaders addressed the crowd. Protesters said the turnout represented "the whole of JNU", and described it as one of the largest mobilisations on campus in recent months.

"We are protesting against the VC's casteist remarks... and against the rustication of the JNUSU office bearers," said Nishu Kumar, former JNUSU president rusticated last year for participating in protests against the installation of a facial recognition system in the university's Central Library. "Such a VC has no place in a campus like JNU," he said. He said the march would later be diverted towards several academic schools on campus. "We will be doing a lockdown where we will divert the march to these schools and lock them," he said.

The protest followed a JNUSU statement on Friday demanding the VC's resignation over what it called "blatantly casteist statements" made during last month. Responding to the controversy, Pandit later told

jected in particular by her criticism of the University Grants Commission's new equity regulations, which she described as "totally unnecessary", "irrational", and an example of "wokism".

In an interview, Pandit said, "You cannot progress by being permanently a victim or playing the victim card. This was done for the Blacks; the same thing was brought for Dalits here."

The union said the remarks reflected "the chronology of injustice, caste supremacy, and perpetual systemic exclusion," and announced a "national protest day" to press for her resignation. The comments were made during a 52-minute podcast interview with The Sunday Guardian, published on February 16, in which Pandit spoke at length about student protests on campus, the recent rustication of JNUSU office bearers, and what she described as the role of Left-wing politics. JNU. She also addressed the UGC equity regulations, which were stayed by the Supreme Court last month. Responding to the controversy, Pandit later told

PTI that her remarks had been taken out of context and rejected the allegation that they were casteist. "I am a Bahujan myself. I come from an OBC background," she said.

"I meant that wokes have written history like this. And those who opposed workers had this to say about permanent victimhood and imaginary worlds being created," she said.

On the equity regulations, Pandit said during the interview that they had been introduced without adequate consultation. "It was done secretly. Many of us who are part of the system didn't even know what was in it," she said, calling the regulations unnecessary and constitutionally flawed.

During the podcast, she also defended the university administration's decision to rusticate five student leaders for allegedly vandalising surveillance equipment at the Ambedkar Library. "They destroyed this property, literally broke it down, sat on top of it, took pictures and they themselves put it on social media although they have done something great," she said.

She added that the students had been charged under what she described as the Public Destruction of Public Property Act—apparently referring to the Prevention of Damage to Public Property Act, 1984—calling it a "very strong Act." The administration, she argued, had shown restraint by barring the students for two semesters and imposing a fine of Rs 20,000. "It is taxpayers' money. I am answerable to the government and to the people of India," she said.
