Subject : Updates

With reference to the Intimation made to National Stock Exchange dated 31st December, 2020, We would like to inform that Airan Limited has entered in to Service Agreement with Standard Chartered Bank, for outsourcing of their various transaction processing activities through CTS (Cheque Truncation System), CMS (Cash Management Services) and Mobile based CTS system in 34 countries.

Due to COVID international travel restrictions, the implementation of this mandate is started with Indian domestic operations and the same is almost entirely implemented by December 2021.

Standard Chartered Bank, Thailand operations are also started remotely and CMS & CTS Clearing process is implemented.

Operations in UAE is expected to start in February 2022. All the formalities like Third Party InfoSec audit and technical alignment is already completed.

The operations in Singapore, Philippines, Hong Kong, Bangladesh is likely to be commenced within this financial year. The commencement of operations in other countries will be followed in next financial year.

The wholly owned subsidiary of the company, Airan Global Private Limited is already operating from the IFSC (International Financial Services Center) of The GIFT City, Gandhinagar and started operations for their Australian clients via our another offshore wholly owned subsidiary Airan Australia Pty Ltd.
