### 1. Expansion in Production capacity:

Our Company is specializing in the manufacturing of high-quality decorative laminate sheets. We are proud to announce that we have successfully expanded our production capacity. Our existing installed capacity for decorative laminates stands at 38,40,000 sheets per annum, and with the recent expansion, this capacity has increased by 20,64,000 sheets per annum. As a result, our total installed capacity is now 59,04,000 sheets per annum.

### 2. Expansion in Solar Capacity:

In addition to our manufacturing capacity, we have also made notable strides in enhancing our renewable energy infrastructure. Currently, our solar energy capacity is 1 MW, and we have completed an expansion to 2.5 MW in the fiscal year 2023-24.
