SUMMARY OF PROCEEDINGS OF THE 13th ANNUAL GENERAL MEETING HELD ON 05TH SEPTEMBER, 2023

- The 13th Annual General Meeting of the Members of Ajooni Biotech Limited was held on Tuesday, 05th September, 2023 at 11.00 A.M through video conferencing ('VC')/ other Audio visual means (OAVM) facility.
- Mr. Jasjot Singh, Managing Director and the Chairman, chaired the proceedings of the Meeting.
- The numbers of shareholders as on record date 29th August 2023 were 21748.
- The requisite quorum being present, the Chairman called the meeting in order and introduced the Directors and Officials present at the meeting.
- The Chairman informed that this meeting has been convened and being conducted in accordance with the circulars issued by Ministry of Corporate Affairs and Securities and Exchange Board of India (SEBI). The Chairman informed that the Company had tied up with National Securities Depositories Limited (NSDL) to provide facility for voting through remote e-voting, VC / OAVM facility for AGM and e-voting during the AGM.
- The Company provided the members the facility to cast their votes electronically on all the resolutions set forth in the Notice. The remote e-voting commenced at 9.00 a.m. on Friday, 01st September, 2023 and ended at 5.00 p.m. on Monday, 04th September, 2023. The Chairman informed the Members that the facility for voting through e-voting system was made available during the Meeting for Members who had not cast their vote prior to the Meeting.
- The Company had appointed M/s. SDK & Associates, Practicing Company Secretaries, Punjab as the Scrutinizer for the purpose of scrutinizing the process of remote e-voting held prior and post AGM.
