US Open

Williams sisters lose thriller; Alcaraz, Sabalenka win

Serena and Venus Williams were once again the main attraction at the US Open, and defending men's champion Carlos Alcaraz made sure he would be watching. "I think there is no better plan (than) to watch the doubles, the Williamses once again, while getting a treatment," Alcaraz said after his victory. "I'm going to be ready for that." The sisters produced a thriller on Friday night but squandered a 5-0 lead in the

deciding 10-point match tiebreaker to lose 6-3, 6-7 (6), 7-6 (10-7) to Hao-Ching Chan and Maya Joint. Playing their first US Open match together since 2022, Serena and Venus fought back from 4-1 down in the third set before faltering late in front of a packed Arthur Ashe Stadium. "I think the crowd is pretty much what we expected. We expected a full stadium, everyone cheering for them, which, pretty much was that," Joint said. Serena returned to tennis this year at 44, while Venus

has continued playing on tour at 46. Both double-faulted during the deciding tiebreaker after dominating its opening stages. It was Serena's second loss to Joint this summer after the Australian beat her in three sets at Wimbledon. Serena and Venus subsequently withdrew from the Wimbledon doubles after Serena injured her knee. Elsewhere, Alcaraz cruised into the fourth round with a 6-3, 6-4, 6-1 victory over Wu Yibing. Two-time defending women's champion Aryna Sabalenka was

made to work harder before beating Kamilla Rakhimova 6-3, 6-4. Sabalenka briefly approached the chair umpire during the match after being bothered by the smell of

marijuana in Louis Armstrong Stadium. "I was like, guys, you can do whatever, you can smoke whatever, you can relax as much as you can, but please, do not do it around the tennis courts," Sabalenka said. Third seed Jessica Pegula recovered from a disastrous opening set to beat 2021 runner-up Leylah Fernandez 1-6, 6-4, 6-3. She will next face Sorana Cirstea, who defeated No. 19 Jasmine Paolini 6-3, 6-3. Taylor Townsend beat Diana Shnaider 6-2, 6-7 (3), 6-3 and will face Sabalenka.
