of the six wolves that were brought to Ambari from Sakkarbaug in a Jagunah six months ago. They were released in an open enclosure last week by state minister for forest, environment and climate change Mulu Bera

Three held for damaging hospital property, IMA demands action

Ahmedabad: Three persons have been arrested for allegedly vandalizing a hospital in CTM on Monday after a woman's death. A complaint filed by a doctor at Ramol police station had named 15 people. The incident has prompted the officers-bearers of the Indian Medical Association to write a letter to the state government, demanding stringent action against the accused. Dr Parth Shah, a resident of Navrangpura, has been running Rajni Gynecology Hospital in the CTM area for the past 12 years. On Feb 3 Suhana Altaf Saiyed, a resident of Ramol, was admitted to his hospital after she went into labour. The FIR states the sonography showed the fetus was dead and the same was communicated to the family. Around 9pm, she delivered the dead child without complications. Around 11am on February 4, she began bleeding after which the medical team informed her family that her uterus needs to be removed. The family reportedly did not allow it and asked for discharge against medical advice. She was moved to SVP Hospital but died during the treatment. On Monday, the patient's husband, hospital, his father covered with a handkerchief, and spilled a liquid at the reception area. The guards caught the person who was identified as Zakir Saiyed, Suhana's brother. The patient's husband, brother, father, and others reportedly vandalized the hospital with sharp weapons and sticks. Ramol police inspector C R Rana said three persons have been arrested in connection with the incident. On Tuesday, the officers-bearers of Indian Medical Association - Gujarat State Branch (IMA-GSB) wrote a letter to Harsh Sanghani, MoS (home), demanding stringent action in the case. "In light of the distressing event, we urge the government to intervene urgently and decisively to ensure that justice is served. It is imperative that the culprits be brought to justice through the full extent of the law," the letter states. Dr Nita Thakre, ex-secretary of Ahmedabad & Obstetrics and Gynaecological Society (AOGS), said violence is not the solution and will damage healthcare services in a big way. "Many times, doctors are believed to be the culprits when they are not responsible for whatever happened," she said. Dr Jayprakash Shah, director of Rajni Hospital, and AOGS president, said that the condition in which the woman had come in was such that it could cause deadly complications like failure of clotting mechanisms.
