'If you have the strength, go to Pakistan and hoist the flag'

FIR against two who hoisted the Jain flag on Girnar's Oghd peak; Don't create obstacles in the eternal tradition: Shernath Bapu



Junagadh, ?A controversy has once again erupted over the ownership of peaks and religious encroachment on Girnar mountain in Junagadh. A case has been registered against two unidentified persons at Bhavnath police station for hoisting the Jain flag and shouting slogans on Girnar's Oghd peak. There is a lot of anger among the saints of the Nath sect in this matter and leading saints of Sanatan Dharma have called this act an affront to the Sanatan tradition. 'Act of spreading enmity between Nath and Jain sect by chanting slogans' An official complaint has been filed in this matter at Bhavnath Police Station by Mahant Pir Yogi Somnathji Gurushree Rajnathji (aged 55) of Shrinathji's Dalicha. According to the complaint, about 4 days ago, two unknown persons wearing white clothes had hatched a criminal conspiracy at Oghadnath Tuk (fourth Tuk), which is considered a holy place of Nath sect on Girnar mountain. These persons had secretly taken the flag of Jain sect from below and hoisted it on Oghadn peak. The complaint states that these persons had spread enmity between Nath sect and Jain sect by chanting slogans there. Based on the photos and videos that went viral on social media, the police have started searching for this person. Yogi Shernath Bapu's strong attack on the incident After the controversy at Oghd Peak, a strong statement has come to the fore by Junagadh's leading saint Yogi Shernathji Bapu. He strongly criticized this act of the Jain community and said that religion is best in its own place, but showing ferocity by going to another's religious place to prove the superiority of one's religion is the biggest sin.

Tensions ahead of Mahashivratri fair: A mini Kumbh Mela of Mahashivratri is going to be held in Junagadh in the near future, in which lakhs of devotees are going to gather. At such a time, there is a fear that these controversial activities taking place on the peaks of Girnar will disrupt public peace and order. The saints have clearly told the administration that if strict action is not taken against such elements, unrest may occur during the upcoming fair. Currently, the Bhavnath police have registered a case and are working to arrest the accused on the basis of technical surveillance and social media footage. Earlier, the saints had submitted a complaint in this matter. It is noteworthy that even before this police complaint was registered, the saints of Girnar had threatened to stage a fierce agitation in this matter. A few days ago, the saints of the Nath sect gathered in large numbers and submitted a complaint to the Junagadh DySP. At that time, the saints had alleged that the ancient foot paduka of Oghadnathji is located on the Oghad peak, which is a monument protected by the state archaeology department. Some people of the Jain

religion have been making false claims here for years. In the complaint, Acharya Sunil Sagarji of the Digambar Jain sect was also accused of incitement. The saints demanded that the writings made with paint on the sacred stones be removed and an FIR be registered against those responsible.
