लखनऊ। वर्ल्ड हाइपरटेंशन डे के अवसर पर रीजेंसी हेल्थ लखनऊ ने एक रीजनल हेल्थ एडवाइजरी जारी की है। रीजेंसी हेल्थ लखनऊ, मरीजों को शिक्षित करने वाली पहलों के जरिए निवारक स्वास्थ्य सेवा और जन जागरूकता पर अपना ध्यान लगाता बढ़ा रहा है। इन पहलों का उद्देश्य बीमारियों का जल्द पता लगाना, स्वस्थ लाइफस्टाइल अपनाना और लंबे समय तक हृदय संबंधी स्वास्थ्य को बेहतर बनाए रखना है। हार्स्पिटल के डॉक्टरों ने यह नोटिस किया कि 20 और 30 की उम्र के आखिर में हाई ब्लड प्रेशर के मरीजों की संख्या बढ़ रही है। ऐसा ज़्यादातर क्रोनिक तनाव, खराब नींद, अस्वस्थ खाने की आदतों, मोटापे, आलसपरी लाइफस्टाइल, धूम्रपान, शराब पीने और लंबे समय तक स्क्रीन का उपयोग करने



से होता है हार्स्पिटल ने नियमित ब्लड प्रेशर जांच और लाइफस्टाइल में शुरुआती बदलाव के बारे में ज़्यादा जागरूकता फैलाने की अपील की है। साथ ही चेतावनी दी है कि हाइपरटेंशन का अक्सर तब तक पता नहीं चलता जब तक कि गंभीर समस्याएं हृदय, किडनी, मस्तिष्क या खून की नसों पर असर न डालने लगे। चिकित्सा विशेषज्ञों ने ज़ोर देकर कहा कि समय पर निदान, नियमित जांच और रोजाना की स्वस्थ आदतें युवा आबादी में कार्डियोवैस्कुलर बीमारी के लंबे समय के बोझ को कम करने में महत्वपूर्ण भूमिका निभा सकती हैं।

अवैध कब्जा व अतिक्रमण की शिकायतों की भरमार

सरोजनीनगर तहसील कार्यालय में शनिवार को एडोप्टेड अपूर्ति ज्योति गौतम की अध्यक्षता में आयोजित संपूर्ण समाधान दिवस में जमीन कब्जा, शासकीय भूमि पर अतिक्रमण, अवैध प्लांटिंग और ग्राम पंचायतों में भ्रष्टाचार से जुड़ी शिकायतें सामने आईं।

संपूर्ण समाधान दिवस में पिपरगण्ड निवासी निधि सिंह ने शिकायत दर्ज कराई कि उनके पति संजीत सिंह ने वर्ष 2015 में



मुल्लाहीखेड़ा नटकुंर में 4000 वर्गफीट का प्लॉट खरीया था, जिसका दाखिल-खारिज भी उनके नाम पर हो चुका है। आरोप है कि कुछ भू-माफियाओं ने प्लॉट की बाउंड्रीवाल तोड़कर अवैध कब्जा कर लिया और वहां खेती शुरू कर दी। विरोध करने पर जान से मारने की धमकी भी दी जा

रही है। वहीं रहीमाबाद के अशोक कुमार श्रीवास्तव ने नगर निगम के सरकारी चक्रोड़ और रास्ते की भूमि पर प्रॉपर्टी डीलरों द्वारा किए गए अवैध कब्जों की शिकायत की। उन्होंने आरोप लगाया है कि वर्षों से शिकायतों के बावजूद लेखपालों द्वारा कोई कार्रवाई नहीं की जा रही है, जिससे सरकारी भूमि पर अवैध प्लांटिंग कर राजस्व को नुकसान पहुंचाया जा रहा है। उन्होंने राजस्व और नगर निगम की संयुक्त टीम से पैमाइश कराकर कब्जा हटाने की मांग की।

तीन शांतिर चोर गिरफ्तार

15 हजार का इनामी गैंगस्टर भी दबोचा

अपराध शाखा लखनऊ एवं थाना मड़ियांव की संयुक्त पुलिस टीम ने बंद मकानों का ताला तोड़कर चोरी करने वाले गिरोह का पर्दाफाश करते हुए तीन अभियुक्तों को गिरफ्तार किया है। पकड़े गए अभियुक्तों के पास से चोरी के आभूषणों के साथ दो अवैध देशी तमंचे और जिंदा कारतूस बरामद किए गए हैं। गिरफ्तार अभियुक्तों में गैंगस्टर एक्ट के मुकदमे में वांछित 15 हजार रुपये का इनामी अपराधी मोहम्मद फुरकान उर्फ बाटे भी शामिल है।

पुलिस के अनुसार, शुक्रवार को रात 11.45 बजे अपराध शाखा लखनऊ और थाना मड़ियांव की संयुक्त टीम आईआईएम चौराहे पर क्षेत्र में अपराध नियंत्रण और वांछित अभियुक्तों की तलाश में मौजूद थी। इसी दौरान मुखबिर से सूचना मिली कि बंद घरों में चोरी करने वाले कुछ

लोग चोरी का सामान लेकर आईआईएम रोड सर्विस लेन के पास लोखरिया मोड़ पर स्कूटी से भागने की फिराक में हैं। सूचना पर तत्परता दिखाते हुए पुलिस टीम ने घेराबंदी कर तीनों संदिग्धों को पकड़ लिया। गिरफ्तार अभियुक्तों की पहचान खलील पुत्र गरीबे (27) निवासी अकबर गेट चौक मूल निवासी सीतापुर फल का ठेला। मोहम्मद फुरकान उर्फ बाटे पुत्र अरगार अली (24) मूल निवासी सीतापुर वर्तमान में पंचाबी गली चौक 15 हजार रुपये का इनामी। चंया का ठेला। सोनू वाल्मिकी उर्फ गोलू पुत्र सुरेश वाल्मिकी (21) नक्खस चौक नगरनिगम कर्मी के रूप में हुई। पुलिस ने अभियुक्तों के कब्जे से पीली धातु की अंगुठी, झालों की जोड़ी, कान के टप्प व बूटें, सफेद धातु की चार जोड़ी पायल, एक जोड़ी पायजब, दो सिक्के, दो अवैध देशी तमंचे (.315 बोर) और तीन जिंदा कारतूस बरामद किए। बरामदगी के आधार पर धारा 317(2) बीएनएसएस की वृद्धि की गई है।

मुख्यमंत्री कार्यालय के आदेश पर दर्ज हुआ दहेज उत्पीड़न का मुकदमा

सरोजनीनगर की एक विवाहिता ने अपने पति और ससुराल वालों पर दहेज की मांग को लेकर उत्पीड़न, मारपीट और जान से मारने की धमकी देने का आरोप लगाया है। उसने इसकी शिकायत मुख्यमंत्री कार्यालय में की।

सरोजनीनगर के नादरगं स्थित ब्रद्रीनगर निवासी शबाना परवीन रियाज अहमद रैनी के मुताबिक उसका निकाह गत पांच दिसंबर 2018 में रायबरेली निवासी मोहम्मद रियाज के साथ हुआ था। विवाह में उसके पिता ने नकद धनराशि, मोटरसाइकिल, जेवरों और धरलू सामान दिया था। आरोप है कि विवाह के कुछ समय बाद ही पति मोहम्मद रियाज, सास मेहरून निशा, ससुर अल्ला नियाज, ननद शकीला, रेशमा, यासमीन, गुड़िया, देवर सरताज, मुमताज, मुस्ताक, और अन्य रिश्तेदार

अतिरिक्त दहेज की मांग को लेकर उसे मानसिक व शारीरिक रूप से प्रताड़ित करने लगे। गत सात फरवरी 2025 में उसे मुंबई ले जाया गया। जहां पति ने 10 लाख रुपये नगद और रिक्वेस्ट कार की मांग को लेकर कई बार मारपीट की।

महिला ने आरोप लगाया कि गत 27 मई 2025 को बीच बाजार में पति ने उसके साथ मारपीट की और रात में गर्दन पर चाकू लगाते हुए शरीर के टुकड़े-टुकड़े कर समुद्र में फेंकने की धमकी दी। इसके बाद गत तीन जून को पति ने आरी से हमला करने का प्रयास किया और अवैध कार्य करने के लिए दबाव बनाया। इसके बाद गत नौ जुलाई 2025 को महिला किसी तरह अपने मायके लखनऊ पहुंची और मुख्यमंत्री कार्यालय से शिकायत की। फिलहाल मुख्यमंत्री कार्यालय के आदेश पर सरोजनीनगर पुलिस ने मामला दर्ज कर जांच शुरू कर दी है।

योजना के तहत सरकार दे रही 52,500 रुपये का अनुदान, ऑनलाइन पोर्टल पर बुकिंग के आधार पर किसानों का ययन

सीमित नहीं, बल्कि उनको आधुनिक तकनीक, जल संरक्षण, सिंचाई सुविधाओं और अतिरिक्त आय के स्रोतों से भी जोड़ रही है। इसी क्रम में 'खेत तालाब योजना' किसानों के लिए बेहद लाभकारी साबित हो रही है। यह योजना जल संरक्षण और कृषि उत्पादन बढ़ाने की दिशा में एक महत्वपूर्ण कदम मानी जा रही है।

राष्ट्रीय कृषि विकास योजना के अंतर्गत संचालित 'खेत तालाब योजना' का मुख्य उद्देश्य वर्षा जल का संचयन कर किसानों को सिंचाई के लिए स्थायी सुविधा उपलब्ध कराना है। आज के समय में भूगर्भ जल स्तर लगातार नीचे जा रहा है, ऐसे में खेत तालाब योजना किसानों के लिए वरदान साबित हो रही है। खेतों में

बनाए जाने वाले तालाब वर्षा के पानी को संरक्षित करते हैं, जिससे सूखे के समय भी किसानों को सिंचाई के लिए पानी उपलब्ध रहता है।

इस योजना के तहत 22 मीटर . 20 मीटर .3 मीटर आकार का तालाब बनाया जाता है। इसकी कुल लागत 1,05,000 निर्धारित की गई है, जिसमें सरकार द्वारा 52,500 का अनुदान दिया जाता है। यानी किसान को आधी लागत सरकार वहन कर रही है। इससे छोटे और सीमांत किसानों को भी इस योजना का लाभ आसानी से मिल पा रहा है। यह योजना केवल सिंचाई तक सीमित नहीं है, बल्कि किसानों को अतिरिक्त आय के नए अवसर भी प्रदान कर रही है। खेत तालाब में किसान मत्स्य पालन, मोती उत्पादन, सिंघाड़ा

उत्पादन और अन्य जलीय खेती कर सकते हैं। इससे किसानों की आय के कई स्रोत विकसित हो रहे हैं। प्रदेश सरकार आधुनिक सिंचाई व्यवस्था को भी बढ़ावा दे रही है। योजना के अंतर्गत स्प्रेडरलर सेट पर 80 से 90 प्रतिशत तक अनुदान दिया जा रहा है। वहीं पम्पसेट पर 15,000 अथवा 50 प्रतिशत तक की सहायता उपलब्ध कराई जा रही है। इससे किसानों की सिंचाई लागत कम हो रही है और जल का बेहतर उपयोग सुनिश्चित हो रहा है। सरकार ने इस योजना में पूरी पारदर्शिता सुनिश्चित की है। किसानों का चयन ऑनलाइन पोर्टल पर बुकिंग के आधार पर 'प्रथम आवक प्रथम पावक' यानी पहले आओ-पहले पाओ के सिद्धांत पर किया जाएगा।
