Sub.: Clarification with respect to the Outcome of Board Meeting-Financial Results submitted to the Exchange on November 14, 2025

We would like to clarify the following points mentioned in your email dated January 12, 2026, seeking clarification on financial results submitted to the Exchange on November 14, 2025.

Please find below our responses:

1. **Query:** Machine Readable Form / Legible copy of Financial Results not submitted

Clarification: The Financial Results uploaded earlier were not in a fully legible and machine-readable format due to a technical issue at the time of file conversion and upload. We have taken note of the same and enclosed herewith the Financial Results in the clear and machine-readable format.

2. **Query:** Segment details not submitted

Clarification: The segment disclosures were not submitted in the Standalone and Consolidated XBRL as the Company has only single reportable segment, i.e., Logistics for the said quarter due to demerger of International Supply Chain segment of the Company.

3. **Query:** Financial results submitted in XBRL with discrepancies. Half yearly figures submitted

Clarification: We have noted the discrepancies highlighted in the XBRL filing, including the inadvertent selecting Reporting type as “Half-yearly” instead of the “Quarterly” in both Standalone and Consolidated Integrated (Finance) XBRL. The rectified XBRL (Standalone and Consolidated) has been submitted with the Stock Exchange on February 11, 2026. Please find enclosed herewith the acknowledgement copies.
