ALPHAGEO (INDIA) LIMITED

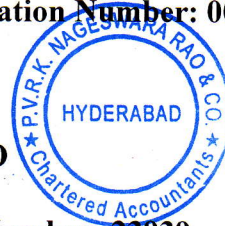
