TRINAMOOL CONGRESS WILL SECURE OVER 226 SEATS, SAYS BENGAL CM

# 'I'm fighting alone for common man'

**WEST BENGAL CHIEF** Minister Mamata Banerjee on Monday claimed that 19 states and the Centre have come together to counter her, and that she is single-handedly fighting for the common people. The BJP-led National Democratic Alliance has governments in 19 states of the country.

Addressing poll rallies at Suri in Birbhum, Galsi in Purba Bardhaman and Paschim Bardhaman's Durgapur, the TMC supremo said the BJP won't be able to win the West Bengal elections using forces from Delhi.

"The Trinamool Congress will secure over 226 seats in the West Bengal assembly elections," she asserted.

Banerjee alleged that the BJP was threatening and intimidating people to secure votes, and dared the party to act against her, contending that even if she is jailed, she would secure more votes from prison.

In an apparent reference to Union Home Minister Amit Shah, she said, "The 'Mota Bhai' (elder brother in Gujarati) is thinking that by threatening people, they will get votes." "Do you think you will get votes this way? Send me to jail, and I will get more votes even from there. Or else, shoot me dead?" she said, exuding confidence that

people would give a befitting reply through the ballot box.

Alleging large-scale interference in the electoral process, she claimed that voters' names were being deleted from electoral rolls. Banerjee also dared the BJP to fight the elections with the existing voters' list.

"If you have the guts, contest the polls with 2024 voters' list without deleting names. Otherwise, the PM elected based on that list should resign," she said.

"All those who are close to the BJP have been brought here and appointed to important posts. I have information that the chief secretary and the DGP are visiting districts today and

asking the administration to arrest booth agents and key Trinamool workers in false cases," the CM claimed.

Banerjee also accused the BJP of planning to misuse the election machinery. "On polling day, BJP workers will pose as EC officials and sit in monitoring cells," she alleged. She alleged that PM Narendra Modi's 'Mann Ki Baat' programme is being telecast to influence young minds.

"They (BJP) are distributing money... They have transferred

everyone (bureaucrats and policemen) to other states so that nobody can catch them. Money, drugs, arms and voters are being smuggled into West Bengal. Voters are being brought in trains and buses from Bihar to cast their votes.

"A total of 19 states and the central government have come together against me... I am enough for them. I will continue my fight for the common people because I do not think I am alone. I have the blessings of the public," she said.

The TMC chief took a swipe at Modi, asking whether he wanted to become the chief minister of West Bengal, in response to his remark that he was the candidate in all the seats. The PM, while addressing a rally in Siliguri on Sunday, said he was the "BJP's candidate across all constituencies" in West Bengal.

"If Modiji says he is the candidate in 294 seats, then he should resign as PM and say he wants to be the CM of West Bengal," Banerjee said.

"You are an outsider here. Handle Delhi first, then think about West Bengal," she said. On employment, Banerjee alleged that "when we try to fill vacancies, cases are filed in courts to stall recruitment. Now they are talking about jobs. Do not try to mislead the people of West Bengal."

Referring to comments made by Uttar Pradesh Chief Minister Yogi Adityanath, who had on Sunday said that bulldozers would roll in West Bengal, Banerjee hit back, asserting that her government does not believe in such an approach but in one based on love.

Banerjee also cautioned people against accepting money from the BJP, alleging that it could lead to legal troubles later. "They will deposit black money into your accounts and later cases will be filed by the ED and the CBI," she alleged.

## SC: Voters caught between constitutional entities

Top court flags deletion of names in Bengal SIR

**CALLING THE RIGHT** to vote the "biggest expression of nationality and patriotism... in a democratic government," the Supreme Court Monday raised questions on the exclusion of voters in the Special Intensive Revision (SIR) in West Bengal and flagged concerns over deletions in the context of winning margins.

Hearing a petition on the adjudication of appeals against the exclusion of names in the SIR of electoral rolls in the state, the court indicated that it might consider allowing an additional supplementary list.

"If 10% of the electorate does not vote and the winning margin is more than 10%... what will happen? Suppose margin is 2% and 15% of electorate who are mapped could not vote, then maybe we are not expressing any opinion, but we would definitely have to



during the Supreme Court-monitored adjudication process in 15% of 293 constituencies than the winning margin in those seats in the 2021 polls.

During Monday's hearing, referring to the apex court deputing judicial officers to decide the names flagged for logical discrepancies and setting up Appellate Tribunals, Justice Bagchi said it was "to ensure that all the rights including the fundamental duty of the Election Commission... as a constitutional body are balanced and a fair and impartial exercise is targeted."

The judge said that no one should think that "the concern of a vigilant voter whose name correctly or incorrectly is not in the list is not in our minds". He added, however, that given the volume of cases which each judicial officer had to adjudicate, "there is always a chance of margin of error... And in these situations, (to) test it again from the principles of reasonableness, due process, we need to have a robust appellate process..."

### Bengal ready to reply to bombs with votes: Shah

**UNION HOME MINISTER** Amit Shah on Monday stated that the people of West Bengal will reply to bombs with votes on EVMs during the assembly polls and are determined to throw infiltrators out, while asserting that the BJP will definitely form the government in the state. Acknowledging that the SIR of voters' list is a "major issue" in the state polls, Shah, during his end-of-the-day roadshow in Durgapur, told PTI videos that the responsibility for political violence in Bengal lies only with Chief Minister Mamata Banerjee and her nephew, Abhishek Banerjee, who is the TMC's general secretary. —PTI

### TMC ignoring Muslims in Murshidabad: Owaisi

**AIMIM CHIEF ASADUDDIN** Owaisi on Monday accused the TMC government in West Bengal of according stepmotherly treatment to Muslims in Murshidabad district. Owaisi also claimed that the Mamata Banerjee dispensation was concentrating all development work in state capital Kolkata and places near it. Addressing a poll rally in Murshidabad, the AIMIM leader asserted that industries and other enterprises have emerged in places like Haldia and Kharagpur, and wondered why a special economic zone (SEZ) had not been established in Murshidabad, which would have provided employment opportunities for the locals. —PTI

### Stalin slams Centre over 'secretive' delimitation

**TAMIL NADU CHIEF** Minister MK Stalin on Monday accused the BJP-led Centre of "secretively" working towards delimitation and amendment over women's reservation and alleged conspiracy. While there were several issues affecting the people, such as LPG shortage, amid elections in states, in order to divert people, the BJP-led Centre is desperate to implement delimitation, he said. "As they secretively work on this matter, it is clear that there is a conspiracy to it," the CM alleged at a poll rally in Ranipet. Referring to the proposal, Stalin said the move is all set to be a very important constitutional amendment. —PTI
