Ref: Our letter BWR/BLR//SRC/Nitika Srivastava/5332/2025-26 dated 20 Nov 2025 reaffirmed the rating of BWR C and letter dated 20 Nov 2025 under Issuer not cooperating rating.

We refer to your mail dated 30-May-2025 requesting for review of the rating with simultaneous withdrawal for the Bank Loan Facility of Rs.24.50 Crs. of Anlon Healthcare Ltd.(Erstwhile Anlon Healthcare Pvt. Ltd.), and withdrawal of term loans of Rs.10.36 due to the closure of the said facility.

Brickwork Ratings has noted that the company has obtained the No Objection Certificate and Closure letter for closed term loans from Punjab National bank, MCC Rajkot.

Based on your request, Brickwork Ratings has removed the ratings from ISSUER NOT COOPERATING and Upgraded the ratings and simultaneously withdrawn the rating of BWR BB+/Stable to the Bank Loan Facility aggregating Rs.24.50 Crs. (Rupees Twenty Four Crore Fifty Lakhs Only) and withdrawal of term loans of Rs.10.36 (Rupees ten crore and thirty six lakhs only) due to the closure of the said facility; with immediate effect.
