Subject: Intimation Regarding Arrangements for Disposal of Odd Lots – Rights Issue of Anondita Medicare Limited

Dear Sir/Madam,

With reference to the above, we hereby confirm and intimate the following in connection with the arrangements for disposal of odd lots pursuant to the Rights Issue of Anondita Medicare Limited ("Company").

Our Company's Equity Shares are traded in dematerialised form only. The Issue has accordingly been structured such that the total number of Rights Equity Shares to be issued (9,58,000) is a whole multiple of the market lot prescribed for trading of the Company's Equity Shares on the SME Platform of NSE. Accordingly, no arrangements for disposal of odd lots are required at the aggregate Issue level.

Eligible Equity Shareholders are, however, advised that Rights Entitlements will be traded and allotted in lots of 10 (Ten) and multiples thereof, whereas the Company's Equity Shares are traded on the SME Platform of NSE only in the market lot of 200 (Two Hundred) Equity Shares. As Rights Equity Shares will be allotted to Eligible Equity Shareholders in accordance with their respective Rights Entitlement holdings, the resultant post-Allotment shareholding of certain Eligible Equity Shareholders may not be in whole multiples of 200 Equity Shares. Such Eligible Equity Shareholders will accordingly be unable to sell the relevant Equity Shares comprised in such odd lot through the online trading mechanism of the Stock Exchange, and may, at their discretion, dispose of the same through off-market transfer, or consolidate their holding to a whole market lot before selling through the online mechanism.
