**Subject:** Intimation Regarding Partial Nullification of Corrigendum to the Letter of Offer dated August 27, 2026, filed on September 07, 2026, in connection with the Rights Issue of Anondita Medicare Limited

Dear Sir/Madam,

With reference to the Corrigendum to the Letter of Offer dated August 27, 2026, filed by Anondita Medicare Limited (“Company”) with the Exchange on September 07, 2026 (“Corrigendum”), the Company hereby intimates the Exchange that Announcement No. 1 of the said Corrigendum, titled ‘Revision of Issue Size and General Corporate Purposes Allocation’, stands nullified and withdrawn with immediate effect. Announcement No. 2 of the said Corrigendum, titled ‘Revision to Arrangements for Disposal of Odd Lots’, remains in full force and effect, subject to the consequential correction set out in paragraph 3 below.

**1. Nullification of Announcement No. 1**

Announcement No. 1 of the Corrigendum had revised the total number of Rights Equity Shares to be issued, the Issue Size, and the allocation towards General Corporate Purposes, as follows:

Pursuant to this nullification of Announcement No 1, the figures as originally disclosed in the Letter of Offer dated August 27, 2026 — being **9,58,000 Total Rights Equity Shares, an Issue Size of ₹9,101.00 Lakhs, and an allocation of ₹979.98 Lakhs towards General Corporate Purposes** —shall continue to apply, and shall not stand revised.

## 2. Announcement No. 2 Remains in Effect

Announcement No. 2 of the Corrigendum, revising the section titled 'Arrangements for Disposal of Odd Lots' (Page 84 of the Letter of Offer) to reflect that Rights Entitlements will be traded and allotted in lots of 10 (Ten) and multiples thereof, resulting in certain Eligible Equity Shareholders holding post-Allotment shareholding not in whole multiples of the 200-Equity-Share market lot, continues to remain in full force and effect and is not affected by the nullification set out in paragraph 1 above.

## 3. Consequential Correction to Announcement No. 2

As Announcement No. 2, in its second paragraph, had referred to the Company issuing "the entire theoretical entitlement of 9,58,166 Rights Equity Shares... aggregating to an Issue Size of ₹9,102.58 Lakhs", and as the aforesaid figures stand nullified pursuant to paragraph 1 above, the said second paragraph of Announcement No. 2 shall be read as follows, with all other paragraphs of Announcement No. 2 remaining unchanged:

***"At the Rights Entitlement ratio of 97:1,831 applied to our Company's existing 1,80,86,618 Equity Shares, the theoretical entitlement works out to 9,58,166 Equity Shares. Our Company has structured the Issue to comprise 9,58,000 Rights Equity Shares, aggregating to an Issue Size of ₹9,101.00 Lakhs at the Issue Price of ₹950 per Equity Share."***
