Sub: Withdrawal of Nullification Letter and confirmation of allotment of 9,58,166 Rights Equity Shares as per the Corrigendum to the Letter of Offer dated September 07, 2026 — Rights Issue of Anondita Medicare Limited (“the Company”)

With reference to the captioned Rights Issue, we wish to inform you as follows.

The Company had, vide its Nullification Letter dated September 08, 2026, withdrawn the Corrigendum to the Letter of Offer dated September 07, 2026, and reverted the Issue Size to 9,58,000 Rights Equity Shares as per the original Letter of Offer dated August 27, 2026.

The Company hereby withdraws the aforesaid Nullification Letter dated September 08, 2026 in its entirety. Accordingly, the Corrigendum to the Letter of Offer dated September 07, 2026, revising the Issue Size to 9,58,166 (Nine Lakhs Fifty-Eight Thousand One Hundred Sixty-Six) Rights Equity Shares, aggregating up to ₹9,102.58 Lakhs, stands restored and continues to be the operative basis for the Issue.

The Company confirms that the allotment of 9,58,166 Rights Equity Shares shall be made in terms of the Letter of Offer dated August 27, 2026, read with the said Corrigendum dated September 07, 2026. All documents, certificates, and disclosures to be submitted to NSE in connection with the In-Principle Approval (Post Allotment) for the Issue shall reflect this revised position of 9,58,166 shares.

We request you to kindly take the above on record and treat this letter as superseding our earlier Nullification Letter dated September 08, 2026 for all purposes.
