# Imran Khan and wife sentenced to 14 years in jail in Toshakhana corruption case

ISLAMABAD, JAN 31 /--/ Former Pakistan prime minister Imran Khan and his wife Bushra Bibi were sentenced on Wednesday to 14 years of rigorous imprisonment in a corruption case, dealing another blow to the jailed leader, a day after he was handed a 10-year jail term for leaking sensitive state secrets. The verdict by an accountability court, which comes eight days before the February 8 general elections, has added to the legal woes of the 71-year-old cricketer-turned-politician who is already serving a three-year

jail term after being convicted of corruption in another case. Khan's party, the Pakistan Tehreek-e-Insaf (PTI) faced numerous troubles before the election starting with the denial of its election symbol, the cricket bat, to the rejection of nomination papers of Khan, former foreign minister Shah Mehmood Qureshi and several other party leaders. Accountability Court Judge Muhammad Bashir conducted the hearing at Rawalpindi's Adiala Jail, where the former premier is incarcerated. In the Toshakhana corruption case, he was accused of retaining

expensive state gifts they received during his tenure as Pakistan's premier. Khan and his wife were also barred from holding any public office for 10 years and slapped with a fine of Rs 787 million each. Bushra Bibi, 49, did not appear before the court on Wednesday. At the outset of the hearing, Judge Bashir asked Khan if he recorded his statement. To this, the former premier said that he would submit his statement once his lawyers came. "I have been deceived as I was only called to mark my attendance for the hearing," Khan said. Following the verdict, Bushra

Bibi arrived at the Adiala jail and surrendered before the authorities. "Why are you in a hurry? Even yesterday, the conviction was announced in haste," the ex-prime minister said, referring to the verdict in the cipher case a day earlier. "My lawyers are not here yet. I will submit the statement after showing it to them when they come," Imran said, adding that he had appeared before the court only to mark his attendance. He then exited the courtroom, after which the court sentenced the ex-premier and his wife in absentia.

The judge in the case had also convicted another former premier Nawaz Sharif in July 2018 ahead of elections. Reacting to the verdict, PTI's current chief Gohar Khan said the judgment only served to lower the respect of the judiciary. "The accused were not given time and the process was hurried to conclude the trial," he said, adding that the defence was not given the right of cross-examination. "Complete destruction of every existing law in Pakistan in 2 days. Imran Khan and Bushra Bibi have faced yet another

kangaroo trial in which no right to defence was given to both. Like cipher, this case has no basis to stand in any Higher court. It's shameful how a complete disregard and mockery of law is in place," PTI said in a post on X. Separately, the PTI in a statement said that these decisions, reached in haste, cannot impact the fervour, any PTI supporter talks of, around election time. It alleged that the star witness was changed and a witness who's a part-time worker did an evaluation of gifts by showing photos, while

no cross-questioning was allowed, no final argument concluded and decision popped up like a predetermined process in play. "This ridiculous decision will also be challenged," the party announced. Last month, the National Accountability Bureau (NAB) filed a fresh case against the two in an accountability court for retaining a jewellery set which included necklaces, earrings, bracelets and a ring worth Rs 1.57 billion received from the Saudi crown prince against undervalued assessment. ## PM Modi's community event, temple opening in mid-Feb in Abu Dhabi sends Indian officials on overdrive

DUBAI, JAN 31 /--/ Ahead of Prime Minister Narendra Modi's February 13-14 visit to the UAE for an Indian community event and a dedication ceremony for a Hindu temple, officials from the Indian Embassy and the Consulate have gone on an overdrive as preparations gather momentum. PM Modi is scheduled to address the Indian community summit, Ahlan Modi (Hello Modi), at Abu Dhabi's Sheikh Zayed stadium on February 13 and is scheduled to attend on February 14 a dedication ceremony at the BAPS Hindu temple getting the finishing touches at the UAE capital. Regarding the

Ahlan Modi event, India's ambassador to the UAE, Sunjay Sudhir, said they are expecting tens of thousands of people to throng the site of the reception. Prime Minister Modi along with then US President Donald Trump addressed a massive community event called 'Howdy, Modi!' in Houston, Texas on September 22, 2019. A registration portal has been set up to smoothen the process and transport is being arranged from all emirates for participants to reach the venue. The event is being organized collaboratively by 150 Indian community organisations in the UAE. A cultural programme

involving 400 local talents has been put together to add colour to the show. During the last 3 years, over 2,000 artisans from Rajasthan and Gujarat have carved the 402 white marble pillars for the temple. Earlier, addressing a gathering of diplomats invited to celebrate the Republic Day, Ambassador Sudhir said over 3.5 million Indians call UAE their home, thanks to the affection shown by the country's leaders. "One of the most significant developments in bilateral relations in recent years is the construction of the BAPS Hindu temple in Abu Dhabi," Ambassador

Sudhir said. "The temple, which is expected to be inaugurated by Prime Minister Modi on the 14th of February, will be a spiritual oasis. Standing on top of a hillock on the outskirts of Abu Dhabi, the temple will be a testimony to the enduring tradition of peace and tolerance aspired by our forefathers Mahatma Gandhi and Sheikh Zayed," he said. As announced by the ambassador then, a preview of the temple for ambassadors and spouses from 42 countries to catch a glimpse of the architectural marvel before its inauguration was organised on Monday. (AP)

## Indian-origin couple jailed for 33 years in UK for exporting over half tonne cocaine to Australia

LONDON, JAN 31 /--/ An Indian-origin couple in the UK, whose extradition was sought by India on charges of the murder of their adopted son in Gujarat, has been sentenced to 33 years in prison each after being convicted of exporting more than half a tonne of cocaine to Australia. Arti Dhir, 59, and Kavaljitsinh Rajjada, 35, from Hanwell in Ealing were identified by the National Crime Agency (NCA) investigators after Australian Border Force intercepted the cocaine worth 57 million pounds upon its arrival in Sydney in May 2021, the agency said in a statement on Monday. The couple was behind a front company that had sent the drugs by plane under a cover load of metal toolboxes, according to investigation. Judge's commendations were awarded to three NCA officers who worked on the case. Dhir and Rajjada denied exporting cocaine to Australia and money laundering. They were convicted of 12 counts of

exportation and 18 counts of money laundering by a jury following a trial at Southwark Crown Court on Monday. They were sentenced at the same court on Tuesday. The drugs exported by the two had been shipped via a commercial flight from the UK and consisted of six metal toolboxes which, when opened, were found to contain 514 kilograms of cocaine. The drugs would have been worth up to 57 million pounds when sold in Australia, where prices are significantly higher than in the UK. In the UK, a kilo of cocaine at wholesale is priced around 26,000 pound but in Australia the same amount sells for 110,000 pounds. Officers traced the consignment back to Dhir and Rajjada, who had set up a front company called Viefly Freight Services with the sole purpose of smuggling drugs. Both defendants had been directors of the company at different points since its incorporation in June 2015. Rajjada's fingerprints were found on

the plastic wrappings of the metal toolboxes containing the seized drugs, while receipts for the order of the toolboxes, worth 2855 pounds were discovered at the couple's home. The NCA's case was that there had been 37 consignments sent to Australia since June 2019, of which 22 were dummy runs and 15 contained cocaine. Dhir had been employed by a flight services company at Heathrow from March 2003 until October 2016. Rajjada worked at the same company from March 2014 to December 2016. NCA investigators believe that their knowledge of the airport freight procedures was used to cover their criminal activities. Dhir and Rajjada were arrested at their home in Hanwell on June 21, 2021, and officers seized 5000 pounds worth of gold-plated silver bars, 13,000 pounds inside the home and found 60,000 pounds in cash in a safety deposit box. ## 15 killed in terrorist attacks in Pak's Balochistan

KARACHI, JAN 31 /--/ Heavily armed terrorists launched three coordinated attacks, including one on a high-security prison, in Pakistan's restive Balochistan province, leaving four law enforcement personnel and two civilians dead and triggering a gunbattle in which nine of the militants were also killed. The attacks took place on Monday in Mach town, some 70 kilometres from the provincial capital Quetta, officials said. A press release issued from the Inter Services Public Relations (ISPR) on Tuesday night said that on the night between January 29 and 30, "multiple terrorists, including suicide bombers, attacked Mach and Kolpur Complexes in Balochistan, which was effectively responded by law enforcement agencies (LEAs)." Nine terrorists were killed and three injured and captured by security forces when they tried to apparently penetrate the high-security central Mach Jail where some dangerous militants are incarcerated. The ISPR also confirmed the death of four security personnel and two civilians since Monday night. It said security forces in the vicinity were immediately mobilised and were carrying out an "ensuing operation". "Nine terrorists, including three suicide bombers, were 'sent to hell till now' while three were injured," the statement said. (PTI)

## UN's top court is ruling in case in which Ukraine accuses Russia of backing terrorists

THE HAGUE, JAN 31 /--/ The United Nations' top court is ruling on Wednesday in a case in which Ukraine accuses Russia of bankrolling rebels in 2014 and

discriminating against Crimea's multiethnic community since its annexation of the region. It is the first of two decisions by the International Court of Justice linked to the decadelong conflict between Russia and Ukraine that exploded into a full-blown war nearly two years ago. Wednesday's legally binding final ruling comes in a case filed in 2017, accusing Moscow of breaching conventions against discrimination and the financing of terrorism. Kyiv wants the court to order Moscow to pay

reparations for attacks and crimes in eastern Ukraine, including the downing of Malaysia Airlines Flight 17, which was shot down by Russia-backed rebels on July 17, 2014, killing all 298 passengers and crew. At hearings last year, a lawyer for Ukraine, David Zions, said that pro-Russia forces in eastern Ukraine "attacked civilians as part of a campaign of intimidation and terror. Russian money and weapons fuelled this campaign." Among the attacks was the downing of MH17. A Dutch domestic court convicted two Russians and a pro-Moscow Ukrainian in November 2022 for their roles in attack and sentenced them in their absence to life imprisonment. Also, the Netherlands and Ukraine are suing Moscow at the European Court of Human Rights over MH17. Russia denies involvement. (AP)
