NOT A TERRORIST CASE, KEJRIWAL TELLS HIGH COURT

THE DELHI HIGH Court on Friday sought the CBI's response to Chief Minister Arvind Kejriwal's bail plea filed over the agency's corruption case linked to the now-scrapped excise policy. While arguing for his bail plea, the AAP national convenor emphasised that this was not a case of a proclaimed offender or a terrorist. A single-judge bench of Justice Neena Bansal Krishna issued a notice to the central agency and asked it to file its response.

NCW INITIATES LEGAL ACTION AGAINST MOITRA

THE NATIONAL COMMISSION for Women (NCW) on Friday said it has initiated legal action against Lok Sabha MP Mahua Moitra for her remarks against its chairperson Rekha Sharma. This came a day after the TMC, commenting on a video posted on X showing the NCW chairperson's arrival at the site of a stampede that recently took place in Uttar Pradesh's Hathras, wrote, "She is too busy holding up her boss's pajamas".

BENGAL SPEAKER ADMINISTERS OATH TO 2 TMC MLAS

WEST BENGAL ASSEMBLY Speaker Biman Banerjee administered the oath to two newly elected TMC MLAs on Friday, defying the Governor's directive to appoint Deputy Speaker Ashish Banerjee for the task, sparking accusations of constitutional impropriety from Raj Bhavan. The incident led Governor C V Ananda Bose to send a report to President Droupadi Murmu, alleging that the Speaker's actions violated constitutional norms.

BIHAR SUSPENDS 14 ENGINEERS OVER BRIDGE COLLAPSES

THE BIHAR GOVERNMENT on Friday suspended 14 engineers in connection with a series of recent incidents of bridge collapse in the state, a senior official said. The decision was taken after a probe panel submitted its report to the Water Resources Department (WRD). A total of 10 bridges collapsed in Siwan, Saran, Madhubani, Araria, East Champaran and Kishanganj districts in the past 17 days, officials said.

Prez awards six CRPF personnel for gallantry

SIX CRPF PERSONNEL, including four posthumous, were decorated with military gallantry medals by President Droupadi Murmu during a defence investiture ceremony held here on Friday.

The family members of Inspector Dilip Kumar Das, Head Constable Raj Kumar Yadav and Constables Bablu Rabha and Shambhu Roy received Kirti Chakras (posthumous) from Murmu. They were recognised for displaying gallant action during an anti-Naxal operation in Chhattisgarh's Bijapur district on April 3, 2021.

Twenty-two security personnel, including eight from the Central Reserve Police Force (CRPF), were killed in action during this gungbatle, followed by a Naxal ambush that went on for six hours.

The president awarded Kirti Chakras to the next of kin of these personnel who displayed extraordinary bravery and inflicted heavy casualties on the Maoists, a force spokesperson said quoting their gallantry citations.

Murmu also awarded Shaurya Chakras to two other personnel of the country's largest paramilitary force for showing gallantry during an anti-Naxal operation and a counter-terrorist action in Jammu and Kashmir.

Assistant Commandant Bibhor Kumar Singh was awarded the military medal for displaying "exceptional" bravery and continuing to lead his troops despite losing his left leg to an improvised explosive device (IED) blast triggered by the Naxals in the Chakrabandha forest of the Aurangabad district in Bihar on February 25, 2022.

Centre opposes NEET retest, tells SC honest candidates will be hit

Absence of large-scale breach of confidentiality: Education Ministry

EXPRESSING ITS UNWILLINGNESS to conduct the NEET-UG examination again, the Centre has told the Supreme Court that "scrapping the exam in entirety would seriously jeopardise the lakhs of honest candidates who attempted the question paper in 2024".

In an affidavit filed on Thursday in the top court — it is set to take up on July 8 a clutch of petitions alleging exam paper leak and irregularities in the conduct of the NEET-UG on May 5 and demands for a retest — the education ministry makes no mention of a paper leak, only acknowledging that "some alleged instances of irregularities/cheating/impersonation/malpractices during the conduct of NEET(UG) 2024 Examination have been reported".

It goes on to state that "in the absence of any proof of any large-scale breach of confidentiality in a pan-India examination, it would not be rational to scrap the entire examination".

"It is submitted that in any examination there are competing rights that have been created whereby the interests of a large number of students who have taken the examination without adopting any alleged unfair means must not also be jeopardised," it said.

"Scrapping the exam in entirety would seriously jeopardise the lakhs of honest candidates who attempted the question paper in 2024," the ministry said in its affidavit.

This is the first time that the Centre is putting on record its stand on holding a retest of NEET-UG for all 2.4 million candidates.

Earlier, in a press conference last month, education minister Dharmendra Pradhan had taken moral responsibility for the inconvenience caused to candidates but did not make the government stand clear on holding a retest.

Change in NEET-PG: Two shifts on Aug 11, only at TCS centres

THE NATIONAL BOARD of Examinations in Medical Sciences announced Friday that NEET-PG 2024, the qualifying examination for postgraduate medical courses which was postponed last month, will be conducted on August 11.

The test, the NBEMS said, will be conducted in two shifts and the scores of the candidates will be normalised.

Announcing the date of the examination, the NBEMS said it will be conducted only at TCS centres and not outsourced centres.

The ministry, in its affidavit, stated that it had asked the CBI to "conduct a comprehensive investigation into the entire gamut of alleged irregularities, including conspiracy, cheating, impersonation, breach of trust, destruction of evidence by the candidates/institutes/middlemen, including attempted irregularities" and that the CBI had registered case in this regard.

It said it had also constituted a high-level committee of experts

This is the first time that the test will be conducted in two batches. Sources said this will ensure that the examination is conducted in fewer centres.

"There has been an increase in the number of students appearing for the paper over the years. To ensure that the examination is completely secure and robust, this time it will be conducted only in TCS centres and not outsourced ones," a senior official said.

The NEET-PG exam is conducted by TCS in collaboration with the NBEMS every year. **ENS**

Modi, Putin to review whole range of ties, says foreign secy

PRIME MINISTER NARENDRA Modi and Russian President Vladimir Putin will review the whole range of bilateral ties, including in areas like defence, investment, energy cooperation, education, culture and people-to-people exchanges, at the upcoming annual India-Russia summit, foreign secretary Vinay Kwatra said on Friday.

Modi will pay a two-day official visit to Russia from July 8 to 9 at the invitation of Putin for the 22nd India-Russia summit that will review the entire range of multifaceted ties between the two countries. Putin will host a private dinner for Modi on the day of arrival.

The two leaders will also share perspectives on "regional and global developments of mutual interest," Kwatra said at a media briefing here ahead of Modi's visit to Russia for the summit.

Sharing details about the Russia itinerary, Kwatra said, as of now, the prime minister is scheduled to arrive in Moscow late afternoon of July 8. The next day, Modi's interactions would include an interface with the Indian community in Russia.

The prime minister will also lay wreath at the Tomb of the Unknown Soldier in Kremlin. And, thereafter he will visit Rosatom pavilion at the exhibition venue in Moscow.

"These engagements will be followed by restricted-level talks between the two leaders, which will then be followed by delegation-level talks led by the honourable prime minister and the Russian President," he added.

The annual India-Russia summit is taking place after three years, and "we attach great importance to it," Kwatra said.

"The issue of early discharge of Indian nationals who have been misled into the service of the Russian Army is expected to figure in the discussions," he added.

After concluding his trip to Russia, Modi will travel to Austria, which will be the first visit by an Indian prime minister to that country in 41 years, the ministry of external affairs said on Thursday.

This will be Modi's first trip to Russia in nearly five years. His last visit to that country was in 2019 when he attended an economic conclave in the Far East city of Vladivostok.

This will also be his first visit to Russia since the conflict in Ukraine.

So far, 21 annual summits have taken place alternately in India and Russia. The last summit was held on December 6, 2021 in New Delhi. Putin had visited India to attend the summit.

"The 22nd annual summit between India and Russia would provide an opportunity to the two leaders to review the whole range of bilateral issues, including defence, trade linkages, investment ties, energy cooperation, S&T, education, culture and people-to-people exchanges," the foreign secretary said.

Both sides are currently working on a "series of outcome documents" which would be the result of this summit, he added.

Kwatra said since the last summit, the two leaders met in 2022 in Samarkand on the margins of the SCO Summit in Uzbekistan.

"They have also stayed in touch with each other through several telephonic conversations through these years," he said.

The leaders will also assess the status of bilateral engagements in groupings such as BRICS, Shanghai Cooperation Organisation (SCO), G20, East Asia Summit, and the UN, the foreign secretary said.

Other areas of interest will include cooperation across the range of areas.

The last summit saw both sides sealing 28 MoUs and agreements besides coming out with a joint statement titled "India-Russia Partnership

for Peace, Progress and Prosperity".

Modi will depart Moscow for Vienna in the afternoon of July 9, Kwatra said.

"India and Russia have a special and privileged partnership since 2020 which has remained resilient in the wake of multiple geopolitical challenges that the world has been facing," he said.

The annual summit between the two leaders is the highest mechanism to steer and drive the cooperation between the two countries.

"Our bilateral exchanges with Russia have also remained fairly frequent over the last year. The two foreign ministers have met several times last year, most recently they met day before yesterday on the sidelines of the SCO. The EAM (external affairs minister) had also visited Moscow and St Petersburg in December last year. And, the two National Security Advisors have also met a few times last year," Kwatra said.

India-Russia bilateral trade has seen a "sharp increase" in 2023-24. It has since touched close to \$65 billion primarily due to strong energy cooperation between the two countries, the foreign secretary said.

On the second leg of his visit, Kwatra said Modi will visit Austria on July 9-10 at the invitation of the Chancellor of Austria.

This will be the first visit to Austria by an Indian prime minister, he said, adding the last prime ministerial visit from India to Austria took place more than 40 years ago.

Volkswagen, M&M in talks for JV

The German company has pumped in more than \$2 billion in India since its debut in 2007, but has failed to sway the audience due to premium pricing and poor brand recall. With Skoda, it has a market share of less than 2% of the Indian PV market.

VW, the group's flagship brand, is known for its popular models such as the Golf, Polo, and Passat. VW's India current range includes Virtus, Taigun and Tiguan.

In terms of tie-ups, the VW Group has been actively collaborating with various partners across markets. In China, the group has joint ventures with local manufacturers such as FAW and SAIC, enabling them to manufacture and sell vehicles tailored to the Chinese market. In the United States, VW has a strong presence with its manufacturing facility in Chattanooga, Tennessee.

While M&M has well-defined plans for the electric vehicle segment, having frozen the product line-up for the next three-four years addressing different segments, VW



is yet to firm up its EV plans. The German giant is keen to find a solution for the EV puzzle.

Talking to a group of visiting Indian journalists in Prague, Klaus Zellmer, global CEO, Skoda Auto had spoken about the need for the India unit to join hands with a local partner for gaining engineering, sales and procurement competence.

He had added that European cars are often "over-engineered", which may not be required in India. This made its cars come at a pre-

mium than its competition.

Skoda Auto is leading the charge in India under the company Skoda Auto Volkswagen India (SAVIPL) for a makeover. Over the last couple of years, the company has launched four new models, including two sports utility vehicles sold under the two brands. Each of those products is now being sold at a heavy discount due to poor demand.

Skoda is betting on the upcoming sub-4 metre compact SUV, which will take on the likes of the Maruti Brezza, Hyundai Venue and the Kia Sonet. VW, however, is unlikely to have a car on the same platform.

Rahul meets Hathras victims

LEADER OF OPPOSITION in Lok Sabha, Rahul Gandhi on Friday met families of Hathras stampede victims, holding the administration responsible for the incident and appealing to Uttar Pradesh chief minister Yogi Adityanath to ensure swift compensation.

The Congress MP said: "It is very tragic. Many families have lost a lot. Many have died. I don't want to say anything through a political prism. But, there are shortcomings of the administration and there have been some mistakes. It should be found out. The most important thing is that the right compensation should

be given. They are poor families, and it is a very tough time for them. They should get maximum compensation. I request the Uttar Pradesh

chief minister that compensation should be given wholeheartedly."

The government has announced compensation of ₹2 lakh for those killed and ₹50,000 for the injured.

Gandhi was accompanied by state Congress chief Ajay Rai, party General Secretary and UP in-charge Avinash Pande, state General Secretary (Organisation) Anil Yadav and other senior Congress leaders.

On the issue of compensation, Gandhi said: "They should get compensation right now. They need it right now. If it is given six months or a year later, then that won't help... I spoke to the families. About their family, children, mothers — what they did, how they were. They have said the administration was at fault.
