**NOTICE OF 22<sup>nd</sup> (TWENTY SECOND) ANNUAL GENERAL MEETING AND E-VOTING INFORMATION**

Notice is hereby given that the 22<sup>nd</sup> (Twenty Second) Annual General Meeting ("AGM") of the Members of Anupam Rasayan India Limited (the "Company") will be held on **Friday, September 26, 2025 at 05:00 p.m. IST** through Video Conferencing ("VC") facility / Other Audio-Visual Means ("OAVM") to transact the businesses, as set out in the Notice of the AGM in compliance with all the applicable provisions of the Companies Act, 2013 (the "Act") and the Rules framed thereunder and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations") read with all applicable circulars issued from time to time, by Ministry of Corporate Affairs ("MCA") and Securities and Exchange Board of India ("SEBI") (collectively referred as "Circulars"). The Company has sent the Notice of the AGM along with the Integrated Annual Report for the financial year 2024-25 on **Wednesday, September 03, 2025**, through electronic mode only to the Members whose e-mail addresses are registered with the Company/Depositories in accordance with the Circulars and the same are also available on the Company's website at [www.anupamrasayan.com](http://www.anupamrasayan.com) and on the websites of Stock Exchanges i.e., BSE Limited at [www.bseindia.com](http://www.bseindia.com) and National Stock Exchange of India Limited at [www.nseindia.com](http://www.nseindia.com) and the Notice of the AGM is available on the website of National Securities Depository Limited ("NSDL") at <http://www.evoting.nsdl.com>.

Further, in compliance with SEBI Listing Regulations, a letter has been sent to Members of the Company who have not registered their email address with the Company, RTA or DP, to *inter-alia* inform them that the Annual Report for the financial year 2024-25 including the notice of AGM can be accessed from the Company's website at [www.anupamrasayan.com](http://www.anupamrasayan.com) and exact path to access the same is <https://www.anupamrasayan.com/investors/results-reports>.

In compliance with Section 108 of the Act read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of the SEBI Listing Regulations and Secretarial Standards on General Meetings ("SS-2") issued by the Institute of Company Secretaries of India and the Circulars, the Members are provided with the facility to cast their votes on all the resolutions set forth in the Notice of the AGM using electronic voting system (e-voting) provided by the National Securities Depository Limited ("NSDL"). The voting rights of the Members shall be in proportion to their shares of the paid-up equity share capital of the Company as on the cut-off date i.e., **Friday, September 19, 2025**.

The Company is providing remote e-voting facility ("remote e-voting") to all its Members to cast their votes on all the resolutions which are set out in the Notice of the AGM. Members have the option to cast their vote on any of the resolutions using remote e-voting facility or e-voting facility during the AGM. Detailed procedure for remote e-voting/e-voting during the AGM is provided in the Notice of the AGM. The remote e-voting period shall commence on **Tuesday, September 23, 2025 (from 9:00 a.m. IST) and ends on Thursday, September 25, 2025 (till 5:00 p.m. IST)**. The remote e-voting module shall be disabled by NSDL thereafter. The Members who have cast their votes by remote e-voting on the resolutions prior to the AGM may attend/participate in the AGM through VC/OAVM but shall not be entitled to cast their votes on such resolutions again.

Any person who acquires the shares of the Company and becomes a Member after the Notice is sent and holding shares as of the cut-off date, may follow steps mentioned in Notice of the AGM and obtain the login ID and password by sending a request at [evoting@nsdl.co.in](mailto:evoting@nsdl.co.in). However, if a Member is already registered with NSDL for remote e-voting, then such Member can use their existing user ID and password for casting the vote. Once the vote on a resolution is cast by the Member, the Member shall not be allowed to change it subsequently.

The Board of Directors of the Company have appointed M/s. M.D. Baid & Associates, Practicing Company Secretaries, Surat (Peer Review No.: 942/2020 & Unique Identification No.: P2004GJ015700), as the Scrutinizer to scrutinize the remote e-voting and e-voting process at AGM in a fair and transparent manner.
