Limited alleged short payment of cross subsidy surcharge amount of Rs.1,54,74,013/- for the period from April 2005 to March 2015 towards power import through open access from Vennar Ceramics Limited.

There is no material impact on financial, operation or other activities of the Company due to the above mentioned demand notice.

Further, the Company intends to file an appeal against the demand before the appropriate judicial forum.
