Apollo Micro Systems Limited Enters into Definitive Agreement to Acquire 41.33% of Premier Explosives Limited

Strategic Acquisition to Support Next-Generation Defence and Space Programmes

Hyderabad, Telangana — July 09, 2026 — Apollo Micro Systems Ltd ("Apollo" or "the Company"), a 41-years-old pioneer in defence technology, specialized in design, development, and manufacturing of advanced electronic, electro-mechanical, and engineering systems, today announced that it has entered into a definitive share purchase agreement (the "Agreement") with Premier Explosives Ltd to acquire Promoter shares of 41.33% for approximately INR 1550 Crores in all cash deal. Premier Explosives Limited is engaged in the business of High Energy Materials, rocket motors for defence & aerospace, countermeasures and munitions.

Transaction Overview

- Apollo Micro Systems Ltd will acquire promoter shares representing 41.33% of Premier Explosives Ltd.
- Total consideration is valued at approximately INR 1550 crores, subject to customary closing adjustments.
- The transaction is expected to close in Third Quarter/December 2026, subject to customary closing conditions, regulatory approvals, shareholder approval, etc.
- Following completion, Premier Explosives Ltd will come under umbrella of Apollo Micro Systems Ltd and will continue to operate under its existing brand, with scaled performance.

The transaction combines complementary capabilities in defence systems and energetic materials, enabling operational efficiencies, enhanced R&D, and broader participation in defence and space-related programmes.
