Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, it is hereby informed that the Resourcing & Business Committee of the Board of Directors of the Company has approved the allotment of 62,500 equity shares of Rs. 2/- each on November 28, 2025, pursuant to exercise of stock options by the employees under the Aptus Employee Stock Option Scheme, 2021.
