OPENAI SAYS PRODUCTS DISPLAYED WON'T BE ADVERTISEMENTS

ChatGPT shopping option a new challenge to Google

CHATGPT CREATOR OPENAI has launched a new shopping option on its popular AI chatbot, in what could be a major challenge to Google, which also enables a similar function. However, there is a key difference, at least for the time being: OpenAI has said that the products which will be shown following a user's query are selected by ChatGPT independently and are not advertisements.

"Users come to ChatGPT with all kinds of questions, and one common topic is researching and buying products. Now, when a user query suggests shopping intent (e.g., 'I'm looking to buy costumes for my two dogs'), ChatGPT can display relevant product options in visually rich carousels, provide additional product details, and link users to websites where they can learn more or make a purchase — available in GPT-4o and 4o-mini," OpenAI said in a blog.

This feature is starting to roll out to Plus, Pro, Free, and logged-out users everywhere ChatGPT is available. While right now the system works on

information ChatGPT receives from third-party providers, it is exploring ways for merchants to provide their product feeds directly to the company.

There are some questions this launch raises: Could it become a potential source of revenue for the company going forward? If that is the case, how will affiliate revenue sharing, a concept well understood in the Google-led web, work? For now, the company has said that the products it showcases are not ads. But will that be the case forever? Could it lead to a world where AI chatbots become marketing

platforms? And what would that do to the whole "productivity" narrative these companies have tried creating, if they become yet another online classifieds platform?

Shopping options

A product appears in the visual carousel when ChatGPT perceives it's relevant to the user's intent. "ChatGPT assesses intent based on the user's query and other available context, such as memories or custom instructions," OpenAI said in its blog.

For example, if a user asks ChatGPT for help finding

goofy costumes for their two large dogs, ChatGPT will consider general factors, such as price, customer ratings, and ease of use, as well as specific criteria provided by the user, like sizing and the desired costume vibe. If the user had previously indicated a dislike for clowns, the model might also consider that and leave out clown costumes, it explained.

Google has also started using AI to show users products it thinks might be relevant to them. ChatGPT's feature bears many similarities to how Google now shows product listings in Search. However, there is one major difference between shopping through ChatGPT versus Google, for now: The results ChatGPT searches are not paid placements, but organic results.

Some product recommendations in Google Shopping could appear because a retailer paid for an ad spot to the company. But there are other mechanisms that Google relies on as well, as it also relies on websites which thoroughly test products and their reviews and accordingly ranks products.

Shubhanshu Shukla to fly into space on May 29



Shubhanshu Shukla will be the second Indian to travel to space after Rakesh Sharma more than four decades ago

AXIOM SPACE WILL launch its fourth mission to the International Space Station (ISS), carrying Indian astronaut Group Captain Shubhanshu Shukla and three others, from the Kennedy Space Center in Florida in the US on May 29.

The announcement was made by Axiom Space at a virtual press conference on Tuesday. Shukla's travel to space comes four decades after Rakesh Sharma's iconic spaceflight on board Russia's Soyuz

spacecraft. Besides Shukla, the Ax-4 crew includes members from Poland and Hungary, marking each nation's first mission to the International Space Station in history and the second government-sponsored human spaceflight mission in over 40 years.

Slawosz Uznanski, European Space Agency (ESA) project astronaut, will be the second Polish astronaut since 1978. Tibor Kapu will be the second national Hungarian astronaut since 1980.

Peggy Whitson will command her second commercial human spaceflight mission,

adding to her standing record for the longest cumulative time in space by an American astronaut.

The Ax-4 crew will launch aboard a SpaceX Dragon spacecraft to the space station and spend up to 14 days at the orbiting laboratory.

On February 27, 2024, Prime Minister Narendra Modi announced Shukla, an Indian Air Force (IAF) pilot, as one of the elite astronauts undergoing intensive training for India's maiden human spaceflight mission, Gaganyaan, scheduled for launch in 2025.

Baptism by fire, burnt by lapses

SUMANT KATHPALIA SHOULD have read the tea leaves long back — the regulator had given enough signals of its discontent with his leadership of IndusInd Bank at least twice in the past. In March 2023, the Reserve Bank of India (RBI) had reduced his tenure to two years, instead of the three years originally recommended by the bank's board. Last month, the RBI approved a one-year extension of his term even though the board had recommended a fresh three-year term.

Under his leadership, IndusInd Bank faced several other regulatory challenges. In December 2024, the RBI imposed a penalty on it for failing to adhere to deposit interest rate guidelines, while its probe revealed that the bank had opened savings accounts for ineligible individuals. In July 2022, a fine was imposed for non-compliance with Know Your Customer (KYC) norms. Also, in November 2021, the bank disclosed that it had inadvertently disbursed around 84,000 loans without customer consent due to a technical glitch.

So it was a surprise that Kathpalia took so much time to realise that the regulator "wasn't comfortable" with his leadership skills. "I don't know what the RBI's rationale is to give me (a) one-year extension, but I think they are not comfortable with my leadership skills of running the bank, and we should respect that," the MD & CEO said in an analyst call on the derivative portfolio impact. In less than two months, he has resigned taking "moral responsibility, given the various acts of omission/commission that have been brought to my notice."

His resignation comes a day after deputy CEO Arun Khurana stepped down and two days after the bank notified the exchanges that an independent probe by Grant

Thornton had found that the derivatives loss had occurred due to incorrect accounting of internal derivative trades by the bank, leading to notional profits and accounting discrepancies.

It was baptism by fire when Kathpalia took over the reins from Ramesh Sobti, another ABNAMRO veteran, at IndusInd Bank in March 2020. The uncertainty around the pandemic had already seen the Sensex fall by 37% — from 41,000 points to 26,000 points. Worse still, just a few weeks back, YES Bank's board had been superseded by the RBI. To be fair, Kathpalia hasn't done too badly on most parameters. For example, the number of branches to drive retail deposits till FY24 has

risen from 1,911 to 3,063 — a rise of 60%. Net profit has doubled from ₹4,418 crore to ₹8,950 crore in FY24. The net interest margin at 4.28% in FY24 is more than that of the country's biggest private sector bank — HDFC Bank's 3.54% — and similar to ICICI Bank's 4.32% in FY25. Evengross and net non-performing assets stood at 2.25% and 0.68%, respectively, as of December 2024.

Of course, it lags big banks in retail deposits at 46%. For example, HDFC Bank's retail deposits are at a whopping 83%. There are also worries about its micro-finance lending book at ₹32,564 crore. And now the losses due to derivatives misreporting have made things worse. The profit numbers give the bank comfort that the ₹1,960-crore loss due to misreporting in the derivatives segment will hurt them for just one quarter. Even the market reacted adversely to the news

initially, with the stock falling 27% on March 11. However, it has recovered and is currently down 7% from its pre-disclosure prices. The Sensex and the Nifty are up over 8% during this period.

But clearly, the RBI was not impressed. There are other allegations as well. Reports suggest that the Securities and Exchange Board of India is examining trading details of top officials of the bank to ascertain if there was any violation of insider trading rules.

According to stock exchange disclosures, between May 2023 and June 2024, Kathpalia sold 950,000 shares valued at approximately ₹134 crore, while Khurana sold 550,000 shares to raise around ₹82 crore. These shares were part of their employee stock option plans. One doesn't know if there are more skeletons in the cupboard.

Kathpalia, who had been leading the bank since 2020, had been at the forefront of its core executive team for over 12 years. A chartered accountant, he has had over 37 years of experience in large multinational banks like Citibank, Bank of America, and ABN AMRO, where he headed the consumer loans division, before joining IndusInd. The end to such a distinguished career must have hurt him badly. But the serious lapses in the recent past left the RBI with no other option as they have the potential to erode the trust factor. Clearly, Kathpalia and his team could have done better.

इसमें दोराय नहीं कि अच्छी और निर्बाध सड़क विकास के लिए अनिवार्य मानक हैं। पर ऐसी सड़कों अगर रफ्तार के बरक्स सफर करने वालों की जिंदगी को जोखिम में डालने का कारक बनती हैं, तो इसका मतलब है कि ऐसी सड़कों पर बचाव के उपायों का खयाल रखना जरूरी नहीं समझा गया है। यह छिपा नहीं है कि राजमार्ग या लंबी दूरी वाले एक्सप्रेस-वे ने लोगों की यात्रा को आसान और समय बचाने वाला बनाया है, मगर इसके साथ-साथ ऐसी सड़कों पर होने वाले हादसे और उसमें मरने वालों की दर भी तेजी से बढ़ी है। सोमवार को एक मामले की सुनवाई करते हुए सर्वोच्च न्यायालय ने कहा कि अगर सड़क हादसों में इतने लोगों की जान जा रही है, तो बड़े-बड़े राजमार्गों के निर्माण का क्या उद्देश्य है। अदालत ने केंद्र सरकार से सड़क हादसों में नकदीरहित इलाज की योजना के अब तक लागू न होने को लेकर भी सवाल पूछे। अखिल तो सड़क सुरक्षा सरकार की जिम्मेदारी है, चाहे उसके लिए नियम-कायदे बनाना हो या फिर लोगों के भीतर जिम्मेदारी से वाहन चलाने की प्रवृत्ति को बढ़ावा देने के लिए जागरूकता अभियान चलाना। दूसरे, अगर किन्हीं हालात में हादसे होते हैं तो उसके बाद हताहतों के जीवन को बचाना सबसे पहली प्राथमिकता होनी चाहिए। यह तथ्य है कि सड़क दुर्घटना में अगर कोई घायल हो जाता है तो उसके बाद के एक घंटे का वक्त यानी 'गोल्डन आवर' उसके जीवन के लिए बेहद महत्वपूर्ण होता है। इस अवधि में अगर उसे उचित इलाज मिल जाए तो उसकी जान बच सकती है। मगर हकीकत यह है कि लंबी दूरी के राजमार्गों या एक्सप्रेस-वे तो बना दिए गए हैं, लेकिन हादसे की स्थिति में घायलों को समय पर इलाज मुहैया कराने के लिए अस्पताल की व्यवस्था से लेकर वहां पहुंचाए जाने के जरूरी इंतजामों की अनदेखी की जाती है। सवाल है कि अगर सरकार ने हादसे के बाद एक घंटे की बेशकीमती अवधि में नकदीरहित इलाज का भरोसा दिया है, तो व्यवहार में उसे लागू करने में उसे क्या दिक्कत है। सड़क हादसों में अनेक ऐसे लोगों की भी मौत हो जाती है, जिन्हें समय पर इलाज मुहैया करा कर बचाया जा सकता था।
