Subject: Reference to your mail dated 12th March, 2026 regarding clarification of Financial Result – ARENTERP

Dear Sir/Madam,

With Reference to your email dated 12th March 2026, regarding clarification of Financial results submitted, we would like to submit the following clarification:

The Standalone and Consolidated figures appear identical because the share of profit/(loss) from the associate company, Rupal Holdings Private Limited, is insignificant. For Third Quarter, the loss attributable amounts to Rs. (201.39). The cumulative loss as at 31st December 2025 is Rs. (21804.118), compared to Rs. (21602.728) as at 30th September 2025, with the difference being Rs. (201.39).

As per disclosure requirements, the figures are required to be presented in lakhs. On conversion, the share of profit/(loss) of the associate company works out to Rs. (0.002) lakhs and if we round it up to the two decimal digits, then it will become zero .

Since this amount is immaterial, the impact on the Consolidated Financial Statements is negligible. Accordingly, the Standalone and Consolidated results are appearing same for the period under consideration. The Financial Results have been prepared in accordance with the format prescribed under Schedule III of the Companies Act, 2013.
