Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform that **Arfin India Limited** is introducing a **new product line — Medium Voltage Covered Conductor (MVCC)**.

The Company has undertaken this expansion to further strengthen its product portfolio within its Conductor & Cable Division. This new addition is expected of the additional revenue growth of **approximately ₹100 Crore over the next three years** and will substantially improve the overall margins. The decision has been taken considering the growing demand from the power distribution and utilities sector.

We would like to highlight that **MVCC (PVC Covered Conductor)** is a niche product category, and the Company anticipates an increase in demand for this type of conductor in the medium to long term. This initiative further strengthens the Company's presence in the conductor market, where suppliers of such specialized products are currently limited.

The commencement of production and dispatch under this new product segment is scheduled within FY 2026–27. The Company will continue to update the Stock Exchanges on any further material developments, as required under the applicable regulatory framework.
