1. An explanatory statement pursuant to Section 102 of the Companies Act, 2013 (**the “Act”**), setting out all material facts relating to the resolution for Item No. 2 to 3 in Notice are appended herein below for information and consideration of Members and the same should be considered as part of this Notice.
2. The Board of Directors of the Company, at its meeting held on August 11, 2026 has appointed Mr. Kamlesh M. Shah, proprietor of M/s. Kamlesh M. Shah & Co., Practicing Company Secretary, Ahmedabad (ICSI membership number: ACS 8356, Certificate of Practice number: 2072), who in the opinion of the Board is a duly qualified person as a scrutinizer to scrutinize the voting processes in a fair and transparent manner. The Scrutinizer shall submit his report of the votes cast in favor or against, if any, to the Chairman of the Company.
3. The Scrutinizer shall after the receipt of assent or dissent of the Members on or before Saturday, September 19, 2026 and after the completion of his Scrutiny, submit his report to the Chairman of the Company on or before September 22, 2026. The Result shall be announced by the Chairman of the Company on or before September 22, 2026 (within 2 working days of AGM) at the Company’s website www.arfin.co.in and on the website of NSDL and shall also be communicated to the stock exchanges. The resolutions will be taken as passed effectively on the date of AGM.
4. As the AGM is conducted through VC/OAVM, the facility to appoint Proxy by the members is not available for this AGM and hence the proxy form and attendance slip including route map are not annexed to this notice.
5. Institutional shareholders (i.e. other than individuals, HUF, NRI etc.) are required to send scanned copy (PDF/JPG Format) of the relevant Board Resolution/ Authority letter etc. with attested specimen signature of the duly authorized signatory (ies) who are authorized to vote, to the Scrutinizer by e-mail to kshahcs@yahoo.co.in with a copy marked to evoting@nsdl.co.in and investor@arfin.co.in. issued by the Securities and Exchange Board of India (collectively referred to as “SEBI Circulars”) and pursuant to Section 101 of the Act read with relevant rules made thereunder, this AGM is being convened to be held through Video Conferencing (“VC”) or Other Audio Visual Means (“OAVM”), without the physical presence of the members at a common venue. The proceedings of the AGM will be deemed to be conducted at the Registered Office of the Company which shall be the deemed Venue of the AGM. Notice of AGM is being sent only through electronic mode to those Members who have registered their email address either with the Company or with the Depository.

9. In compliance with provisions of Section 108 of the Companies Act, 2013, read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended from time to time, Regulation 44 of the SEBI LODR Regulations, and other applicable laws, and General Circular No. 14/2020 and 17/2020 dated April 8, 2020, April 13, 2020 respectively and other circulars further issued, if any, respectively by the Ministry of Corporate Affairs, the company is pleased to offer e-voting facility to its Members holding Equity Shares as on Saturday, September 12, 2026, being the cut-off date, to exercise their right to vote electronically on the above resolutions.
10. This facility is arranged by the National Securities Depository Limited (“NSDL”). The instructions for e-voting are given in this Notice. E-voting will commence on Wednesday, September 16, 2026 to Friday, September 18, 2026. E-voting shall not be allowed beyond the said date and time.
11. Member will be provided with a facility to attend the AGM through VC/OAVM through the NSDL e-Voting system. Members may access by following the steps mentioned below in Point ‘THE INSTRUCTIONS FOR MEMBERS FOR e-VOTING’ for Access to NSDL e-Voting system. 12. During this period, Members holding shares either in physical form or in dematerialized form, as on Saturday, September 12, 2026 i.e. cut-off date, may cast their vote electronically. Those members, who will be present in the AGM through VC / OAVM facility and have not cast their vote on the resolutions through remote e- Voting and are otherwise not barred from doing so, shall be eligible to vote through e-Voting system during the AGM. Any recipient of the Notice, who has no voting rights as on cut-off date, shall treat this notice as information only. The voting rights of members shall be in proportion to their shares in the paid-up equity share capital of the Company as on the cut-off date.
13. As required by Rule 20 of the Companies (Management and Administration) Rules, 2014 read with the MCA Circulars and the SEBI LODR Regulations, the details about this Notice will be published in one English newspaper having a wide circulation in India (in the English language) and one vernacular newspaper having a wide circulation in Gujarat (in the Gujarati language).
14. 18. Securities of listed companies would be transferred in dematerialized form only w.e.f. April 1, 2019. Technology Upgradation and Operational Excellence

During the financial year 2025–26, the Company continued to strengthen its manufacturing capabilities through strategic investments in technology enhancement, process optimisation, and operational infrastructure. These initiatives reflect our commitment to improving operational efficiency, enhancing product quality, and supporting long-term sustainable growth.

1. Commissioning of Ageing Furnace

The Company successfully commissioned an advanced Ageing Furnace to enhance Aluminium Alloy Rod processing capabilities and facilitate the manufacturing of AL-59 and AAAC Conductors. The installation of this facility has significantly improved production efficiency, process consistency, and product quality standards, while also supporting the Company's future expansion plans and growing customer demand.

2. Installation of Tilting Rotary Furnaces (TRF)

3. Installation of two Induction Furnaces for Ferro Alloys plant

The Company further strengthened its Ferro Alloy manufacturing operations through the installation of two new induction furnaces. This capacity enhancement is expected to improve operational efficiency, increase production output, and support the growing demand for ferro alloy products.

4. Procurement of High-Capacity RBD Machine

As part of its strategic expansion into the Extra High Voltage (EHV) conductor segment, the Company procured a high-capacity Double Wire Rod Breakdown (RBD) Machine. The new equipment is expected to enhance manufacturing efficiency, improve production speed, ensure superior product quality, and strengthen the Company's capability to cater to the increasing demand for EHV conductors.

5. Installation of Advanced Rigaku WD-XRF Testing facility

The Company installed a Rigaku make WD-XRF testing and analysis system to further strengthen its quality assurance and material testing capabilities. This advanced analytical equipment enhances the precision, reliability, and accuracy of material inspection processes, reinforcing the Company's commitment to maintaining the highest standards of quality and operational excellence.

Growth Projects Under Implementation/ Expansion & Development Initiatives

As part of its long-term growth strategy, Arfin India Limited continues to invest in capacity enhancement, product diversification, and advanced manufacturing infrastructure. These strategic initiatives are aimed at strengthening the Company's competitive position, improving operational efficiency, and addressing the evolving requirements of the power transmission and metallurgical industries. The key projects currently under implementation are outlined below:

1. MVCC Conductors

The Company is expanding its Conductor & Cable Division with the introduction of the MVCC (Medium Voltage Covered Conductors) product line. This strategic initiative is expected to strengthen Arfin's presence in the rapidly growing power transmission, distribution, and utility sectors while broadening its portfolio of value-added products. To support this expansion, the Company has placed an order for the required machinery, and the project is progressing as planned. Upon commissioning, the new facility is expected to enhance the Company's manufacturing capabilities and support the commercial production of MVCC conductors.

2. Advanced Rigid Multi-Stranding Machine at Conductor Plant

As part of its ongoing expansion in the Conductor Division, the Company has placed an order for an advanced Rigid Multi-Stranding (RST) Machine for its Conductor Plant. Once commissioned, the machine will facilitate the production of Extra High Voltage (EHV) conductors, including HTLS, ACSS, and AL-59 conductors, enhancing manufacturing capabilities, improving operational efficiency, and enabling the Company to cater to the growing demand from the power transmission sector. This initiative is expected to support future business growth and reinforce the Company's presence in the value-added conductor segment.

3. Tilting Rotary Furnace (TRF) Expansion at Dhanot Plant

The Company is expanding its melting infrastructure through the addition of Tilting Rotary Furnaces (TRFs) at its Dhanot Plant. The expansion is expected to enhance operational performance, optimize production capacity, and improve process efficiency. The project will also support the Company's long-term manufacturing objectives by strengthening plant infrastructure and enabling higher operational reliability.

4. Holding Furnace at Alloy Wire Rod Plant

Arfin is enhancing its Alloy Wire Rod manufacturing capabilities through the installation of a 10 MT Holding Furnace. 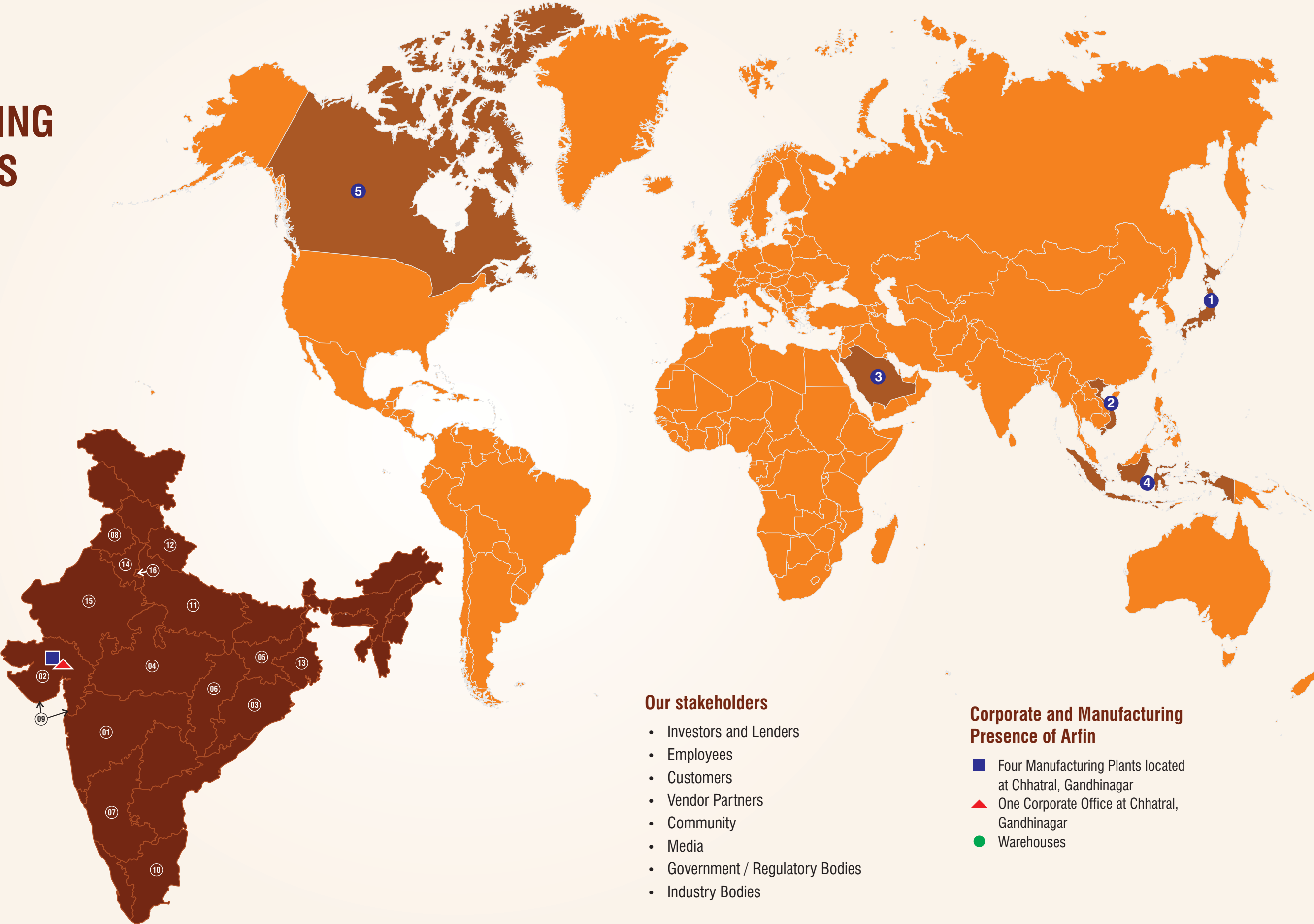

Industry Structure and Developments

The global aluminium industry demonstrated resilience during FY 2025-26, supported by sustained demand from key end-user sectors including electrical transmission and distribution, steel, foundry, construction, packaging, and infrastructure. Aluminium continues to be the material of choice owing to its lightweight properties, corrosion resistance, recyclability, and energy efficiency, making it an integral component of the global transition towards sustainable industrial development.

India's aluminium industry maintained a positive growth trajectory during the year, driven by increased public infrastructure spending, expansion of power transmission and distribution networks, rising electric vehicle adoption, and accelerated investments in renewable energy. Government initiatives such as enhanced capital expenditure, rural electrification, Make in India, and manufacturing-led growth continue to provide strong structural support for long-term demand across the aluminium value chain.

The aluminium recycling industry has emerged as a key enabler of sustainable manufacturing, supported by increasing emphasis on circular economy principles, resource efficiency, and carbon footprint reduction. Recycled aluminium consumes substantially less energy than primary aluminium production while offering significant environmental and economic advantages, making it an increasingly preferred choice across industries. The Aluminium recycling sector also continued to gain prominence owing to increasing emphasis on circular economy practices, resource efficiency, and reduction in carbon emissions.

The Government's policy initiatives, including the Extended Producer Responsibility (EPR) framework for non-ferrous metal scrap and the National Non-Ferrous Metal Scrap Recycling Framework, are expected to further strengthen India's organised recycling ecosystem. These initiatives encourage higher recycling rates, improved scrap traceability, efficient resource utilisation, and support the country's transition towards a circular economy, creating long-term growth opportunities for the secondary aluminium industry.

Structural demand drivers for aluminium and value-

added aluminium products continue to strengthen, supported by India's growing investments in transmission and distribution infrastructure, renewable energy integration, urbanisation, rail electrification, and industrial manufacturing. These sectors are increasingly demanding high-performance, lightweight, energy-efficient, and sustainable aluminium solutions. Simultaneously, the shift towards premium products, localisation of manufacturing, and supply chain diversification is creating significant opportunities for organized manufacturers with integrated capabilities and diversified product portfolios. Backed by its manufacturing expertise, expanding conductors' business, strong presence in Aluminium wire rods and allied products. Arfin India Limited is strategically positioned to benefit from these long-term structural growth drivers while continuing to deliver sustainable value to its stakeholders.

Although the industry continues to face challenges arising from raw material price volatility, energy costs, geopolitical developments, supply chain disruptions, and global economic uncertainties, its long-term fundamentals remain robust. Rising investments in infrastructure, clean energy, electrification, and sustainable manufacturing are expected to support healthy demand over the medium to long term.

Arfin India Limited operates in the ferrous and non-ferrous metals industry with a strategic focus on aluminium and value-added metal solutions. The Company has built a diversified portfolio comprising Aluminium Wire Rods, Aluminium Deox, Cored Wire, Aluminium Ingots, Ferro Titanium, Conductors & Cables, Spheroidizing Agent, Inoculants & AL-59, serving a wide spectrum of industries including power transmission, steel, foundry, infrastructure, engineering, and manufacturing. Backed by continuous product innovation, operational excellence, and a strong customer-centric approach, the Company remains well positioned to capitalise on emerging opportunities while delivering sustainable long-term value to its stakeholders.

Opportunities

The Indian aluminium industry offers significant long-term growth opportunities, driven by increasing

investments in power transmission and distribution, renewable energy, infrastructure, rail electrification, electric mobility, and manufacturing. Government initiatives such as Make in India, Atmanirbhar Bharat, and the growing emphasis on circular economy practices and aluminium recycling are expected to further strengthen demand for sustainable and value-added aluminium products.

The Company is well positioned to capitalise on these opportunities through its diversified product portfolio, integrated manufacturing capabilities, and strategic focus on value-added products. The strategic partnership with JFE Shoji India enhances the Company's access to global markets, while continued investments in operational excellence, product innovation, and capacity expansion are expected to strengthen its competitive position and support sustainable long-term growth.

In FY 2025-26, the Company demonstrated resilience amidst a challenging macroeconomic environment characterised by volatile commodity prices, changing market dynamics, and global uncertainties. During the year, the Company achieved total consolidated sales of 24,047 metric tons, generating revenue of ₹ 71,343 Lakhs. During the year, the Company maintained a strong operational performance through a disciplined focus on value-added products, product mix optimisation, cost efficiency, and prudent financial management, resulting in improved profitability and stronger operating margins. The Company recorded Consolidated Gross Export Sales of ₹ 9,834 Lakhs during the financial year ended March 31, 2026. With an installed annual production capacity of 71,000 metric tons, the Company remains well positioned to cater to future demand and drive sustainable growth through enhanced capacity utilisation, operational excellence, and strategic market expansion.

Threats

The Company continuously monitors the evolving business environment to identify potential risks that could impact its operations, financial performance, and long-term growth. While strategic initiatives and a robust risk management framework help mitigate these challenges, the following factors continue to pose potential threats to the business:

These factors can be main drivers behind the pressure on the Company in terms of operation and profitability.

Product / Plant Wise Performance

The Company operates solely in the business of manufacturing and trading of Ferrous and non-ferrous metals. It does not have any other reportable segments or business activities. Accordingly, separate segment-wise reporting is not applicable. The consolidated financial performance of each product/plant is presented below:

Aluminium Wire Rod

The Company has installed capacity of 15,000 metric tons per annum in the business of aluminium wire rod. The Company has sold 5,906 metric tons of aluminium wire rod worth ₹ 18,982. The Company recorded captive consumption of 364 metric tons and completed job work of 243 metric tons, reflecting our operational efficiency and trusted manufacturing capabilities. The

product primarily caters to the Steel and Power sectors, where it is used as a raw material for deoxidizing agents in the steel industry, as well as for the manufacturing of conductors and cables in the power sector.

Aluminium Deox

The Company is having installed capacity of 20,000 metric tons per annum in aluminium deox. The sales during the financial year under report was 11,543 metric tons amounting to ₹ 31,845 Lakhs. The product is primarily used in the Steel industry as an aluminium deoxidant agent for steel refining processes in steel plants.

Cored Wire

The Company is having cored wire plant with capacity of 3,500 metric tons per annum. The sales quantity during the financial year under report was 918 metric tons worth ₹ 4,089 Lakhs. The product is primarily used in the Steel Industry for desulphurization of steel and also serves as an additive during the steel melting process.

Conductor & Cables

The Company is having installed capacity of 12,000 metric tons per annum of conductor and cables plant. The sales during the financial year under report stood at 2,417 metric tons amounting to ₹ 8,383 Lakhs. The product is primarily used in the Power industry for the transmission of electricity from power plants to substations and from substations to end consumers.

Ferro Alloys

The Company is having installed capacity of 2,500 metric tons per annum of Ferro Alloys plant. The sales during the financial year under report stood at 803 metric tons amounting to ₹ 2,154 Lakhs. The product is primarily used in the Steel Industry as an additive in steel peeling processes for the manufacturing of high-grade steel.

Outlook

The global economy is expected to remain resilient despite geopolitical uncertainties, evolving trade policies, and commodity price volatility. Continued investments in clean energy, digital infrastructure, industrial automation, and power transmission are

expected to sustain demand across manufacturing sectors. The global transition towards decarbonization and resource-efficient manufacturing is accelerating the adoption of recyclable and lightweight materials, positioning aluminium as a critical enabler of sustainable industrial growth.

India continues to stand out as one of the world's fastest-growing major economies, supported by robust domestic demand, infrastructure-led capital expenditure, manufacturing expansion, and progressive policy initiatives such as Make in India and Atmanirbhar Bharat. Rising investments in renewable energy, transmission and distribution infrastructure, railway electrification, electric mobility, and urban development are expected to create sustained demand for aluminium and value-added metal products. Simultaneously, increasing emphasis on circular economy practices and aluminium recycling is expected to further strengthen the long-term growth prospects of the secondary aluminium industry.

Against this favourable backdrop, Arfin India Limited is well positioned to leverage emerging opportunities through its diversified product portfolio, integrated manufacturing capabilities, strategic partnership with JFE Shoji India, and continued focus on operational excellence, product innovation, and sustainable manufacturing. The Company's expansion into high-growth segments such as Conductors & Cables, coupled with its commitment to enhancing value-added offerings and strengthening global market presence, provides a strong foundation for sustainable long-term growth. With a disciplined execution strategy and a clear focus on creating enduring stakeholder value, the Company remains confident of strengthening its competitive position in the years ahead.

Business Highlights

The Aluminium Wire Rod, Aluminium Deox, and Conductors & Cables segments remained the key contributors to the Company's performance during FY 2025–26. The key financial highlights on a consolidated basis for the financial year ended March 31, 2026 are as follows:

3. Foreign Exchange Exposure:

The Company is exposed to foreign exchange fluctuations due to imports of raw materials and export transactions. Significant movements in exchange rates may impact procurement costs, export competitiveness, and overall financial performance.

4. Regulatory and Compliance Risk

The Company operates in a highly regulated

environment. Changes in environmental regulations, taxation policies, trade regulations, product standards, and corporate governance requirements may necessitate additional investments and operational adjustments.

The metal industry continues to witness intense competition from domestic as well as international manufacturers. Sustained pricing pressure and evolving customer expectations require continuous improvements in product quality, operational efficiency, innovation, and cost optimisation.

6. Supply Chain and Logistics Risk:

Disruptions in procurement, transportation, port operations, or supplier performance may impact the timely availability of raw materials and execution of customer orders. The Company continues to strengthen its sourcing strategy and supply chain resilience to minimise such risks.

7. Sustainability and ESG Expectations

Increasing stakeholder focus on environmental stewardship, energy efficiency, carbon reduction, and responsible business practices requires continuous investment in sustainable manufacturing processes and compliance with evolving ESG standards.

8. Human Capital Risk

The Company's long-term success depends on attracting, developing, and retaining a skilled workforce. Talent availability, employee engagement, succession planning, and workplace safety remain key priorities in supporting business growth.

Internal Control Systems and its Adequacy

The Company has established a comprehensive and robust internal control framework commensurate with the size, nature, and complexity of its business operations. The internal control system is designed to

provide reasonable assurance regarding the effectiveness and efficiency of operations, reliability of financial reporting, safeguarding of assets, compliance with applicable laws and regulations, and timely identification and mitigation of business risks.

The Company has implemented well-defined policies, delegation of authority, and maker-checker mechanisms across key business processes. These controls facilitate disciplined decision-making, enhance operational efficiency, ensure compliance with statutory requirements, and strengthen the overall governance framework.

The Internal Audit function, carried out by an independent firm of professionals, adopts a risk-based audit approach covering all critical operational, financial, compliance, and information technology processes. The scope of internal audit is reviewed periodically to ensure that emerging business risks, regulatory developments, and process changes are adequately addressed. The Internal Auditors submit their reports directly to the Audit Committee, which regularly reviews the audit observations, management responses, and implementation status of corrective actions.

The Audit Committee provides strategic oversight of the Company's internal financial controls and risk management framework. It periodically evaluates the adequacy and effectiveness of internal controls, reviews the findings of the Internal Auditors and Statutory Auditors, and monitors the implementation of recommendations to further strengthen the control environment. The Committee also ensures compliance with the requirements relating to Internal Financial Controls under Section 134(5)(e) of the Companies Act, 2013.

The Company's Financial Statements are prepared in accordance with the Indian Accounting Standards (IND AS) notified under the Companies (Indian Accounting Standards) Rules, 2015, as amended, and other applicable provisions of the Companies Act, 2013. The significant accounting policies are reviewed periodically and approved by the Audit Committee and the Board of Directors to ensure consistency, transparency, and compliance in financial reporting.

Based on the assessment carried out during the financial year ended March 31, 2026, the Management believes that the Company's Internal Financial Controls over Financial Reporting (IFC/ICFR) are adequate and operating effectively. No material weaknesses were identified in the design or operating effectiveness of the internal control system, and the Company continues to strengthen its governance and control processes in line with evolving business requirements and regulatory expectations.

Return on Net Worth (RONW)) serves as a key profitability indicator, expressed as a percentage. It is calculated by dividing the net profit by the average net worth (capital employed) during the financial year. During the year, the Company's net profit grew from ₹ 915 lakhs to ₹ 1,545 lakhs. Concurrently, the net worth of the Company increased significantly from ₹ 15,678 lakhs to ₹ 17,035 lakhs, primarily due to the increase in profit for the year.

Review of Consolidated Financial Performance of the Company for the Period under Report

Sales

The Company reported Gross Sales of ₹ 71,343 Lakhs and Net Income from Operations of ₹ 61,800 Lakhs during the financial year 2025–26 as compared to ₹ 70,919 Lakhs and ₹ 61,575 Lakhs, respectively, in the previous financial year 2024–25. The Company maintained a stable financial performance during the year despite a dynamic business environment, supported by its diversified product portfolio, continued focus on value-added products, strong customer relationships, and sustained operational efficiencies, which contributed to improved overall business performance.

Profit Before Tax

The Company reported a Profit Before Tax of ₹ 2,371 Lakhs for the financial year 2025–26, marking a 65% year-on-year growth compared to ₹ 1,438 Lakhs in the previous year.

Interest

Finance costs decreased from ₹ 1,982 Lakhs in the previous financial year 2024–25 to ₹ 1,873 Lakhs during the financial year 2025–26, reflecting prudent financial management and optimized borrowing costs. Consequently, the Debt Service Coverage Ratio (DSCR) improved to 2.51 times as on March 31, 2026, from 1.93 times in the previous year, indicating stronger debt-servicing capability and an enhanced financial position.

Net Profit

Net profit for the financial year under report stood at ₹ 1,545 Lakhs as compared to ₹ 915 Lakhs in the previous financial year 2024-25. It reflects year on year growth of 69 % with compared to previous financial year.

Dividend

The Board of Directors of the Company has decided not to recommend final dividend for the financial year ended March 31, 2026, to conserve profit for its future operations.

Capital Employed

The capital employed in the business was increased by ₹ 2,591 Lakhs for financial year ended March 31, 2026 as the Reserve or Surplus of the company increased during the year.

Surplus Management

The Company generated a cash profit of ₹ 2,140 Lakhs for the financial year ended March 31, 2026 as compared to ₹ 1,408 Lakhs during the previous financial year. The cash profit is ploughed back into the business to fund the growth.

Equity Share Capital

Financial Highlights and State of Company's Affairs

During the year under review, your Company's Standalone revenue stood at ₹ 62,611.48 Lakhs including other income of ₹ 121.90 Lakhs as compared to total revenue of ₹ 61,771.22 Lakhs including other income of ₹ 195.84 Lakhs during the previous financial year ended March 31, 2025. The Net Profit stood at ₹ 1,359.71 Lakhs as compared to the profit of the previous financial year ended March 31, 2025 amounting to ₹ 915.10 Lakhs.

Further on Consolidated basis, the total revenue stood at ₹ 61,891.37 Lakhs including other income

of ₹ 92.19 Lakhs as compared to total revenue of ₹ 61,771.22 Lakhs including other income of ₹ 195.84 Lakhs during the previous financial year ended March 31, 2025. The Net Profit stood at ₹ 1,545.13 Lakhs as compared to the profit of the previous financial year ended March 31, 2025 amounting to ₹ 914.63 Lakhs.

2. Transfer to Reserve

The closing balance of the retained earnings of the Company for FY 2025-2026, after all appropriation and adjustments was ₹ 6,841.55 Lakhs for the Standalone and ₹ 7,026.51 for the Consolidated financial statement. The Board of Directors of the Company has not proposed any amount to be

transferred to the General Reserve.

3. Dividend

The Board of Directors of the Company, at its meeting held on November 11, 2025, declared an Interim Dividend for the financial year ended March 31, 2026. The Interim Dividend was duly paid to the eligible shareholders on November 20, 2025.

In view of the Interim Dividend already declared and paid during the year, and after careful evaluation of the Company's capital requirements, growth opportunities, and long-term strategic priorities, the Board has not recommended any Final Dividend on equity shares for the financial year ended March 31, 2026.

The Board remains committed to maintaining a prudent balance between rewarding shareholders and retaining adequate resources to support future growth initiatives. The decision to conserve a portion of earnings reflects the Company's focus on strengthening its financial position, funding strategic investments, enhancing operational capabilities, and pursuing emerging business opportunities, including expansion into new product segments. The Board believes that such disciplined capital allocation will contribute to sustainable value creation and deliver enhanced long-term returns to shareholders.

4. Listing on Stock Exchanges

As on March 31, 2026, the equity shares of the Company were listed on BSE Limited & National Stock Exchange of India Limited. The Company has paid the annual listing fees for the financial year ending on March 31, 2026 within the prescribed timeline. Further, the Company got listed on the National Stock Exchange of India Limited (NSE) with effect from July 22, 2025.

5. Details in Respect of Adequacy of Internal Financial Control with Reference to the Financial Statements and Audit

The Company has designed and implemented process driven framework for internal financial

controls within the meaning of explanation to Section 134(5)(e) of the Act.

For the year ended on March 31, 2026, the Board is of the opinion that the Company has adequate internal control systems commensurate with the size, scale and complexity of its business operations. The internal control systems comprising of policies and procedures are designed to ensure sound management of your Company's operations, safe keeping of its assets, optimal utilization of resources, reliability of its financial information and compliances. A rooftop Solar PV system with an installed capacity of 350.46 KW was successfully implemented at the Company's Kalol facility (Block No. 132, Old Survey No. 75). This installation reinforces the Company's commitment to sustainable operations by harnessing clean energy, optimizing power usage, and reducing operational energy intensity. 3. The Company also commissioned a 509.24 KW solar PV system at its Kadi unit (Survey No. 118/1, Ravi Estate). This initiative aligns with Arfin's broader environmental stewardship agenda by integrating sustainable energy solutions into its manufacturing processes, thereby supporting long-term ecological balance and responsible resource management. 4. The Company installed an 87.75 KW Solar PV System at its Conductor Plant located at Plot No. 117/3, 6 & 7, Ravi Industrial Estate, Chhatral, Gandhinagar – 382729. This initiative supports the Company's commitment to renewable energy, improved energy efficiency, and environmentally responsible manufacturing practices.

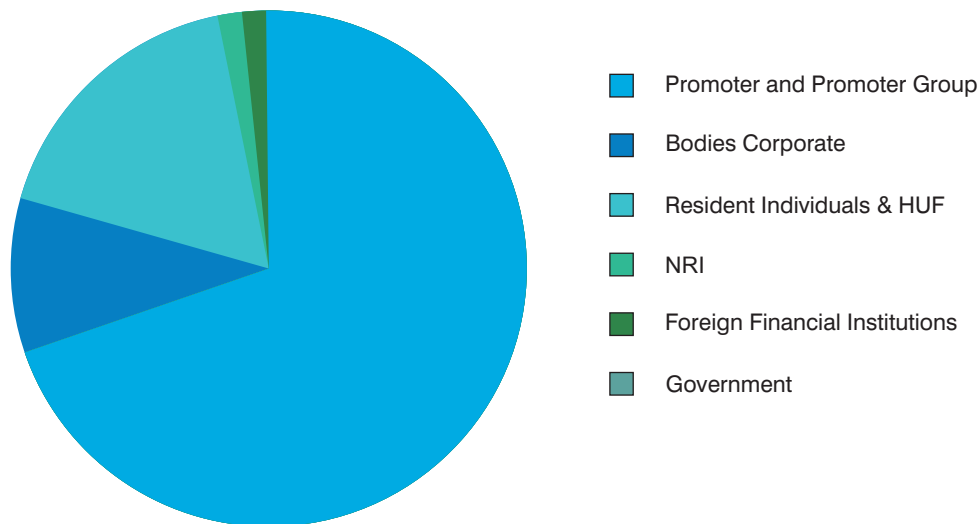

Note 1 Company Overview and Significant Accounting Policies

1 Corporate Information

Arfin India Limited (the “Company”) is a public Company domiciled in India and incorporated under the provisions of Companies Act, 1956. Its Equity Shares are listed on Main Board of NSE & BSE Limited. The registered office of the Company is located at Plot No. 117, Ravi Industrial Estate, Billeshwarpura, Chhatral, Tal. – Kalol, Dist. – Gandhinagar-382729, Gujarat, India.

The Company is engaged in the business of manufacturing, trading and selling of various Ferrous & non-ferrous metal products and its manufacturing facilities are located at Chhatral, Dhanot and Vadaswami in the State of Gujarat. The Company has branch office at Raigarh in the State of Maharashtra. The Company caters to both domestic as well as international markets.

The Standalone Financial Statements for the financial year ended March 31, 2026 have been approved by the Board of Directors of the Company in its meeting held on May 11, 2026.

2.1 Basis of Preparation of Standalone Financial Statements

Compliance with IND AS

These Standalone Financial Statements have been prepared in accordance with the Indian Accounting Standards (hereinafter referred to as the ‘IND AS’) as notified by the Ministry of Corporate Affairs pursuant to Section 133 of the Companies Act, 2013 (‘Act’) read with the Companies (Indian Accounting Standards) Rules, 2021 as amended and other relevant provisions of the Act.

Historical Cost Convention

The Standalone financial statements have been prepared on a historical cost basis, except for the following:

- i) Certain financial assets and liabilities that are measured at fair value or amortized cost;
- ii) Defined benefit plans - plan assets are measured at fair value less present value of defined benefit obligations.

Current and Non-Current Classification

All assets and liabilities have been classified as current or non-current as per the Company’s normal operating cycle (twelve months) and other criteria set out in the Schedule III to the Act.

Rounding off of Amounts

All amounts disclosed in the Standalone Financial Statements and notes have been rounded off to the nearest rupees in lakh as per the requirement of Schedule III, unless otherwise stated.

2.2 Use of Estimates

The estimates and judgments used in the preparation of the Standalone Financial Statements are continuously evaluated by the Company and are based on historical experience and various other assumptions and factors (including expectations of future events) that the Company believes to be reasonable under the existing circumstances. Differences between actual results and estimates are recognized in the period in which the results are known / materialized. The said estimates are based on the facts and events, that existed as at the reporting date, or that occurred after that date but provide additional evidence about conditions existing as at the reporting date.

2.3 Property, Plant & Equipment

Property, plant and equipment are stated at cost, net of recoverable taxes, less depreciation and impairment losses, if any. Such cost includes purchase price, borrowing cost and other cost directly attributable to the acquisition of the items.

Subsequent costs are included in the asset’s carrying amount or recognized as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the

Company and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognized when replaced. All other repairs and maintenance are charged to the Statement of Profit and Loss during the reporting period in which they are incurred.

Depreciation methods, estimated useful lives and residual value

Depreciation is provided on a Straight-Line Method over the estimated useful lives of assets.

The Company depreciates its property, plant and equipment over the useful life in the manner prescribed in Schedule II to the Act, and the management believes that useful life of assets are same as those prescribed in the Schedule II to the Act.

The residual values are not more than 5% of the original cost of the asset. The assets residual values and useful lives are reviewed and adjusted if appropriate, at the end of each reporting period.

The gain or loss arising from the de-recognition of an item of property, plant and equipment is measured as the difference between the net disposal proceeds and the carrying amount of the item and is recognized in the Statement of Profit and Loss when the item is derecognized.

Capital Work-In-Progress and Capital Advances

Cost of assets not ready for intended use, as on the Balance Sheet date is shown as capital work in progress. Advances given towards acquisition of fixed assets outstanding at Balance Sheet date are disclosed as Other Current Assets.

2.4 Intangible Assets

Computer software are stated at cost, less accumulated amortization and impairments, if any.

Amortization Method and Useful Life

The Company amortizes computer software using the straight-line method over the period of 5 years. Gains and losses on disposals are determined by comparing proceeds with carrying amount. These are included in the Statement of Profit and Loss.

2.5 Inventories

Items of inventories of Raw Material, Finished goods, WIP, Spares and Stores, Packing Material & Fuel are valued at lower of cost or net realizable value except waste which is valued at estimated net realizable value. Raw Material cost of inventories comprises of cost of purchase and other costs incurred in bringing the inventories to their present location and condition. Finished goods cost of inventories comprises of cost of purchase, cost of conversion and other costs including manufacturing overheads incurred in bringing them to their respective present location and condition

2.6 Financial Instruments

(i) Initial Recognition and Measurement

The Company recognizes financial assets and liabilities when it becomes a party to the contractual provisions of the instrument. All financial assets and liabilities are recognized at fair value on initial recognition, except for trade receivables which are initially measured at transaction price. Transaction costs that are directly attributable to the acquisition or issue of financial assets and liabilities that are not at fair value through profit or loss are added to the fair value on initial recognition. Regular way of purchase and sale of financial assets are recognized on the trade date.

(ii) Subsequent Measurement

A. Non-Derivative Financial Instrument

(a) Financial Assets Carried at Amortized Cost

A financial asset is subsequently measured at amortized cost if it is held within a business model whose objective is to hold the asset in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

(b) Financial Assets at Fair Value through Other Comprehensive Income

A financial asset is subsequently measured at fair value through other comprehensive income if it is held within a business model whose objective is achieved by both collecting contractual cash flows and selling financial assets and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

The Company has made an irrevocable election for its investments which are classified as equity instruments to present the subsequent changes in fair value in other comprehensive income based on its business model. Further, in cases where the Company has made an irrevocable election based on its business model, for its investments which are classified as equity instruments, the subsequent changes in fair value are recognized in other comprehensive income.

(c) Financial Assets at Fair Value through Profit or Loss

A financial asset which is not classified in any of the above categories is subsequently fair valued through profit or loss.

(d) Financial Liabilities

Financial liabilities are subsequently carried at amortized cost using the effective interest method, except for contingent consideration recognized in a business combination which is subsequently measured at fair value through profit and loss. For trade and other payables maturing within one year from the Balance Sheet date, the carrying amounts approximate fair value due to the short maturity of these instruments.

B. Derivative Financial Instruments

The Company holds derivative financial instruments such as foreign exchange forward and option contracts to mitigate the risk of changes in exchange rates on foreign currency exposures. The counterparty for these contracts is generally a bank.

Financial Assets or Liabilities, at Fair Value through Profit or Loss

This category has derivative financial assets or liabilities which are not designated as hedges. Although the Company believes that these derivatives constitute hedges from an economic perspective, they may not qualify for hedge accounting under IND AS 109, Financial Instruments. Any derivative that is either not designated as hedge, or is so designated but is ineffective as per IND AS 109, is categorized as a financial asset or financial liability, at fair value through profit or loss.

Derivatives not designated as hedges are recognized initially at fair value and attributable transaction costs are recognized in net profit in the Statement of Profit and Loss when incurred. Subsequent to initial recognition, these derivatives are measured at fair value through profit or loss and the resulting exchange gains or losses are included in other income. Assets / liabilities in this category are presented as current assets / liabilities if they are either held for trading or are expected to be realized within 12 months after the balance sheet date.

C. De-Recognition of Financial Instruments

The Company derecognizes a financial asset when the contractual right to receive the cash flows from the financial asset expires or it transfers the financial asset.

A financial liability is derecognized when the obligation under the liability is discharged, cancelled or expired.

2.7 Current versus Non-Current Classification

An asset is considered as current when it is:

- expected to be realized or intended to be sold or consumed in normal operating cycle;
- held primarily for the purpose of trading;
- expected to be realized within twelve months after the reporting period; or
- cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period.

All other assets are classified as non-current.

A liability is considered as current when it is:

- expected to be settled in normal operating cycle;
- held primarily for the purpose of trading;
- due to be settled within twelve months after the reporting period; or
- there is no unconditional right to defer the settlement of the liability for at least twelve months after the reporting period.

All other liabilities are classified as non-current.

Deferred tax assets and liabilities are classified as non-current assets and liabilities respectively.

2.8 Measurement of Fair Value

Fair value is the price that would be received on sell of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either:

- in the principal market for the asset or liability; or
- in the absence of a principal market, in the most advantageous market for the asset or liability.

The principal or the most advantageous market must be accessible by the Company.

The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Company uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximizing the use of relevant observable inputs and minimizing the use of unobservable inputs.

Notes Forming Part of Standalone Financial Statements

All assets and liabilities for which fair value is measured or disclosed in the Standalone Financial Statements are categorized within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

- Level 1– Quoted (unadjusted) market prices in active markets for identical assets or liabilities.
- Level 2 – Valuation techniques for which the lowest level input that is significant to the fair value measurement is directly or indirectly observable.
- Level 3 – Input for the asset or liability those are not based on observable market data (unobservable inputs).

2.9 Investments and Other Financial Assets

Classification

The Company classifies its financial assets in the following measurement categories:

- Those to be measured subsequently at fair value (either through Other Comprehensive Income, or through the Statement of Profit and Loss), and
- Those measured at amortized cost.

The classification depends on the Company's business model for managing the financial assets and the contractual terms of the cash flows.

Measurement

At initial recognition, the Company measures a financial asset at its fair value. Transaction costs of financial assets are expensed out in the Statement of Profit and Loss.

Impairment of Financial Assets

The Company measures the expected credit loss associated with its assets based on historical trend, industry practices and the business environment in which the entity operates or any other appropriate basis. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

2.10 Revenue Recognition

Revenue is measured at the value of the consideration received or receivable. Amounts disclosed as revenue are net of returns, trade allowances, rebates, discounts, GST and amounts collected on behalf of third parties.

The Company recognizes revenue when the amount of revenue can be reliably measured. It is probable that future economic benefits will flow to the Company and specific criteria have been met for each of the Company's activities as described below:

Sale of Goods

Sales are recognized when substantial risk and rewards of ownership are transferred to customers. In case of domestic customer, generally sales take place when goods are dispatched or delivery is handed over to transporter. In case of export customers, generally sales take place when goods are shipped on board based on bill of lading or Ex Works as per terms with customers.

Other Operating Revenue

Export Incentives under various schemes are accounted in the year in which right to receive is irrevocably established.

Other Revenue

Interest income is recognized on a time proportion basis taking into account the amount outstanding and the applicable rate of interest.

Revenue in respect of insurance / other claims etc. is recognized only when it is reasonably certain that the ultimate collection will be made.

Dividend

Dividends are generally recognized in the Statement of Profit and Loss only when the right to receive payment is established.

2.11 Foreign Currency Transactions

The Standalone Financial Statements are presented in Indian Rupee (INR), which is Company's functional and presentation currency.

Foreign currency transactions are accounted for at the exchange rate prevailing on the date of the transaction. All monetary foreign currency assets and liabilities are converted at the exchange rates prevailing on the date of the Balance Sheet. All exchange differences other than those relating to the acquisition of fixed assets from outside India are dealt with in the Statement of Profit and Loss. Exchange gain or loss relating to fixed assets acquired from outside India is adjusted in the cost of respective fixed assets. All non-monetary items are measured at historical cost basis.

In case of forward contracts, the gain / loss on contracts are treated as periodical expense or revenue. Any profit or loss arising on the cancellation or renewal of a forward exchange contract is recognized as income or expense for the year, except in case of a forward exchange contract relating to liabilities incurred for acquiring fixed assets from outside India, in which case, such profit or loss is adjusted in the cost of fixed assets.

Exchange difference is calculated as the difference between the foreign currency amount of the contract translated at the exchange rate at the reporting date, or the settlement date where the transaction is settled during the reporting period, and the corresponding foreign currency amount translated at the later of the date of inception of the forward exchange contract and the last reporting date. Such exchange differences are recognized in the Statement of Profit and Loss in the reporting period in which the exchange rates change.

2.12 Income Tax

The income tax expense or credit for the period is the tax payable on the current period's taxable income based on the applicable income tax rate adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses.

Deferred income tax is provided in full, using the liability method on temporary differences arising between the tax bases of assets and liabilities and their carrying amount in the Standalone Financial Statements. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantially enacted by the end of the reporting period and are expected to apply when the related deferred income tax asset is realized or the deferred income tax liability is settled.

Deferred tax assets are recognized for all deductible temporary differences and unused tax losses, only if, it is probable that future taxable amounts will be available to utilize those temporary differences and losses.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets and liabilities and when the deferred tax balances relate to the same taxation authority. Current tax assets and tax liabilities are offset where the Company has a legally enforceable right to offset and intends either to settle on a net basis, or to realize the asset and settle the liability simultaneously.

Current and deferred tax is recognized in the Statement of Profit and Loss, except to the extent that it relates to items recognized in other comprehensive income or directly in equity. In that case, the tax is also recognized in other comprehensive income or directly in equity, respectively.

Minimum Alternate Tax credit is recognized as deferred tax asset only when and to the extent there is convincing evidence that the Company will pay normal income tax during the specified period. Such asset is reviewed at each Balance Sheet date and the carrying amount of the MAT credit asset is written down to the extent there is no longer a convincing evidence to the effect that the Company will pay normal income tax during the specified period.

2.13 Provisions and Contingent Liabilities

Provisions are recognized when the Company has a present legal or constructive obligation. As a result of past events, it is probable that an outflow of resources will be required to settle the obligation and the amount can be reliably estimated. Provisions are not recognized for future operating losses.

Provisions are measured at the present value of management's best estimate of the expenditure required to settle the present obligation at the end of the reporting period. The discount rate used to determine the present value is a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. The increase in the provision due to the passage of time is recognized as interest expense.

Contingent Liabilities are disclosed in respect of possible obligations that arise from past events but their existence will be confirmed by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company or where any present obligation cannot be measured in terms of future outflow of resources or where a reliable estimate of the obligation cannot be made.

2.14 Employee Benefits

Short Term Obligations

Liabilities for wages and salaries, including non-monetary benefits that are expected to be settled wholly within 12 months after the end of the period in which the employees render the related services are recognized in respect of employees' services up to the end of the reporting period and are measured at the amounts expected to be paid when the liabilities are settled.

Post-Employment Obligations

The Company operates the following post-employment schemes:

- (a) defined benefit plans such as gratuity; and
- (b) defined contribution plans such as provident fund.

Gratuity Obligations

The liability or asset recognized in the Balance Sheet in respect of defined benefit gratuity plan is the present value of the defined benefit obligation at the end of the reporting period less the fair value of plan assets. The defined benefit obligation is calculated annually by actuaries using the projected unit credit method.

The present value of the defined benefit obligation is determined by discounting the estimated future cash outflows by reference to market yields at the end of the reporting period on government bonds that have terms approximating to the terms of the related obligation.

The net interest cost is calculated by applying the discount rate to the net balance of the defined benefit obligation and the fair value of plan assets. This cost is included in employee benefit expense in the Statement of Profit and Loss.

Remeasurement gains and losses arising from experience adjustments and changes in actuarial assumptions are recognized in the period in which they occur, directly in other comprehensive income. They are included in retained earnings in the Statement of Changes in Equity and in the Balance Sheet. Gratuity liability of employees is not funded.

Defined Contribution Plans

Defined Contribution Plans such as Provident Fund, etc., are charged to the Statement of Profit and Loss as incurred.

2.15 Borrowing Costs

Borrowing cost comprises of interest and other costs incurred in connection with the borrowing of the funds.

All borrowing costs are recognized in the Statement of Profit and Loss using the effective interest method except to the extent attributable to qualifying property, plant and equipment (PPE) which are capitalized to the cost of the related assets. A qualifying PPE is an asset that necessarily takes a substantial period of time to get ready for its intended use or sale. Borrowing cost also includes exchange differences to the extent considered as an adjustment to the borrowing costs.

2.16 Earnings Per Share

Basic Earnings Per Share

Basic earnings per share is calculated by dividing:

- the profit attributable to owners of the Company by
- average number of equity shares outstanding during the financial year, adjusted for bonus elements in equity shares issued during the year and excluding treasury shares.

Diluted Earnings Per Share

Diluted earnings per share adjusts the figures used in the determination of basic earnings per share to take into account:

- the after income tax effect of interest and other financing costs associated with dilutive potential equity shares, and
- the weighted average number of additional equity shares that would have been outstanding assuming the conversion of all dilutive potential equity shares.

2.17 Impairment of Assets

An asset is treated as impaired when the carrying cost of asset exceeds its recoverable Value. An impairment loss is charged to the Statement of Profit and Loss in the year in which an asset is identified as impaired. The impairment loss recognized in earlier accounting period is reversed if there has been a change in the estimate of recoverable amount.

2.18 Leases

As a Lessee

The Company's lease asset classes primarily consist of leases for buildings taken on lease for operating its branch offices, if any. The Company assesses whether a contract contains a lease, at inception of a contract. At the date of commencement of the lease, the Company recognizes a right-of-use asset ("ROU") and a corresponding lease liability for all lease arrangements in which it is a lessee, except for leases with a term of twelve months or less (short-term leases) and low value leases. For these short-term and low value leases, the Company recognizes the lease payments as an operating expense on a straight-line basis over the term of the lease.

Right-of-use assets are depreciated from the commencement date on a straight-line basis over the lease term. The lease liability is initially measured at amortized cost at the present value of the future lease payments, if any.

During the year, Company has only short-term and low value leases, therefore the Company recognizes the lease payments as an operating expense on a straight-line basis over the term of the lease.

As a Lessor

Lease income from operating leases where the Company is a lessor is recognised in income on a straight-line basis over the lease term unless the receipts are structured to increase in line with expected general inflation to compensate for the expected inflationary cost increases. The respective leased assets are included in the balance sheet based on their nature, if any.

During the year, Company has only short-term and low value leases receipt, therefore the Company recognizes the lease receipts as an operating income in profit & loss account.

2.19 Government Grants

Government grants are recognized on systematic basis when there is reasonable certainty of realization of the same. Revenue grants including subsidy / rebates are credited to the Statement of Profit and Loss under "Other Income" or deducted from the related expenses for the period to which these are related. Grants which are meant for purchase, construction or otherwise acquired through non-current assets are recognized as deferred income and disclosed under non-current liabilities and transferred to the Statement of Profit and Loss on a systematic basis over the useful life of the respective asset. Grants relating to non-depreciable assets are transferred to the Statement of Profit and Loss over the periods that bear the cost of meeting the obligations related to such grants.

2.20 Cash and Cash Equivalents

Cash and cash equivalents include cash and cheques in hand, bank balances, demand deposits with banks and other short term highly liquid investments that are really convertible to known amounts of cash and which are subject to an insignificant risk of changes in value where original maturity is three months or less.

2.21 Cash Flow Statement

Cash flows are reported using the indirect method whereby the profit before tax is adjusted for effect of the transactions of a non-cash nature, any deferrals or accruals of past and future operating cash receipts or payments and items of income or expenses associated with investing or financing cash flows. The cash flows from operating, investing and financing activities of the Company are segregated.

2.22 Share Capital

Shares are classified as equity. Incremental costs directly attributable to the issuance of new ordinary shares and share options are recognized as a deduction from equity, net of any tax effects.

2.23 Cash Dividend

The Company recognizes a liability to make cash or non-cash distributions to equity shareholders of the Company when the distribution is authorized and the distribution is no longer at the discretion of the Company. As per the Companies Act, 2013, a distribution is authorized when it is approved by the shareholders. A corresponding amount is recognized directly in equity.

44. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The Company's activities are exposed to variety of financial risks. The key financial risks include market risk, credit risk and liquidity risk. The Company's focus is to foresee the unpredictability of financial markets and seek to minimize potential adverse effects on its financial performance. The Board of Directors reviews and approves policies for managing risks. The risks are governed by appropriate policies and procedures and accordingly financial risks are identified, measured and managed in accordance with the Company's policies and risk objectives.

MARKET RISK

Market risk is the risk of loss of future earnings, fair values or future cash flows that may result from a change in the price of a financial instrument. The value of a financial instrument may change as a result of changes in the interest rates, foreign currency exchange rates, equity prices and other market changes

that affect market risk sensitive instruments. Market risk is attributable to all market risk sensitive financial instruments including investments and deposits, foreign currency receivables, payables and loan borrowings.

The Company manages market risk through its treasury department, which evaluates and exercises independent control over the entire process of market risk management. The treasury department recommends risk management objectives and policies, which are approved by the Senior Management. The activities of this department include management of cash resources, implementing hedging strategies for foreign currency exposures, borrowing strategies and ensuring compliance with market risk limits and policies.

Interest Rate Risk

Interest rate risk is the risk that fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. In order to optimize the company's position with regards to the interest income and interest expenses and to manage the interest rate risk, treasury performs a comprehensive corporate interest rate risk management by balancing the proportion of fixed rate and floating rate financial instruments in its total portfolio.

CREDIT RISK

Credit risk arises from the possibility that counter party may not be able to settle their obligations as agreed. To manage this, the Company periodically assesses the financial reliability of customers, taking into account the financial condition, current economic trends and analysis of historical bad debts and ageing of accounts receivable (Refer note no. 10.2). Individual risk limits are set accordingly.

The Company considers the probability of default upon initial recognition of asset and whether there has been a significant increase in credit risk on an ongoing basis throughout each reporting period. To assess whether there is significant increase in credit risk, the company compares the risk of a default occurring on the asset at the reporting date with the risk of default on the date of initial recognition. It considers reasonable and supportive forward-looking information such as:

- Actual or expected significant adverse changes in business,
- Actual or expected significant changes in the operating results of the counterparty,

- (iii) Financial or economic conditions that are expected to cause a significant change to the counterparty's ability to meet its obligation.

Financial assets are written off when there is no reasonable expectation of recovery, such as a debtor failing to engage in a repayment plan with the Company. Where loans or receivables have been written off, the Company continues to engage in enforcement activity to attempt to recover the receivable due. Where recoveries are made, these are recognised in profit or loss.

LIQUIDITY RISK

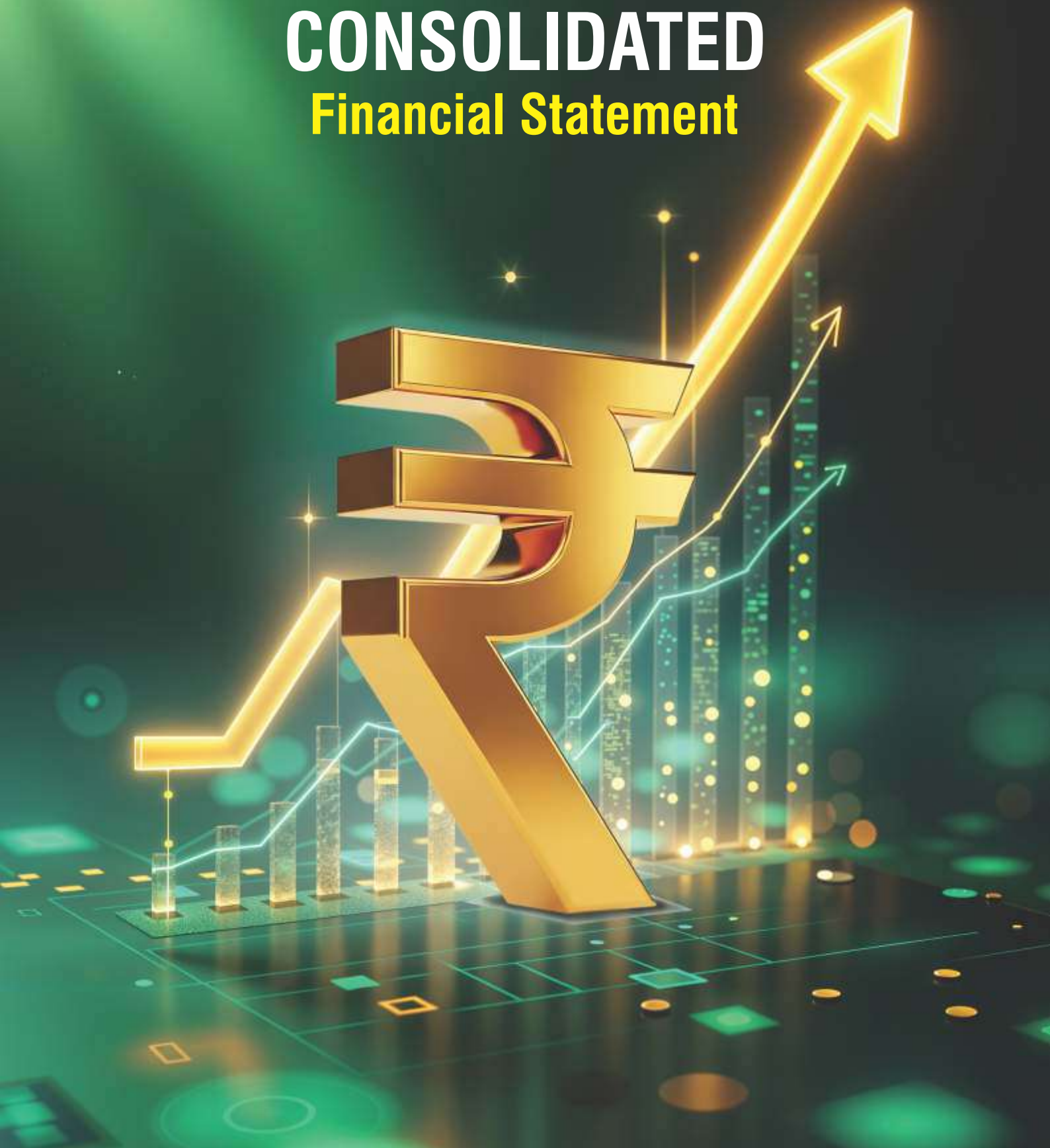

Note 1 Company Overview and Significant Accounting Policies

1 Corporate Information

The Consolidated Financial Statements comprise financial statements of Arfin India Limited (the "Holding Company") and its subsidiaries (collectively the "Group"). The Company is a public Company domiciled in India and incorporated under the provisions of Companies Act, 1956 applicable in India. Its Equity Shares are listed on Main Board of NSE & BSE Limited. The registered office of the Company is located at Plot No. 117, Ravi Industrial Estate, Billeswarpura, Chhatral, Tal. – Kalol, Dist. – Gandhinagar-382729, Gujarat, India.

The Holding Company is engaged in the business of manufacturing, trading and selling of various ferrous & non-ferrous metal products and its manufacturing facilities are located at Chhatral, Dhanot and Vadaswami in the State of Gujarat. The Company has branch office at Raigarh in the State of Maharashtra. The Company caters to both domestic as well as international markets.

The Consolidated Financial Statements for the financial year ended March 31, 2026 have been approved by the Board of Directors of the Company in its meeting held on May 11, 2026.

2.1 Basis of Preparation of Consolidated Financial Statements

Compliance with IND AS

These Consolidated Financial Statements have been prepared in accordance with the Indian Accounting Standards (hereinafter referred to as the 'IND AS') as notified by the Ministry of Corporate Affairs pursuant to Section 133 of the Companies Act, 2013 ('Act') read with the Companies (Indian Accounting Standards) Rules, 2021 as amended and other relevant provisions of the Act.

Historical Cost Convention

The Consolidated Financial Statements have been prepared on a historical cost basis, except for the following:

- i) Certain financial assets and liabilities that are measured at fair value or amortized cost;
- ii) Defined benefit plans - plan assets are measured at fair value less present value of defined benefit obligations.

Current and Non-Current Classification

All assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle (twelve months) and other criteria set out in the Schedule III to the Act.

Rounding off of Amounts

All amounts disclosed in the Consolidated Financial Statements and notes have been rounded off to the nearest rupees in lakh as per the requirement of Schedule III, unless otherwise stated.

2.2 Use of Estimates

The estimates and judgements used in the preparation of the Consolidated Financial Statements are continuously evaluated by the Group and are based on historical experience and various other assumptions and factors (including expectations of future events) that the Group believes to be reasonable under the existing circumstances. Differences between actual results and estimates are recognized in the period in which the results are known / materialized. The said estimates are based on the facts and events, that existed as at the reporting date, or that occurred after that date but provide additional evidence about conditions existing as at the reporting date.

2.3 PRINCIPLES OF CONSOLIDATION

The Consolidated Financial Statements comprise the financial statements of the Holding Company and entities controlled by the Holding Company and its subsidiaries as at March 31, 2026. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee. Specifically, the Group controls an investee if and only if the Group has:

- Power over the investee (i.e. existing rights that give it the current ability to direct the relevant activities of the investee).
- Exposure, or rights, to variable returns from its involvement with the investee, and
- The ability to use its power over the investee to affect its returns.

Generally, there is a presumption that a majority of voting rights result in control. To support this presumption and when the Group has less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- The contractual arrangement with the other vote holders of the investee;
- Rights arising from other contractual arrangements;
- The Group's voting rights and potential voting right;
- The size of the group's holding of voting rights relative to the size and dispersion of the holdings of the other voting rights holders.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Assets, liabilities, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit and loss from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Consolidated Financial Statements are prepared using uniform accounting policies for like transactions and other events in similar circumstances. If a member of the group uses accounting policies other than those adopted in the Consolidated Financial Statements for like transactions and events in similar circumstances, appropriate adjustments are made to that group member's financial statements in preparing the Consolidated Financial Statements to ensure conformity with the group's accounting policies.

The Financial Statements of all entities used for the purpose of consolidation are drawn up to same reporting date as that of the Holding Company, i.e., year ended on March 31. When the end of the reporting period of the parent is different from that of a subsidiary, the subsidiary prepares, for consolidation purposes, additional financial information as of the same date as the financial statements of the parent to enable the parent to consolidate the financial information of the subsidiary, unless it is impracticable to do so.

Consolidation procedure:

- a) Combine like items of assets, liabilities, equity, income, expenses and cash flows of the parent with those of its subsidiaries. For this purpose, income and expenses of the subsidiary are based on the amounts of the assets and liabilities recognised in the Consolidated Financial Statements at the acquisition date.
- b) Offset (eliminate) the carrying amount of the parent's investment in each subsidiary and the parent's portion of equity of each subsidiary.
- c) Eliminate in full intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between entities of the group (profits or losses resulting from intragroup transactions that are recognised in assets, such as inventory and fixed assets, are eliminated in full). Intragroup losses may indicate an impairment that requires recognition in the Consolidated Financial Statements. IND AS 12 Income Taxes applies to temporary differences that arise from the elimination of profits and losses resulting from intragroup transactions..

Profit or loss and each component of other comprehensive income are attributed to the equity holder of the parent of the Group and to the non- controlling interests even if this results in the non-controlling interests having a deficit balance. When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with the Group's accounting policies. All intra-group assets and

2.4 BUSINESS COMBINATION AND GOODWILL:

Acquisition of subsidiaries and businesses are accounted for using the acquisition method. The consideration transferred in each business combination is measured at the aggregate of the acquisition date fair values of assets given, liabilities incurred by the Group to the former owners of the acquire and equity interests issued by the Group in exchange for control of the acquire. Acquisition related costs are recognised in the consolidated statement of profit and loss.

Goodwill arising on acquisition is recognised as an asset and measured at cost, being the excess of the consideration transferred in the business combination over the Group's interest in the net fair value of the identifiable assets acquired, liabilities assumed and contingent liabilities recognised. Where the fair value of the identifiable assets and liabilities exceed the cost of acquisition, after re-assessing the fair values of the net assets and contingent liabilities, the excess is recognised as capital reserve on consolidation.

Once control has been achieved, any subsequent acquisitions where the Group does not originally hold hundred percent interest in a subsidiary are treated as an acquisition of shares from non-controlling shareholders. The identifiable net assets are not subject to further fair value adjustments and the difference between the cost of acquisition of the non-controlling interest and the netbook value of the additional interest acquired is adjusted in equity. Business combinations arising from transfer of interests in entities that are under common control are accounted for using the pooling of interest method. The difference between any consideration transferred and the aggregate historical carrying values of assets and liabilities of the acquired entity are recognised in shareholders' equity.

Goodwill:

Goodwill is initially recognised as an asset at cost and is subsequently measured at cost less any accumulated impairment losses.

For the purpose of impairment testing, goodwill is allocated to each of the Group's cash-generating units or groups of cash-generating units that are expected to benefit from the synergies of the combination. Cash generating units to which goodwill has been allocated are tested for impairment annually, or more frequently when there is an indication that the unit's value may be impaired. If the recoverable amount of the cash generating unit is less than the carrying value of the unit, the impairment loss is allocated first to reduce the carrying value of any goodwill allocated to the unit and then to the other assets of the unit in proportion to the carrying value of each asset in the unit.

An impairment loss recognised for goodwill is not reversed in a subsequent period. On disposal of a subsidiary, the attributable amount of goodwill is included in the determination of profit or loss on disposal.

2.5 Property, Plant & Equipment

Property, plant and equipment are stated at cost, net of recoverable taxes, less depreciation and impairment losses, if any. Such cost includes purchase price, borrowing cost and other cost directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognized as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognized when replaced. All other repairs and maintenance are charged to the Statement of Profit and Loss during the reporting period in which they are incurred.

Depreciation methods, estimated useful lives and residual value

Depreciation is provided on a Straight-Line Method over the estimated useful lives of assets.

The Group depreciates its property, plant and equipment over the useful life in the manner prescribed in Schedule II to the Act, and the management believes that useful life of assets are same as those prescribed in the Schedule II to the Act.

The residual values are not more than 5% of the original cost of the asset. The assets residual values and useful lives are reviewed and adjusted if appropriate, at the end of each reporting period.

The carrying amount of an item of property, plant and equipment is derecognized on disposal or when no future economic benefits are expected from its use or disposal. The gain or loss arising from the de-recognition of an item of property, plant and equipment is measured as the difference between the net disposal proceeds and the carrying amount of the item and is recognized in the Statement of Profit and Loss when the item is derecognized.

Capital Work-In-Progress and Capital Advances

Cost of assets not ready for intended use, as on the Balance Sheet date is shown as capital work in progress. Advances given towards acquisition of fixed assets outstanding at Balance Sheet date are disclosed as Other Current Assets.

2.6 Intangible Assets

Computer software are stated at cost, less accumulated amortization and impairments, if any.

Amortization Method and Useful Life

The Group amortizes computer software using the straight-line method over the period of 5 years. Gains and losses on disposals are determined by comparing proceeds with carrying amount. These are included in the Statement of Profit and Loss.

2.7 Inventories

Items of inventories of Raw Material, Finished goods, WIP, Spares and Stores, Packing Material & Fuel are valued at lower of cost or net realizable value except waste which is valued at estimated net realizable value. Raw Material cost of inventories comprises of cost of purchase and other costs incurred in bringing the inventories to their present location and condition. Finished goods cost of inventories comprises of cost of

purchase, cost of conversion and other costs including manufacturing overheads incurred in bringing them to their respective present location and condition.

2.8 Financial Instruments

(I) Initial Recognition and Measurement

The Group recognizes financial assets and liabilities when it becomes a party to the contractual provisions of the instrument. All financial assets and liabilities are recognized at fair value on initial recognition, except for trade receivables which are initially measured at transaction price. Transaction costs that are directly attributable to the acquisition or issue of financial assets and liabilities that are not at fair value through profit or loss are added to the fair value on initial recognition. Regular way of purchase and sale of financial assets are recognized on the trade date.

(ii) Subsequent Measurement

A. Non-Derivative Financial Instrument

(a) Financial Assets Carried at Amortized Cost

A financial asset is subsequently measured at amortized cost if it is held within a business model whose objective is to hold the asset in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

(b) Financial Assets at Fair Value through Other Comprehensive Income

A financial asset is subsequently measured at fair value through other comprehensive income if it is held within a business model whose objective is achieved by both collecting contractual cash flows and selling financial assets and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

The Group has made an irrevocable election for its investments which are classified as equity instruments to present the subsequent changes in fair value in other comprehensive income based on its business model. Further, in cases where the Company has made an irrevocable election based on its business model, for its investments which are classified as equity instruments, the subsequent changes in fair value are recognized in other comprehensive income.

(c) Financial Assets at Fair Value through Profit or Loss

A financial asset which is not classified in any of the above categories is subsequently fair valued through profit or loss.

(d) Financial Liabilities

Financial liabilities are subsequently carried at amortized cost using the effective interest method, except for contingent consideration recognized in a business combination which is subsequently measured at fair value through profit and loss. For trade and other payables maturing within one year from the Balance Sheet date, the carrying amounts approximate fair value due to the short maturity of these instruments.

B. Derivative Financial Instruments

The Group holds derivative financial instruments such as foreign exchange forward and option contracts to mitigate the risk of changes in exchange rates on foreign currency exposures. The counterparty for these contracts is generally a bank.

Financial Assets or Liabilities, at Fair Value through Profit or Loss

This category has derivative financial assets or liabilities which are not designated as hedges. Although the group believes that these derivatives constitute hedges from an economic perspective, they may not qualify for hedge accounting under IND AS 109, Financial Instruments. Any derivative that is either not designated as hedge, or is so designated but is ineffective as per IND AS 109, is categorized as a financial asset or financial liability, at fair value through profit or loss.

Derivatives not designated as hedges are recognized initially at fair value and attributable transaction costs are recognized in net profit in the Statement of Profit and Loss when incurred. Subsequent to initial recognition, these derivatives are measured at fair value through profit or loss and the resulting exchange gains or losses are included in other income. Assets / liabilities in this category are presented as current assets / liabilities if they are either held for trading or are expected to be realized within 12 months after the balance sheet date.

C. De-Recognition of Financial Instruments

The Group derecognizes a financial asset when the contractual right to receive the cash flows from the financial asset expires or it transfers the financial asset.

A financial liability is derecognized when the obligation under the liability is discharged, cancelled or expired.

2.9 Current versus Non-Current Classification

An asset is considered as current when it is:

- expected to be realized or intended to be sold or consumed in normal operating cycle;
- held primarily for the purpose of trading;
- expected to be realized within twelve months after the reporting period; or
- cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period.

All other assets are classified as non-current.

A liability is considered as current when it is:

- expected to be settled in normal operating cycle;
- held primarily for the purpose of trading;
- due to be settled within twelve months after the reporting period; or
- there is no unconditional right to defer the settlement of the liability for at least twelve months after the reporting period.

All other liabilities are classified as non-current.

Deferred tax assets and liabilities are classified as non-current assets and liabilities respectively.

2.10 Measurement of Fair Value

Fair value is the price that would be received on sell of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either:

- in the principal market for the asset or liability; or
- in the absence of a principal market, in the most advantageous market for the asset or liability.

The principal or the most advantageous market must be accessible by the Group.

The fair value of an asset or a liability is measured using the assumptions that market participants would use

when pricing the asset or liability, assuming that market participants act in their economic interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximizing the use of relevant observable inputs and minimizing the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the Consolidated Financial Statements are categorized within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

- Level 1 – Quoted (unadjusted) market prices in active markets for identical assets or liabilities.
- Level 2 – Valuation techniques for which the lowest level input that is significant to the fair value measurement is directly or indirectly observable.
- Level 3 – Input for the asset or liability those are not based on observable market data (unobservable inputs).

2.11 Investments and Other Financial Assets

Investments in subsidiaries are measured at cost as per INDAS 27 - Separate Financial Statements.

Classification

The Group classifies its financial assets in the following measurement categories:

- Those to be measured subsequently at fair value (either through Other Comprehensive Income, or through the Statement of Profit and Loss), and
- Those measured at amortized cost.

The classification depends on the Group's business model for managing the financial assets and the contractual terms of the cash flows.

Measurement

Investments in subsidiaries are measured at cost as per INDAS 27 - Separate Financial Statements. At initial recognition, the Group measures a financial asset at its fair value. Transaction costs of financial assets are expensed out in the Statement of Profit and Loss.

Impairment of Financial Assets

The Group measures the expected credit loss associated with its assets based on historical trend, industry practices and the business environment in which the entity operates or any other appropriate basis. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

2.12 Revenue Recognition

Revenue is measured at the value of the consideration received or receivable. Amounts disclosed as revenue are net of returns, trade allowances, rebates, discounts, GST and amounts collected on behalf of third parties.

The Group recognizes revenue when the amount of revenue can be reliably measured. It is probable that future economic benefits will flow to the Company and specific criteria have been met for each of the Company's activities as described below:

Sale of Goods

Sales are recognized when substantial risk and rewards of ownership are transferred to customers. In case of domestic customer, generally sales take place when goods are dispatched or delivery is handed over to transporter. In case of export customers, generally sales take place when goods are shipped on board based on bill of lading.

Other Operating Revenue

Export Incentives under various schemes are accounted in the year in which right to receive is irrevocably established.

Other Revenue

Interest income is recognized on a time proportion basis taking into account the amount outstanding and the applicable rate of interest.

Revenue in respect of insurance / other claims etc. is recognized only when it is reasonably certain that the ultimate collection will be made.

Dividend

Dividends are generally recognized in the Statement of Profit and Loss only when the right to receive payment is established.

2.13 Foreign Currency Transactions

The Consolidated Financial Statements are presented in Indian Rupee (INR), which is Group's functional and presentation currency.

Foreign currency transactions are accounted for at the exchange rate prevailing on the date of the transaction. All monetary foreign currency assets and liabilities are converted at the exchange rates prevailing on the date of the Balance Sheet. All exchange differences other than those relating to the acquisition of fixed assets from outside India are dealt with in the Statement of Profit and Loss. Exchange gain or loss relating to fixed assets acquired from outside India is adjusted in the cost of respective fixed assets. All non-monetary items are measured at historical cost basis.

In case of forward contracts, the gain / loss on contracts are treated as periodical expense or revenue. Any profit or loss arising on the cancellation or renewal of a forward exchange contract is recognized as income or expense for the year, except in case of a forward exchange contract relating to liabilities incurred for acquiring fixed assets from outside India, in which case, such profit or loss is adjusted in the cost of fixed assets.

Exchange difference is calculated as the difference between the foreign currency amount of the contract translated at the exchange rate at the reporting date, or the settlement date where the transaction is settled during the reporting period, and the corresponding foreign currency amount translated at the later of the date of inception of the forward exchange contract and the last reporting date. Such exchange differences are recognized in the Statement of Profit and Loss in the reporting period in which the exchange rates change.

2.14 Income Tax

The income tax expense or credit for the period is the tax payable on the current period's taxable income based on the applicable income tax rate adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses.

Deferred income tax is provided in full, using the liability method on temporary differences arising between the tax bases of assets and liabilities and their carrying amount in the Consolidated Financial Statements. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantially enacted by the end of the reporting period and are expected to apply when the related deferred income tax asset is realized or the deferred income tax liability is settled.

Deferred tax assets are recognized for all deductible temporary differences and unused tax losses, only if, it is probable that future taxable amounts will be available to utilize those temporary differences and losses.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets and liabilities and when the deferred tax balances relate to the same taxation authority. Current tax assets and tax liabilities are offset where the Group has a legally enforceable right to offset and intends either to settle on a net basis, or to realize the asset and settle the liability simultaneously.

Current and deferred tax is recognized in the Statement of Profit and Loss, except to the extent that it relates to items recognized in other comprehensive income or directly in equity. In that case, the tax is also recognized in other comprehensive income or directly in equity, respectively.

Minimum Alternate Tax credit is recognized as deferred tax asset only when and to the extent there is convincing evidence that the Group will pay normal income tax during the specified period. Such asset is reviewed at each Balance Sheet date and the carrying amount of the MAT credit asset is written down to the extent there is no longer a convincing evidence to the effect that the Group will pay normal income tax during the specified period.

2.15 Provisions and Contingent Liabilities

Provisions are recognized when the Group has a present legal or constructive obligation. As a result of past events, it is probable that an outflow of resources will be required to settle the obligation and the amount can be reliably estimated. Provisions are not recognized for future operating losses.

Provisions are measured at the present value of management's best estimate of the expenditure required to settle the present obligation at the end of the reporting period. The discount rate used to determine the present value is a pre tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. The increase in the provision due to the passage of time is recognized as interest expense.

Contingent Liabilities are disclosed in respect of possible obligations that arise from past events but their existence will be confirmed by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Group or where any present obligation cannot be measured in terms of future outflow of resources or where a reliable estimate of the obligation cannot be made.

2.16 Employee Benefits

Short Term Obligations

Liabilities for wages and salaries, including non-monetary benefits that are expected to be settled wholly within 12 months after the end of the period in which the employees render the related services are recognized in respect of employees' services up to the end of the reporting period and are measured at the amounts expected to be paid when the liabilities are settled.

Post-Employment Obligations

The Group operates the following post-employment schemes:

- (a) defined benefit plans such as gratuity; and
- (b) defined contribution plans such as provident fund.

Gratuity Obligations

The liability or asset recognized in the Balance Sheet in respect of defined benefit gratuity plan is the present value of the defined benefit obligation at the end of the reporting period less the fair value of plan assets. The defined benefit obligation is calculated annually by actuaries using the projected unit credit method.

The present value of the defined benefit obligation is determined by discounting the estimated future cash outflows by reference to market yields at the end of the reporting period on government bonds that have terms approximating to the terms of the related obligation.

The net interest cost is calculated by applying the discount rate to the net balance of the defined benefit obligation and the fair value of plan assets. This cost is included in employee benefit expense in the Statement of Profit and Loss.

Remeasurement gains and losses arising from experience adjustments and changes in actuarial assumptions are recognized in the period in which they occur, directly in other comprehensive income. They are included in retained earnings in the Statement of Changes in Equity and in the Balance Sheet. Gratuity liability of employees is not funded.

Defined Contribution Plans

Defined Contribution Plans such as Provident Fund, etc., are charged to the Statement of Profit and Loss as incurred.

2.17 Borrowing Costs

Borrowing cost comprises of interest and other costs incurred in connection with the borrowing of the funds. All borrowing costs are recognized in the Statement of Profit and Loss using the effective interest method except to the extent attributable to qualifying property, plant and equipment (PPE) which are capitalized to the cost of the related assets. A qualifying PPE is an asset that necessarily takes a substantial period of time to get ready for its intended use or sale. Borrowing cost also includes exchange differences to the extent considered as an adjustment to the borrowing costs.

2.18 Earnings Per Share

Basic Earnings Per Share

Basic earnings per share is calculated by dividing:

- the profit attributable to owners of the Company by
- average number of equity shares outstanding during the financial year, adjusted for bonus elements in equity shares issued during the year and excluding treasury shares.

Diluted Earnings Per Share

Diluted earnings per share adjusts the figures used in the determination of basic earnings per share to take into account:

- the after income tax effect of interest and other financing costs associated with dilutive potential equity shares, and
- the weighted average number of additional equity shares that would have been outstanding assuming the conversion of all dilutive potential equity shares.

2.19 Impairment of Assets

An asset is treated as impaired when the carrying cost of asset exceeds its recoverable Value. An impairment loss is charged to the Statement of Profit and Loss in the year in which an asset is identified as impaired. The impairment loss recognized in earlier accounting period is reversed if there has been a change in the estimate of recoverable amount.

2.20 Leases

As a Lessee

The Group's lease asset classes primarily consist of leases for buildings taken on lease for operating its branch offices, if any. The Holding Company assesses whether a contract contains a lease, at inception of a contract. At the date of commencement of the lease, the Group recognizes a right-of-use asset ("ROU") and a corresponding lease liability for all lease arrangements in which it is a lessee, except for leases with a term of twelve months or less (short-term leases) and low value leases. For these short-term and low value leases, the Group recognizes the lease payments as an operating expense on a straight-line basis over the term of the lease.

Right-of-use assets are depreciated from the commencement date on a straight-line basis over the lease term. The lease liability is initially measured at amortized cost at the present value of the future lease payments, if any.

During the year, Holding Company has only short-term and low value leases, therefore the Group recognizes the lease payments as an operating expense on a straight-line basis over the term of the lease.

As a Lessor

Lease income from operating leases where the Holding Company is a lessor is recognised in income on a straight-line basis over the lease term unless the receipts are structured to increase in line with expected general inflation to compensate for the expected inflationary cost increases. The respective leased assets are included in the balance sheet based on their nature, if any.

During the year, Holding Company has only short-term and low value leases receipt, therefore the Group recognizes the lease receipts as an operating income in profit & loss account.

2.21 Government Grants

Government grants are recognized on systematic basis when there is reasonable certainty of realization of the same. Revenue grants including subsidy / rebates are credited to the Statement of Profit and Loss under "Other Income" or deducted from the related expenses for the period to which these are related. Grants which are meant for purchase, construction or otherwise acquired through non-current assets are recognized as deferred income and disclosed under non-current liabilities and transferred to the Statement of Profit and Loss on a systematic basis over the useful life of the respective asset. Grants relating to non-depreciable assets are transferred to the Statement of Profit and Loss over the periods that bear the cost of meeting the obligations related to such grants.

2.22 Cash and Cash Equivalents

Cash and cash equivalents include cash and cheques in hand, bank balances, demand deposits with banks and other short term highly liquid investments that are really convertible to known amounts of cash and which are subject to an insignificant risk of changes in value where original maturity is three months or less.

2.23 Cash Flow Statement

Cash flows are reported using the indirect method whereby the profit before tax is adjusted for effect of the transactions of a non cash nature, any deferrals or accruals of past and future operating cash receipts or payments and items of income or expenses associated with investing or financing cash flows. The cash flows from operating, investing and financing activities of the Group are segregated.

2.24 Share Capital

Shares are classified as equity. Incremental costs directly attributable to the issuance of new ordinary shares and share options are recognized as a deduction from equity, net of any tax effects.

2.25 Cash Dividend

The Group recognizes a liability to make cash or non-cash distributions to equity shareholders of the Group when the distribution is authorized and the distribution is no longer at the discretion of the Group. As per the Companies Act, 2013, a distribution is authorized when it is approved by the shareholders. A corresponding amount is recognized directly in equity.

a) SECURITIES PREMIUM RESERVE

Securities Premium Reserve is created when shares are issued at premium. The reserves are utilized by the Company in accordance with provisions of the Act.

The Company has created Capital Reserve of ₹ 26.38 Lakhs on account of forfeiture of shares and balance amount of ₹ 576.74 Lakhs has been created pursuant to scheme of amalgamation during the financial year 2017-18.

c) GENERAL RESERVE

Pursuant to the provisions of the Companies Act, 1956, the Group has transferred a portion of its net profit to General Reserve before declaration of dividend. Mandatory transfer to General Reserve is not required under the Companies Act.

d) RETAINED EARNINGS

Retained Earnings are the profits that the Group has earned till date, less any transfer to general reserve, dividends or other distribution paid to shareholders.

e) FAIR VALUE THROUGH OTHER COMPREHENSIVE INCOME [FVTOCI] RESERVE

The Group transfers actuarial gain / (loss) arising at the time of valuation defined benefit obligation to "Actuarial Gain / Loss" component of Other Comprehensive Income (OCI).

The Group has elected to recognize changes in the fair value of certain investments in Other Comprehensive Income (OCI). These changes are accumulated within the FVTOCI.

44. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The Group's activities are exposed to variety of financial risks. The key financial risks include market risk, credit risk and liquidity risk. The Group's focus is to foresee the unpredictability of financial markets and seek to minimize potential adverse effects on its financial performance. The Board of Directors reviews and approves policies for managing risks. The risks are governed by appropriate policies and procedures and accordingly financial risks are identified, measured and managed in accordance with the Group's policies and risk objectives.

MARKET RISK

Market risk is the risk of loss of future earnings, fair values or future cash flows that may result from a change in the price of a financial instrument. The value of a financial instrument may change as a result of changes in the interest rates, foreign currency exchange rates, equity prices and other market changes that affect market risk sensitive instruments. Market risk is attributable to all market risk sensitive financial instruments including investments and deposits, foreign currency receivables, payables and loan borrowings.

The Group manages market risk through its treasury department, which evaluates and exercises independent control over the entire process of market risk management. The treasury department recommends risk management objectives and policies, which are approved by the Senior Management. The activities of this department include management of cash resources, implementing hedging strategies for foreign currency exposures, borrowing strategies and ensuring compliance with market risk limits and policies.

Interest Rate Risk

Interest rate risk is the risk that fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. In order to optimize the Group's position with regards to the interest income and interest expenses and to manage the interest rate risk, treasury performs a comprehensive corporate interest rate risk management by balancing the proportion of fixed rate and floating rate financial instruments in its total portfolio.

Other Price Risk

CREDIT RISK

Credit risk arises from the possibility that counter party may not be able to settle their obligations as agreed. To manage this, the Group periodically assesses the financial reliability of customers, taking into account the financial condition, current economic trends and analysis of historical bad debts and ageing of accounts receivable (Refer note no. 10.2). Individual risk limits are set accordingly.

The Group considers the probability of default upon initial recognition of asset and whether there has been a significant increase in credit risk on an ongoing basis throughout each reporting period. To assess whether there is significant increase in credit risk, the Group compares the risk of a default occurring on the asset at the reporting date with the risk of default on the date of initial recognition. It considers reasonable and supportive forward-looking information such as:

- (i) Actual or expected significant adverse changes in business,
- (ii) Actual or expected significant changes in the operating results of the counterparty,
- (iii) Financial or economic conditions that are expected to cause a significant change to the counterparty's ability to meet its obligation.
- (iv) Significant increase in credit risk on other financial instruments of the same counterparty, and
- (v) Significant changes in the value of the collateral supporting the obligation or in the quality of third-party guarantees or credit enhancements.

Financial assets are written off when there is no reasonable expectation of recovery, such as a debtor failing to engage in a repayment plan with the Group. The Group categorises a loan or receivable for write off when a debtor fails to make contractual payments greater than 2 years past due. Where loans or receivables have been written off, the Group continues to engage in enforcement activity to attempt to recover the receivable due. Where recoveries are made, these are recognised in profit or loss.

LIQUIDITY RISK

Liquidity Risk is defined as the risk that the Group will not be able to settle or meet its obligations on time or at reasonable price. The Group's treasury department is responsible for liquidity, funding as well as settlement management. In addition, processes and policies related to such risks are overseen by the senior management. Management monitors the Group's net liquidity position through rolling forecast on the basis of expected cash flows.
