Dear Sir/Madam,

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company hereby clarifies that the rumours regarding the alleged takeover of Mahesh Tutorials (MT Educare Ltd.) by Arihant Academy Limited are misleading.

The Company has not entered into any agreement for the takeover, acquisition or merger of Mahesh Tutorials (MT Educare Ltd.). The Company has only extended coaching support to certain eligible students on a humanitarian basis to ensure continuity of their education. This arrangement does not amount to a takeover or assumption of any business or liabilities of Mahesh Tutorials (MT Educare Ltd.).

The above clarification is issued to avoid any misinformation in the market and for the information of investors and other stakeholders.

It has come to our attention that certain rumours and speculative reports are circulating regarding an alleged takeover of Mahesh Tutorials (MT Educare Ltd.) by Arihant Academy Ltd.

We categorically deny these claims. The dissemination of such false and unauthorised information is unfortunate and misleading.

Students, parents, teachers and other stakeholders are requested to rely only on official communications issued by Arihant Academy Ltd. We shall not be responsible for any false representations, assurances or claims made by any unauthorised individual or entity on our behalf.

We would, however, like to clarify that last month our management was approached by senior representatives of Mahesh Tutorials regarding certain operational challenges affecting their ability to fulfil commitments to a large number of students in Mumbai.

Keeping the interests and academic continuity of these students as our foremost priority, we agreed, on a purely humanitarian and best-effort basis, to extend reasonable coaching support by accommodating eligible students at select Arihant Academy branches in Mumbai, subject to applicable policies.

This arrangement is solely intended to support the affected students and should not, under any circumstances, be construed as a takeover, acquisition, merger, transfer or assumption of Mahesh Tutorials (MT Educare Ltd.), its business, employees, assets, liabilities, contractual obligations or any other responsibilities.
