WEDDING CELEBRATION DEATHS WAR CRIME: IRAN

Dubai: US Central Command has released footage of overnight strikes on Iran, including a missile launch from what appears to be an American aircraft carrier, as Tehran accused Washington of a "war crime" over an alleged strike on a wedding celebration.

Footage also emerged of an Iranian strike in Aqaba, Jordan, and damage in Kuestak, southern Iran, where the Iranian Red Crescent said four people were killed.

Israel is preparing for the possibility of an Iranian attack during the upcoming Jewish holidays and would respond with significant force, Defence Minister Israel Katz said on Wednesday.

IRAN SEIZES SHIP WITH 3,82,000 LITRES OF FUEL

Iranian border guards seized a vessel carrying 3,82,000 litres of "smuggled" fuel in the northern Persian Gulf and arrested its 11 foreign crew members, state broadcaster IRIB reported, without giving their nationality.

'UNLAWFUL WAR'
Iranian foreign ministry spokesman Esmael Baqaei called the conflict an "unlawful war of choice". Sharing footage of the alleged wedding strike in Sirik, he said it exposed "the true face of the war crime". Iranian Red Crescent said four people, including a child, were killed after shrapnel from a US missile hit a house hosting the celebration.

Nepal's Shah links deadly disaster to climate change

PM: Global community shares responsibility; toll tops 1,127; 4,800 missing

Rathmandu: Nepal's Prime Minister Balendra Shah on Wednesday linked the devastating Bhotekoshi river floods to climate change and said the global community also had a responsibility to "manage and minimise" its effects.

More than 1,127 people have been killed and over 4,800 remain missing in the floods.

Briefing the House of Representatives, Shah said: "This incident shows the increasing risk the people of the mountain region have to bear with the occurrence of climate change. There is a global contribution behind climate change. And the responsibility to manage and minimise its effects also rests on the global community."

"In this hour of crisis, we have accepted the reality that the country's leadership must provide courage, support and reassurance, not tears," he said. Shah said the disaster had devastated Rasuwak and Dhading districts and was "a shared blow to the heart of the country".

"We have no alternative but to fight with determination and courage, and we are fighting," the Prime Minister said.

On international assistance, Shah said there was "no question" of not accepting aid given the magnitude of the crisis.

"We have coordinated with the international community to receive support and assistance since the beginning," he said.

Two oil tankers struck sea mines and exploded in the strait, IIRGC said, alleging they had been directed by the US to use an "illegal route".

PAK PUSHES TALKS

Pakistan said it was in contact with Washington and Tehran to help end the war.

Meanwhile, Israel said it nabbed a Hamas official in the Gaza City. The operation killed at least four people, including two kids.

Further, Saudi Arabia on Wednesday condemned Iran for attacking the Saudi tanker *Al-Sidra* as it passed through the Strait of Hormuz, an incident the kingdom said resulted in deaths among the vessel's crew.

NHRC takes cognisance of 'paid ads' on Meta platform 'promoting' access to child sexual abuse material

NEW DELHI

The NHRC has taken cognisance of reports alleging that paid advertisements displayed on a social media platform, owned and operated by Meta, promoted or facilitated access to child sexual abuse material (CSAM) in India, officials said on Thursday.

The National Human Rights Commission (NHRC) has sought specific, pointwise reports within two weeks from the Ministry of Information and Broadcasting (MIB), the Ministry of Electronics and Information Technology (MeitY) and the Delhi Police commissioner, according to the proceedings of the case dated September 3.

"MeitY shall specifically confirm compliance with Section 19 of the POCOA Act, 2012, or, in case of non-reporting, state the reasons and identify the responsible officer/authority. The above issue shall not be left to a general or omnibus response on intermediary compliance and shall be answered specifically, supported by contemporaneous records," the proceedings said.

There was no immediate response from Meta Platforms.

"The Commission took cognisance of media reports published by the BBC World Service, alleging that paid advertisements displayed on Instagram, owned and operated by Meta Platforms Inc., promoted or facilitated access to child sexual abuse material in India," the proceedings said.

JPC formed to examine FCRA Amendment Bill, BJP's Sanjay Jaiswal to head panel

A 31-member Joint Committee of Parliament (JPC) has been formed to examine the proposed Foreign Contribution (Regulation) Amendment Bill, 2026, and the move is the

next stage of legislative scrutiny of the contentious legislation, said officials.

According to a Lok Sabha bulletin issued on Thursday, Bharatiya Janata Party (BJP) MP from Bihar's Bettiah, San-

jay Jaiswal, has been appointed Chairperson of the joint parliamentary panel. The committee, constituted by Lok Sabha Speaker Om Birla, comprises 21 members from the Lok Sabha and 10 from the

Rajya Sabha.

The panel has been tasked with examining the provisions of the proposed FCRA amendment and considering changes before the Bill proceeds further through Parliament.

Former bureaucrat Ashish Joshi on Thursday claimed that Delhi Police questioned him for nearly nine hours over social media posts concerning the Election Commission of India, and did not allow him to inform his wife about his whereabouts for several hours.

The Special Cell of Delhi Police on Wednesday questioned Joshi in connection with a case allegedly related to posts involving the Election Commission.

Joshi was released in the evening after nine hours of questioning. He was reportedly taken home by police after several people gathered outside the office of the counter-intelligence unit of the Special Cell in New Friends Colony de-

manding his release.

Police sources said that Joshi, a former controller of communications in the Department of Telecommunications, was picked up from Chanakypuri for questioning in a case registered two days ago.

The case was lodged under Section 192 of the BNS, which deals with provocation with the intent or knowledge that it is likely to cause a riot.
