As the business has matured, the Company has organically evolved into a significantly broader and more integrated network, combining multi-material supply, execution-linked services, and proprietary technology into a unified operating model serving the construction ecosystem at scale.

The adoption of “**ARIS**” as the corporate brand in the Company's logo represents a natural progression of this journey. The refreshed identity retains continuity with the legacy brand while more accurately reflecting the Company's present scale and capabilities, and its ambition to become the organised backbone of construction in India – bringing reliability, coordination, and
