The Company is of the considered view that the aforesaid Order is contrary to the settled legal position, including the principles laid down by the Hon'ble Supreme Court in *M/s Armour Security (India) Ltd. v. Commissioner, CGST*. The issues involved are primarily interpretational in nature, particularly with respect to the scope of proceedings and jurisdiction under the GST framework.

The Company is in the process of reviewing the Order and will take appropriate legal remedies including filing an appeal before the appropriate authority. The Company is confident of a favourable outcome and does not expect any material adverse impact on its financial, operational or other activities on account of the aforesaid Order.
